Opinion

We have audited the financial statements of the Harbor Group Comprehensive Health & Welfare Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of Plan's benefit obligations as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in Plan's benefit obligations for the year ended August 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of August 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the year ended August 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Description of Plan

The following description of the Harbor Group Comprehensive Health & Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan provides health, prescription drug, dental, vision, long-term and short-term disability, dependent care and medical expense reimbursement, identity protection monitoring, and life, cancer, accident, and accidental death and dismemberment insurance benefits covering eligible employees of Harbor Group, Inc. and its subsidiaries (collectively, the Company) as defined by plan documents.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (the ERISA).

Benefits and Eligibility

The Plan provides benefits for the Company's participating full-time employees and part-time employees working 30 hours or more per week, shareholders, and their covered spouses and dependents. Employees are eligible to participate on the first day of the month following hire or stock purchase. The trust funds health, prescription drug, and dental benefits. Long-term and short-term disability, life, cancer, accident, and accidental death and dismemberment benefits are provided through insurance contracts. The Plan also provides voluntary identity protection and monitoring benefits and continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop Loss Coverage

The Plan has entered into a stop loss insurance agreement in an effort to limit its exposure for self-insured benefits (for individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions

Participants pay the full cost of the flexible dependent care and medical expense reimbursement, identity protection monitoring, vision, voluntary life, cancer, accident, and accidental death and dismemberment insurance components of the Plan. The Company funds 100% of the group term life, and long-term and short-term disability portions of the Plan. The Company and participants both contribute towards the health, prescription drug, and dental portions of the Plan. The amount of a participants' contribution varies depending on the participants' choice of plan options.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Insured Benefits

The Plan fully insures long-term and short-term disability, identity protection monitoring, life, cancer, accident, and accidental death and dismemberment benefits through insurance contracts. The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid to the insurance company from the general assets of the Company. Premiums for all other insured benefits are paid from the assets of the VEBA trust.

Self-Insured Benefits

The Plan is “self-insured” for medical and dental benefits up to individual and aggregate stop loss limits. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan’s VEBA trust or the general assets of the Company. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

The Plan has flexible spending account (FSA) arrangements for health care and dependent care reimbursements that are funded solely by active employee contributions based on a calendar year. The FSA’s allow eligible participants to be reimbursed tax free for qualified health care and dependent care expenses subject to annual limitations established under the Plan. The employer is not permitted to refund any part of the FSA balances to the employee; the accounts cannot be used for anything other than qualified health care and dependent care expenses; remaining amounts are not portable upon termination once the employee leaves the employer; and, any unused amount is forfeited back to the Company. Residual FSA amounts unused at the end of the calendar year can be carried over for 90 days into the next year to allow qualified expenses incurred during that period to be reimbursed from the account. Any residual FSA health care amounts in excess of \$500 and any residual FSA dependent care amounts remaining after the 90 day extension are immediately forfeited.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan’s participants.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Concentration of Credit Risk

At times during the year, the balance of deposit accounts may be in excess of the Federal Deposit Insurance Corporation (FDIC) insurance limit. Accounts are guaranteed by the FDIC up to \$250,000 per depositor, per insured bank, for each account ownership category. At August 31, 2024 and 2023, the Plan's money market account balances were approximately \$3,176,000 and \$1,872,000, respectively, in excess of FDIC-insured limits.

Administrative Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include managed care fees and medical administrative fees. These expenses are recorded as administrative expenses in the accompanying statement of changes in net assets available for benefits. Expenses that are paid by the Company, such as professional fees, are excluded from these financial statements.

Benefit Obligations

Plan obligations at August 31, 2024 and 2023 for health, drug, and dental claims incurred by participants but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan's year-end in addition to an estimate of future claims expected to be paid based upon an analysis of plan participants with chronic conditions as provided by the claims administrators. Such estimated amounts are included in the accompanying statements of plan's benefit obligations in amounts currently payable. Benefit obligations in excess of plan assets will be funded by Company contributions as described in Note 1.

Stop Loss

Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$551,423, net of aggregating plan deductibles of \$125,000, have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended August 31, 2024.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$1,353,518 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended August 31, 2024.

Payments for Benefits

Premiums paid by the VEBA trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Flexible Spending Accounts

Included in the accompanying statements of net assets available for benefits are amounts available to reimburse participants for qualifying health care and dependent care expenses as of August 31, 2024 and 2023, totaling \$72,734 and \$69,210, respectively.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through June 16, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Money Market Deposit Account – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Note 4 - Tax Status

The VEBA trust established to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the VEBA trust's net investment income is exempt from income taxes. The VEBA trust has obtained an exemption letter dated May 27, 1988, in which the Internal Revenue Service (IRS) stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC. However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in the financial statements for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Sponsor believes that the trust is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Related Party and Party-in-interest Transactions

Plan assets consist of a money market deposit account managed by Northwest Bank, who is the custodian as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions.

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions. Fees paid by the Plan to parties-in-interest for processing and administration of claims activity were \$781,627 for the year ended August 31, 2024. Fees paid by the Plan to parties-in-interest for network access totaled \$122,952 for the year ended August 31, 2024. Fees paid by the Plan to parties-in-interest for stop loss premiums were \$833,127 for the year ended August 31, 2024.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in this estimate in the near term would be material to the financial statements.
