Independent Auditor's Report

To the Plan Administrator  
The Preservation Society of Newport County Retirement Savings Plan

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Preservation Society of Newport County Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

*Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

*Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements December 31, 2024

### Note 1 - Description of Plan

The following description of The Preservation Society of Newport County Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

#### General

The Plan is a contributory Internal Revenue Code (the "IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of The Preservation Society of Newport County (the "Society"). Employees are eligible to make salary deferral contributions to the Plan as soon as administratively feasible following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the IRC. The Society's Board of Trustees is responsible for oversight of the Plan. The Plan's Fiduciary Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Society's Board of Trustees.

Empower Trust Company, LLC ("Empower") is the Plan's primary custodian. Additional assets are also held with Teachers Insurance Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF"). TIAA and CREF are also custodians of the Plan, however, no additional contributions are remitted to TIAA and CREF.

#### Contributions

Each year, participants may make salary deferral contributions to the Plan equal to a fixed dollar amount or percentage of their annual pre-tax compensation, as defined by the Plan, up to IRC limits. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan contains an Automatic Contribution Arrangement provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their pre-tax deferral rate increase annually by 1% on the first date of each subsequent Plan year up to a maximum automatic contribution rate of 6%.

The Plan contains a provision where the Society is required to make nonelective contributions to the Plan equal to 3% of each participant's eligible compensation. Participants must complete 950 hours of service during the Plan year and be actively employed on the last day of the Plan year to be eligible for the Society's nonelective contributions. Both the requirement that a participant be employed on the last day of the Plan year and the minimum number of hours that must be worked will be waived if any of the following conditions are met: the participant terminated service due to a disability, the participant reached normal retirement age or the participant died during the Plan year.

The Society may, at its discretion, also make matching contributions to the Plan. For the year ended December 31, 2024, the Society elected to match 50% of elective deferrals up to the first 6% of eligible compensation that a participant contributes to the Plan each pay period. Participants must complete 950 hours of service during the Plan year and be actively employed on the last day of the Plan year to be eligible for any discretionary matching contributions. Both the requirement that a

participant be employed on the last day of the Plan year and the minimum number of hours that must be worked will be waived if any of the following conditions are met: the participant terminated service due to a disability, the participant reached normal retirement age or the participant died during the Plan year.

Leased employees, as defined, are excluded from receiving any nonelective contributions or discretionary matching contributions. Participants also direct the investment of the Society's contributions. All contributions are subject to certain IRC limitations.

### Participant accounts

Each participant's account is credited with the participant's contributions and any discretionary matching contributions, as well as an allocation of the Society's nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their salary deferral contributions, rollover contributions, and discretionary matching contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the Society's nonelective contribution portion of their account. For all other participants, vesting in the Society's nonelective contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

<u>Years of service</u>	<u>Vested percentage</u>
Less than 1	0%
1	25%
2	50%
3	75%
4 or more	100%

The Plan administrator determined that a partial plan termination had occurred during the year ended December 31, 2021. Therefore, in accordance with the applicable provisions of the IRC, all Plan participants who were terminated from January 1, 2020 to March 31, 2021 become fully vested in their accounts.

### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate, determined at the origination of the loan, is set at the prime rate, as defined. Principal and interest payments are made ratably through payroll deductions.

### Payment of benefits

On termination of service due to death, disability, or normal retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, installment payments for a specified term or purchase of an annuity contract available

under the terms of the Plan. For termination of service for other reasons, a participant with an account balance of less than \$1,000 may receive the value of his or her account as a lump sum distribution. Unless a participant directs otherwise, participants with an account balance greater than \$1,000, but less than \$7,000 will receive an automatic rollover to an individual retirement account specified by the Plan. Participants with an account balance greater than \$7,000 may defer payments until a later time.

Withdrawals from the vested portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may also be made at any time in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59½.

### **Forfeited accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$912 and \$4,029, respectively. Forfeited nonvested accounts may be used to pay Plan expenses or used to reduce future employer contributions in accordance with the provisions of the Plan. For the year ended December 31, 2024, forfeited nonvested accounts of \$5,586 were utilized to reduce the Society's contributions.

## **Note 2 - Summary of accounting policies**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in two types of fixed annuity contracts, of which one is considered fully benefit-responsive.

### **Investment valuation and income recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Contributions**

Contributions from Plan participants and the discretionary matching contributions from the Society are recorded in the year in which the employee contributions are withheld from compensation. The nonelective contributions from the Society are recorded in the year in which the contributions are earned.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

### Payment of benefits

Benefits are recorded when paid.

### Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Society. Expenses that are paid by the Society are excluded from these financial statements. Fees related to the administration of notes receivable from participants, processing distributions, annual record-keeping charges and asset-based investment management fees are charged directly to the participant's account and are included in administrative expenses. Other indirect investment-related expenses are included in the net appreciation in fair value of investments.

### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Subsequent events

The Plan has evaluated subsequent events through June 5, 2025, the date the financial statements were available to be issued.

## Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* The Plan invests in variable annuity contracts with CREF. The CREF accounts are valued at the unit value as reported by the account. The unit values are listed on the National Association of Securities Dealers Automated Quotations ("NASDAQ") website and updated overnight for each day that the NASDAQ is open. The CREF accounts held by the Plan are deemed to be actively traded (Level 1).

The Plan also invests in variable annuity contracts with TIAA in the form of TIAA Access accounts. The accounts are valued at the Accumulation Unit Value ("AUV") of units held by the Plan at year-end. The AUV is based on the value of underlying investments, which are valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing less its liabilities and account charges, plus any applicable dividend income, then divided by the number of units outstanding. The TIAA Access accounts allow for daily redemptions and contributions (Level 2).

*Pooled separate account:* Valued at the unit value reported by the account. The unit value is listed on the NASDAQ website and updated overnight for each day that NASDAQ is open. The pooled separate account held by the Plan is deemed to be actively traded.

*Nonfully benefit-responsive fixed annuity contracts:* Valued based on the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. These annuity contracts are not available for sale or transfer on any securities exchange. Withdrawals under the retirement annuity contracts may be made in the form of a life annuity or in 10 annual installments. The fully benefit-responsive fixed annuity contracts are valued as described in Note 4.

### Note 4 - Investment contract with insurance company

The Plan has entered into fully benefit-responsive fixed annuity contracts with TIAA, an insurance company, referred to as the TIAA Traditional Annuity, totaling \$648,616 and \$643,608 as of December 31, 2024 and 2023, respectively. Participants who choose to invest in these contracts make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis.

As described in Note 2, because the fixed annuity contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed annuity contracts. The fixed annuity contracts are presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by TIAA, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and ranges between 1% and 3% and has the potential for additional interest if declared by TIAA.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note 5 - Related party transactions and party-in-interest transactions

Plan investments are held by Empower, TIAA and CREF. Empower, TIAA and CREF are the custodians, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for certain investment management services are included in the net appreciation in fair value of investments. Fees paid directly by the Plan to the custodians for administrative expenses and to the Plan's investment advisor for other investment management services amounted to \$86,100 for the year ended December 31, 2024. The Society pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

Effective May 1, 2024, all TIAA-CREF proprietary mutual funds and TIAA-CREF Lifecycle funds were renamed Nuveen funds. TIAA is the parent company of Nuveen, therefore, the Nuveen funds are considered proprietary assets and also qualify as party-in-interest transactions.

At December 31, 2024 and 2023, the Plan's revenue sharing account totaled \$3,058 and \$2,175, respectively. The Plan received revenue sharing credits from Empower in the amount of \$30,056 for the year ended December 31, 2024. This amount, which is shown as other income in the accompanying financial statements, may be used to offset Plan expenses or may be reallocated to Plan participants. The Plan made direct payments for administrative expenses in the amount of \$30,056 for the year ended December 31, 2024 that were covered by revenue sharing credits from Empower.

### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Society's nonelective contributions.

### Note 7 - Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by The Angell Pension Group, Inc. ("Angell"). Angell received an advisory letter dated March 31, 2017, in which the IRS stated that the volume submitter 403(b) plan document satisfies the applicable requirements of the IRC. Although the Plan itself has never received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified and considered tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower, TIAA and CREF, the custodians of the Plan.
