## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Pension Plan for Employees of Easter Seals, Inc. as maintained by Easter Seals UCP North Carolina & Virginia, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended August 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Pension Plan for Employees of Easter Seals, Inc. as maintained by Easter Seals UCP North Carolina & Virginia, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Pension Plan for Employees of Easter Seals, Inc. as maintained by Easter Seals UCP North Carolina & Virginia, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Pension Plan for Employees of Easter Seals, Inc. as maintained by Easter Seals UCP North Carolina & Virginia, Inc.'s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. PLAN DESCRIPTION:**

General –

The Pension Plan for Employees of Easter Seals, Inc. as maintained by Easter Seals UCP North Carolina & Virginia, Inc. (the “Plan”), is a defined benefit plan which covered substantially all employees of Easter Seals UCP North Carolina & Virginia, Inc. (the “Society”) after completion of one year of service provided they were at least 21 years of age. An employee who was at least 21 years of age was credited with one year of eligibility service if he or she completed 1,000 hours or more of service. Employees under 21 years of age were required to complete 1,700 hours of service in the 12-month period following his/her date of hire in order to become eligible for the Plan. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (“ERISA”), as amended, and as further discussed in this note, the Plan was frozen effective February 6, 2005.

Overall responsibility for administering the Plan rests with the Plan’s administrative committee (the “Committee”), which is appointed by the Board of Directors of the Society. The trustee, Principal Life Insurance Company, is responsible for the management and control of the Plan’s assets and has certain discretionary authority and control over such assets.

Retirement Benefits –

Participants may elect retirement between the ages of 55 and 65 with five years of vesting service. Normal retirement age is 65 with five years of vesting service. Benefits are received at normal retirement age or, if elected, at early retirement. Subject to certain plan provisions, upon elective retirement, participants may elect to receive their distributions in the form of an annuity or in a lump-sum payment, if their balance is less than \$10,000.

Participants who continue to be employed at the Society after reaching age 65 will not receive benefit payments until formal retirement. Upon formal retirement, the participant will receive a one-time catch-up payment for monthly payments from the attainment of age 65 to formal retirement. Monthly payments will commence after formal retirement.

The Plan administrator, in its sole discretion, may make a lump-sum payment if the participant’s accrued benefit is less than \$1,000. A vested participant who terminates for any reason other than retirement, disability, or death is entitled to the monthly vested termination benefit beginning on his normal retirement date in the amount of his/her accrued benefit.

If a fully vested participant dies before retirement, his/her beneficiary will receive 50% of the reduced monthly benefit beginning on the date the participant would have attained age 65 or one month after the date of death if the participant was age 55 or older.

**1. PLAN DESCRIPTION: (Continued)**

Retirement Benefits – (continued)

Benefits under the Plan are primarily based on employees' average compensation during the five highest compensated consecutive plan years out of the ten plan years prior to the earlier of the Plan's freeze date or retirement. Each participant's accrued benefit shall be determined under Section 5.1(a) of the plan. No employee of the Easter Seals UCP North Carolina & Virginia Affiliate who was not a participant in the plan on or immediately prior to February 6, 2005 shall be eligible to become a participant in the plan on or after February 6, 2005, and no period of the participant's employment, if any, after February 6, 2005 will be taken into account for purposes of computing benefit services. Each participant's accrued benefit under the terms and conditions of the plan shall be determined as of the end of the day on February 6, 2005, as if such participant had terminated employment on such date for purposes of computing years of benefit service.

**2. SIGNIFICANT ACCOUNTING POLICIES:**

Basis of Accounting –

The accompanying financial statements have been prepared using the accrual method of accounting. Accordingly, investment income is recognized when earned and expenses are recognized when incurred.

Use of Estimates –

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States ("US GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition –

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits –

Benefit payments are recorded when paid.

**2. SIGNIFICANT ACCOUNTING POLICIES: (Continued)**

Administrative Expenses –

Substantially all administrative expenses are paid by the Plan. These expenses include investment management, accounting, actuarial, trustee fees and certain allocations of expenses from the Society.

Contributions –

The Society's funding policy is usually to make contributions to the Plan to meet minimum funding requirements as determined by the Plan's independent actuary. The Plan met the minimum funding requirements prescribed by ERISA for the plan years ended August 31, 2024 and 2023. The Society made a contribution of \$62,500 during the year ended August 31, 2023 that was applied to the minimum funding requirement for the plan year ending August 31, 2024. The Plan does not allow for employee contributions.

Contributions Receivable –

The Plan had contribution receivables from the Society relating to contributions not yet funded as of August 31, 2024, and 2023. These contributions have subsequently been received by the Plan, no allowance for credit losses has been recorded.

Vesting –

Participants are fully vested in their accrued benefits.

Credit Losses –

Financial assets measured at amortized cost are presented at the net amount expected to be collected and the measurement of credit losses and any expected increases in expected credit losses are recognized in earnings. The estimate of expected credit losses involves judgement and is based on an assessment over the life of the financial instrument taking into consideration current market conditions and reasonable and supportable forecasts of expected future economic conditions. The Plan determined the allowance for credit losses on financial assets measured at amortized cost was de minimis as of August 31, 2024 and 2023, therefore, no allowance for credit losses has been recorded related to those assets.

Recently Issued Accounting Pronouncements –

In June 2016, the FASB issued ASU 2016-13, Measurement of Credit Losses on Financial Instruments (Topic 326). The guidance provides for estimating credit losses on financial assets measured at amortized cost by introducing an approach based on expected losses over the financial asset's entire life, recorded at inception or purchase.

This model replaces the probable, incurred loss model for those assets and broadens the information an entity must consider in developing its expected credit loss estimate for assets measured at amortized cost. The FASB also subsequently issued the following additional ASU's which amend and clarify the new expected loss methodology: ASU 2019-04, Codification Improvements to Topic 326, Financial Instruments – Credit Losses, Topic 815, Derivatives and Hedging, and Topic 825, Financial Instruments; ASU 2019-05, Financial instruments – Credit Losses (Topic 326) – Targeted Transition Relief; ASU 2022-02, Financial Instruments – Credit Losses (topic 326) – Troubled Debt Restructurings and Vintage Disclosures. The effective date for the ASUs was for annual and interim periods beginning after December 15, 2022.

The Plan adopted these ASU's effective September 1, 2023 using the modified-retrospective approach. The adoption of the new guidance under ASU 2016-13 did not have a material impact on the Plan's revenues, results of operations or financial condition.

**Uncertain Tax Positions –**

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Sponsor has evaluated the tax positions taken by the Plan, and has concluded that as of August 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or a disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. If applicable, the Plan would record interest and penalties on uncertain tax positions as income tax expense as part of total deductions.

**3. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS:**

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered through the valuation date. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits payable are included to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated Plan benefits is determined by the Plan's actuary using the unit credit cost method, and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money through discounts for interest and the probability of payment (by means of decrements such as for death, withdrawal or retirement) between the valuation date and the expected date of payment.

- Mortality basis – Pri-2012 mortality table projected to future years with historical and assumed mortality improvement (MI) rates using the Principal Mortality Improvement Scale (Principal 2023 and 2022) as of August 31, 2024 and 2023, respectively.
- Retirement Rates – 5% - 10% at ages 55-61  
100% at age 62
- Normal retirement age – age 65
- Salary increases – no estimated increases
- Actuarial Cost Method – unit credit accrued benefit cost method

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

For the year ended August 31, 2024, there was a \$198,005 minimum required contribution. There was a \$113,000 required contribution necessary for the year ended August 31, 2023.

**4. PLAN TERMINATION AND PENSION BENEFIT GUARANTY CORPORATION MATTERS:**

In the event the Plan terminates, the Plan's assets will be allocated to provide the following benefits in the order indicated:

1. Benefits of retired employees and employees who have reached their normal retirement dates.
2. Benefits of all other employees based on their accrued retirement benefits at the date of termination of the Plan in amounts proportionate to the actuarially determined present values of their retirement benefits at the date of termination of the Plan.
3. The remaining balance after satisfaction of all liabilities of the Plan will be returned to the Society.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation ("PBGC") if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the maximum amount of an individual's monthly benefit that the PBGC guarantees. That ceiling is between \$21,608 and \$1,777 per month based on a straight-line annuity or \$19,447 and \$1,599 for joint and 50% survivor annuity, based on the participant's years of service.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Society and the level of benefits guaranteed by the PBGC. While it has not expressed any intention to do so, the Society has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA.

**5. FAIR VALUE MEASUREMENTS:**

Fair value is defined as an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants. US GAAP defined a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities that the entity has the ability to access.
- Level 2 – Valuation based on quoted prices for similar assets or liabilities, quoted prices that are not active, or other inputs that are observable or can be corroborated by observable data for substantially the full term of the assets or liabilities.
- Level 3 – Valuations based on inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Pooled separate accounts: Pooled separate accounts invest primarily in domestic and international stocks, commercial paper or single registered investment companies. Net asset value (NAV) is used as a practical expedient to determine fair value for these accounts. Investments in pooled separate accounts are not classified according to the fair value hierarchy, in accordance with Accounting Standards Codification 820, as the NAV is used as a practical expedient to value the investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**8. TAX STATUS:**

The Plan obtained its latest determination letter on December 18, 2015, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”).

**9. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:**

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

Principal is the Plan’s record keeper and, therefore qualifies as a party-in-interest. The Plan regularly invests in common/collective investment funds for which Principal and its affiliates are the issuing parties. These party-in-interest transactions occur in the ordinary course of business and are exempt transactions.

Principal provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Plan and Principal. Principal receives revenue from mutual fund services providers for services Principal provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan.

If the revenue received by Principal from such mutual fund service providers exceeds the amount owed, Principal remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023 there were no excess amounts. The Plan or Plan sponsor may make a payment to Principal for administrative expenses not covered by revenue sharing.

**10. SUBSEQUENT EVENTS:**

The Plan has evaluated subsequent events through June 16, 2025, the date on which the financial statements were available to be issued.

The Blue collar base rate table was selected based on information provided by the plan sponsor.

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. **Treatment of administrative expenses**

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
