### Note 1: Description of Plan

The following description of the McKay Nursery Company 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by McKay Nursery Company (the "Employer"). Employees aged 18 or older are immediately eligible to participate and receive the Employer safe harbor contribution. To qualify for additional Employer discretionary matching and profit-sharing contributions, employees must complete at least 1,000 hours of service within a 12-month period. Participation in these additional Employer contributions begins either on September 1st or March 1st, depending on when the service requirements are met. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants are allowed to contribute, on a pretax basis up to 100% of eligible compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer makes contributions equal to a minimum of 3% of a participant's eligible compensation to this Plan. For the year ended August 31, 2024, the Employer safe harbor contributions equaled 3% of participants eligible compensation. No Employer discretionary matching or profit sharing contributions were made during 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer safe harbor contributions, Employer discretionary matching contributions, and allocations of the Employer's discretionary profit sharing contribution, forfeitures, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

A participant is fully and immediately vested in their contributions, rollover contributions, and Employer safe harbor contributions plus actual earnings thereon. A participant is vested in the Employer's discretionary matching and profit sharing contributions and earnings thereon according to the following schedule:

#### Forfeitures

Forfeitures of nonvested participant balances are used to reduce Employer contributions, to pay Plan administrative expenses, or are reallocated among eligible participants. As of August 31, 2024 and 2023, there were no amounts available in the Plan's forfeiture account. No forfeitures were incurred or used during the year ended August 31, 2024.

#### Payment of Benefits

Upon death, disability, or retirement, or upon separation from service with the Employer, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. In-service withdrawals are permitted for participants who have reached normal retirement age at any time up to their vested account balance. Distributions less than \$1,000 can be paid out as soon as administratively feasible without participant consent. Hardship distributions are not permitted.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through June 16, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of August 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Information Prepared and Certified by the Trustee

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

Fees incurred and paid by the Plan to the Trustee for plan administration services were \$3,413 for the year ended August 31, 2024.

The Employer pays directly certain fees related to the Plan's operations.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer discretionary matching and profit sharing contributions.

### **Note 7: Tax Status**

The Employer adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
