Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Therma-Stor 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to August 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Therma-Stor 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 30, 2024 and December 31, 2023, and for the period January 1, 2024 to August 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Therma-Stor 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination

As discussed in Note 1 to the financial statements, the board of directors of Therma-Stor LLC approved a plan to merge the plan assets of Therma-Stor 401(k) Plan into the Madison Air 401(k) Plan, a plan sponsored by Therma-Stor LLC's holding Company. As a result, Plan assets amounting to \$23,171,853, were transferred to the Madison Air 401(k) Plan and the Therma-Stor 401(k) Plan was terminated effective August 30, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of Plan

The following description of the Therma-Stor 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan Termination

Effective August 2024, the Plan Sponsor approved the merger of this Plan into the Madison Air 401(k) Plan. Madison Air is the holding company of Therma-Stor, LLC. As part of the merger, Non-Union employees of Therma-Stor, LLC became eligible to participate in the Madison Air 401(k) Plan effective September 3, 2024, and all contributions subsequent to that date were directed to the Madison Air 401(k) Plan. Effective August 30 2024, investments totaling \$23,171,853 were transferred into the Madison Air 401(k) Plan.

General

The Plan was a defined contribution plan covering substantially all employees of Therma-Stor LLC (the "Employer") not covered by a collective bargaining agreement. Participants entered the Plan on the first day of the month following the date of hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants could contribute up to 100 percent of their pretax or after-tax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan also allowed participants to roll over distributions from other qualified retirement plans. Participants could direct the investment of their contributions into various investment options offered by the Plan. The Employer could make discretionary matching contributions, qualified non-elective contributions and discretionary contributions. Employer discretionary matching contributions totaled \$391,733 for the period January 1, 2024 to August 30, 2024. No Employer qualified non-elective or discretionary contributions were made during the period January 1, 2024 to August 30, 2024. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, Employer discretionary matching contributions, and allocations of (a) the Employer's qualified non-elective and discretionary contributions, if any, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting and Forfeitures

A participant was fully and immediately vested in their contributions and Employer qualified non-elective contributions, plus actual earnings thereon. A participant was vested in the Employer discretionary matching and discretionary contributions and earnings thereon according to the following schedule:

Participants' vesting service included service with certain affiliates, as defined by the Plan.

As a result of the plan merger and termination, all unvested Employer contributions of active participants as of August 30, 2024, were considered 100% vested.

Participants who terminated for reasons other than death, disability, or retirement, and were less than fully vested, forfeited the nonvested portion of their account. Forfeitures of non-vested participant balances were used to reduce Employer contributions, pay plan expenses or were reallocated to remaining participants. During the period January 1, 2024 to August 30, 2024, forfeitures amounting to \$38,732 were used to offset Employer contributions and \$17,526 used to pay plan expenses, with \$11,873 being transferred to the Madison Air 401(k) Plan. The amount of unallocated forfeitures at August 30, 2024 and December 31, 2023, was \$0 and \$6, respectively.

Notes Receivable From Participants

Participants could borrow from their accounts up to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or, 50% of the participant's vested balance. The minimum amount of any loan was \$1,000 and loan terms ranged from one to five years except loans used to acquire a dwelling unit may extend up to 15 years. Loans were secured by the participant's investment accounts and bore interest at rates ranging from 3.25%-8.50%, commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were generally paid ratably through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or monthly installments over various periods or an annuity. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution or leave the account under the Plan. Terminated participants with account balances under \$5,000 were forced paid out in a lump sum. The Plan also permitted in-service distributions to participants over the age of 59 ½ or in the case of financial hardship.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceases to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Employer and are excluded from these financial statements. Fees related to benefit payments and to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 16, 2025, the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used since December 31, 2023. There were no Plan assets at August 30, 2024.

Pooled separate accounts: Investments in pooled separate accounts are valued using a readily available fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on these transactions.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Investments in common trust funds are valued using a readily determinable fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on these investments.

Note 4: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at August 30, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2024 to August 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee of the Plan.

Note 5: Related-Party-in-Interest Transactions

Fees paid during the period for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services. The Plan made direct payments to the third-party administrator of \$55,996 for the period January 1, 2024 to August 30, 2024. Certain legal, accounting, and administrative expenses relating to the maintenance of the Plan were paid by the Employer. Certain plan investments were pooled separate accounts and common collective trust funds managed by affiliates of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee. Transactions involving these investments were considered transactions with parties-in-interest.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective August 30, 2024, the Plan was merged into the Madison Air 401(k) Plan. See Note 1.

Note 7: Tax Status

The Employer adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan was amended since receiving the determination letter; however, the plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC and had no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in values of investment securities could occur and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
