Opinion

We have audited the accompanying financial statements of Atlantic Homecare, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of August 31, 2024 (in liquidation) and the related statement of changes in net assets available for benefits for the period November 1, 2023 through August 31, 2024 (in liquidation), and the statement of net assets available for benefits as of October 31, 2023 (in liquidation) and the related statement of changes in net assets available for benefits for the year then ended (in liquidation), and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits of Atlantic Homecare, Inc. Profit Sharing Plan as of August 31, 2024 (in liquidation) and October 31, 2023 (in liquidation), and the changes in net assets available for benefits for the period November 1, 2023 through August 31, 2024 (in liquidation) and the changes in net assets available for benefits for the year ended October 31, 2023 (in liquidation), in accordance with the accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Atlantic Homecare, Inc. Emphasis of Matter – Basis of Accounting

As described in Note 2 to the financial statements, the governing body of Atlantic Homecare, Inc. Profit Sharing Plan approved a plan of liquidation effective on February 28, 2023, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Atlantic Homecare, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan Termination

The Plan Sponsor approved termination of the Plan effective February 28, 2023. Upon termination, all participant accounts became 100% vested. As of August 31, 2024, all participant accounts were distributed to plan participants in accordance with the Plan document and the Plan had no remaining assets or liabilities.

General

The Plan was a defined contribution plan established by Atlantic Homecare, Inc. and subsidiaries (the Company) under the provisions of Section 401(a) of the Internal Revenue Code for the benefit of eligible employees of the Company. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

On October 29, 2019, the Company's Board of directors approved an amendment and restatement of the Plan effective November 1, 2019. The amendment and restatement, among other things, added a 401(k) provision to the Plan.

Eligibility

Employees were eligible to participate in the Plan at the beginning of the next quarter after their hire date and after working a minimum of 1 hour.

Employees were eligible to participate in the Plan's profit sharing as of the first day of the month following the date they first complete 1,000 hours of service during an eligibility computation period. The eligibility computation period shall mean a 12 consecutive month period beginning on the first day the employee performs an hour of service. However, if the employee does not complete 1,000 hours during such 12 month period, the eligibility computation period will become the plan year, beginning with the plan year immediately following the plan year within which the employee first performs an hour of service

Contributions

The Company may make discretionary profit sharing contributions as determined by the Board of Directors. The discretionary profit sharing contributions, if any, are invested in a portfolio of investments as directed by the Company. Only eligible participants shall receive a share of the allocation of the company contribution. The Plan allows the Company to determine the level of contributions, if any. The Company had no discretionary profit sharing contributions for the period November 1, 2023 through August 31, 2024 and for the year ending October 31, 2023, respectively.

Participants may contribute up to 100% of the participant's pretax annual compensation, as defined by the Plan, subject to an annual dollar limitation which is set by law. The Company may contribute discretionary matching contributions. For the period November 1, 2024 through August 31, 2024 and the year ending October 31, 2023, the Company elected to make no discretionary matching contributions.

Participant Accounts

Each participant's account is credited with an allocation of the Company's contribution, remaining forfeitures, and net investment earnings(losses). Allocations of the company contribution and remaining forfeitures are based on the compensation of the eligible participant in proportion to total compensation of all such eligible participants. Allocations of net investment earnings(losses) are determined based on the eligible participant's account balance at the beginning of the year less any distributions during the plan year in proportion to the total of all such eligible participants' beginning account balances less any distributions during the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested 100% in their contributions and subsequent investment growth. The Company's discretionary contributions made to the plan will be subject to the following vesting schedule:

Effective with the Plan's termination on February 28, 2023, all participants became fully vested in their accounts.

Benefit Payments

Upon termination of employment, death, disability, or retirement a Participant becomes eligible to receive the vested portion of his account balance in accordance with the provisions of the Plan.

Forfeitures

At August 31, 2024, there was a zero ending balance held in the forfeiture account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed by the Plan in preparing the financial statements:

Basis of Accounting

The financial statements have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions

Discretionary employer profit sharing and/or matching contributions are recorded when they are approved by the Board of Directors. Participant deferrals are recorded as soon as amounts are received.

Payment of Benefits

Benefit distributions are recorded when incurred by the Plan.

Forfeited Accounts

As of August 31, 2024 and October 31, 2023, forfeited, non-vested accounts totaled \$0. The Plan provides for forfeitures to be reallocated to participants. Forfeitures of \$0 and \$0 were reallocated to participants for the period November 1, 2023 through August 31, 2024 and the year ending October 31, 2023, respectively.

Reclassifications

Certain amounts in 2023 may have been reclassified to conform to the 2024 presentation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation in fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the

Investment Valuation and Income Recognition

accrual basis. Dividends are recorded on the ex-dividend date. Acquisition costs are included in the cost of investments purchased, and sales are recorded net of selling expenses.

Administrative Expenses

As provided in the Plan Document, administrative expenses may be paid either by the Plan or the Company. The Company has historically paid a portion of the operating expenses for the Plan.

3. INVESTMENTS

The Custodians hold the Plan's investments and execute all investment transactions. The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment and insurance companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. The Plan's exposure to a concentration of risk is limited by the diversification of investments across multiple investment fund options. Additionally, the investments within each investment fund option are further diversified into varied financial instruments.

4. CASH

The Plan maintains deposits in financial institutions that occasionally exceed amounts covered by the insurance provided by the U.S. Federal Deposit Insurance Corporation (FDIC). Plan management believes that there is no significant risk with respect to these deposits. As of August 31, 2024 and October 31, 2023, the Company had uninsured cash balances of \$0 and \$2,026,196, respectively.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and October 31, 2023.

Common stocks: Certain common stocks are valued at the closing price reported in the active market in which the individual securities are traded. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less an appropriate discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings less an appropriate discount. The multiple chosen is consistent with multiples of similar companies based on current market prices.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the plan at year end.

Common collective trust funds: Valued at NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Principal Trust Company. Principal Trust Company is a custodian as defined by the Plan and, therefore, these transactions qualify as part-in interest transactions.

7. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated April 23, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2019.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through June 16, 2025, the date the audit report and financial statements were available to be issued.


