**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Illinois Health and Hospital Association 401(k) and Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established in 1985 as a defined contribution plan covering all eligible employees of the Illinois Health and Hospital Association (the Association or Employer). An eligible employee (a participant) is any regular full-time employee or regular part-time employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Committee is responsible for oversight of the Plan, as delegated by the Board of Trustees of the Association. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Association's Board of Trustees.

Contributions: Each year, participants may contribute up to 80% of eligible compensation, as defined in the Plan. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. If automatically enrolled in the Plan, the pre-tax contribution rate will automatically increase by one percentage point each April 1, until the pre-tax contribution rate reaches 6% or the participant elects to stop future automatic annual increases. Eligible participants may elect to make Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Each pay period, the Employer makes Matching Contributions to the account of each eligible employee equal to 100% of the first 6% of eligible compensation that a participant contributes to the Plan. The Employer will also make an Employer Retirement Contribution to the Plan on behalf of eligible employees equal to 2.5% of eligible compensation for each payroll period up to the annual compensation limit as defined by the Internal Revenue Code (IRC), regardless of whether the employee makes any contributions. Contributions are subject to certain limitations defined by the IRC.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contributions, and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Participants actively employed on or after January 1, 2017 are immediately vested in the contributions made by the Employer on behalf of each participant, which includes both the Employer Matching Contribution and the Employer Retirement Contribution.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Benefit amounts under \$7,000 are automatically distributed to participants. Active participants may also take distributions from the Plan upon attainment of age 59½.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Notes Receivable from Participants: Participants may borrow from the portion of their fund accounts attributable to employee contributions a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions. Loan terms range from one to five years.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Stable Value Collective Trust: The fair values of participation units held in the collective trust are based on the net asset values per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net assets values per share, with no advance notice requirement for participant transactions.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer. Certain investments of the Plan at December 31, 2024 and 2023 were invested in mutual funds managed by Fidelity Investments. Fidelity Investments is affiliated with Fidelity Management Trust Company, the trustee of the Plan, and Fidelity Investments Institutional Operations Company, recordkeeper of the Plan; therefore, these transactions and the Plan’s payment of fees to the trustee and recordkeeper of the Plan qualify as party-in-interest transactions. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service has determined and informed the Employer by a letter dated December 8, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended, Plan management believes that the Plan is currently being operated in accordance with the applicable standards of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; currently the Plan is under examination by the DOL for the year ended December 31, 2022 and through the present date. The Plan Administrator believes it is no longer subject to income tax examinations of years prior to 2021.

**NOTE 7 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through June 9, 2025, which is the date the financial statements were available to be issued.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Illinois Health and Hospital Association 401(k) and Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established in 1985 as a defined contribution plan covering all eligible employees of the Illinois Health and Hospital Association (the Association or Employer). An eligible employee (a participant) is any regular full-time employee or regular part-time employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Committee is responsible for oversight of the Plan, as delegated by the Board of Trustees of the Association. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Association's Board of Trustees.

Contributions: Each year, participants may contribute up to 80% of eligible compensation, as defined in the Plan. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. If automatically enrolled in the Plan, the pre-tax contribution rate will automatically increase by one percentage point each April 1, until the pre-tax contribution rate reaches 6% or the participant elects to stop future automatic annual increases. Eligible participants may elect to make Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Each pay period, the Employer makes Matching Contributions to the account of each eligible employee equal to 100% of the first 6% of eligible compensation that a participant contributes to the Plan. The Employer will also make an Employer Retirement Contribution to the Plan on behalf of eligible employees equal to 2.5% of eligible compensation for each payroll period up to the annual compensation limit as defined by the Internal Revenue Code (IRC), regardless of whether the employee makes any contributions. Contributions are subject to certain limitations defined by the IRC.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contributions, and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Participants actively employed on or after January 1, 2017 are immediately vested in the contributions made by the Employer on behalf of each participant, which includes both the Employer Matching Contribution and the Employer Retirement Contribution.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Benefit amounts under \$7,000 are automatically distributed to participants. Active participants may also take distributions from the Plan upon attainment of age 59½.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Notes Receivable from Participants: Participants may borrow from the portion of their fund accounts attributable to employee contributions a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions. Loan terms range from one to five years.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Stable Value Collective Trust: The fair values of participation units held in the collective trust are based on the net asset values per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net assets values per share, with no advance notice requirement for participant transactions.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer. Certain investments of the Plan at December 31, 2024 and 2023 were invested in mutual funds managed by Fidelity Investments. Fidelity Investments is affiliated with Fidelity Management Trust Company, the trustee of the Plan, and Fidelity Investments Institutional Operations Company, recordkeeper of the Plan; therefore, these transactions and the Plan’s payment of fees to the trustee and recordkeeper of the Plan qualify as party-in-interest transactions. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service has determined and informed the Employer by a letter dated December 8, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended, Plan management believes that the Plan is currently being operated in accordance with the applicable standards of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; currently the Plan is under examination by the DOL for the year ended December 31, 2022 and through the present date. The Plan Administrator believes it is no longer subject to income tax examinations of years prior to 2021.

**NOTE 7 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through June 9, 2025, which is the date the financial statements were available to be issued.
