INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CASA Mechanical Services 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements



December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

CASA Mechanical Services 401(k) Retirement Plan (Plan) is a defined contribution plan adopted by CASA Mechanical Services (Sponsor) on May 1, 2001, and was most recently amended and restated effective October 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility: Employees (except union employees and nonresident aliens) who have one year of service and have attained the age of 21 are eligible to participate in the Plan. Employees may enter the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date the employee satisfies the eligibility requirements.

Contributions: Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. A participant's contribution cannot exceed the annual dollar limitation set forth by Internal Revenue Code (IRC) Section 402(g). Participants may also designate some or all of their contributions as Roth deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who are age 50 or will attain age 50 before the end of the calendar year, may also make additional catch-up salary deferral contributions that are in addition to any limits that are imposed by the Plan and federal law.

The Sponsor may make a discretionary matching contribution equal to a uniform percentage or dollar amount based on a participant's salary deferrals. Additionally, the Sponsor may make a discretionary nonelective contribution. The contribution will be determined by calculating the participant's share based on their annual compensation relative to annual compensation of all participants who are eligible to receive the nonelective contribution. In order to receive the discretionary nonelective contribution, the participant must complete at least 500 hours of service during the Plan year. For 2024, the Sponsor did not make a discretionary matching or nonelective contribution to the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, Sponsor contributions, rollovers, and allocations of Plan earnings. Participant accounts are charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are always 100% vested in their salary deferrals, including catch-up contributions, rollovers, and any earnings thereon. Sponsor matching and nonelective contributions are subject to a six-year graded vesting schedule in which participants earn 20% vesting each year after two years of service. Participants will become 100% vested in all of their accounts under the Plan upon death, disability, or normal retirement age while still employed by the Sponsor.

Investment Options: Participants direct the investment of their entire interest in the Plan into investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable From Participants: Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator by reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions.

Forfeitures: When participants separate from service, any amounts that are not vested will be forfeited. For any Plan year, forfeitures occurring under the Plan may be allocated to other participants, used to pay administrative expenses of the Plan, or used to reduce employer contributions.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Payment of Benefits: Upon termination of employment, normal retirement, disability, or death, a participant may receive a distribution of the vested portion of their accounts in the Plan. If a participant's vested account balance does not exceed \$7,000, the Sponsor will distribute their vested account balance in a single lump-sum payment. If a participant's vested account balance exceeds \$7,000, they may elect to receive a distribution in a single lump-sum payment or installments. Participants who have attained age 59½ or normal retirement age may receive an in-service distribution from certain accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Effective January 1, 2024, and in accordance with Section 314 of the SECURE 2.0 Act of 2022, the Plan adopted to allow penalty-free distributions to participants who are victims of domestic abuse.

Administrative Expenses: The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Sponsor or indirectly through investment-related revenue sharing arrangements. Expenses that have been paid by the Sponsor are excluded from these financial statements. Expenses relating to specific participant transactions (i.e. loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

The Plan may incur other expenses (e.g., legal, accounting, and audit services). The actual amount of these expenses may vary from year to year. To the extent such expenses are not charged against forfeitures, indirectly through investment-related revenue sharing arrangements, or paid by the Plan Sponsor, these expenses may be paid from the Plan's assets and deducted from the participant's accounts on a pro-rata basis. The term pro-rata describes a fractional amount as determined by comparing the participant's account balance to the Plan's total balance. A fee charged pro-rata is allocated proportionately to the participants' account.

Plan Termination: Although it has not expressed any intent to do so, the Sponsor has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions and earnings thereon.

Subsequent Events: On February 1, 2025, the Plan Sponsor elected to transition the Plan to a Pooled Employer Plan ("PEP"). The Plan will become part of a PEP administered by The Finway Group. The transition to the PEP is expected to result in changes to certain plan provisions, service providers, and administrative procedures. Plan assets will remain protected and fiduciary responsibility for administration will shift to the pooled plan provider, as outlined in the governing PEP documents. The financial statements do not reflect any adjustments related to the transition, as the event occurred subsequent to the Plan's year-end of December 31, 2024, and does not impact conditions that existed as of that date.

The Plan has evaluated subsequent events through June 12, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value) as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company (AUL), a OneAmerica company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Pooled Separate Accounts: The fair values of accumulation units held in the pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement date and recent transaction prices. Each of the pooled separate accounts held by the Plan is a passively managed fund that invests in mutual funds or other investment entities as directed by the contract holder. The underlying investment composition of the pooled separate accounts as of December 31, 2024 and 2023, was approximately 42% target date mutual funds, 52% US equity index funds and 6% fixed income securities funds, respectively. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

NOTE 5 – INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive guaranteed investment contract (GIC). This contract is included in the financial statements at contract value, which is the relevant measure for fully benefit-responsive investment contracts because it is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The issuer is contractually obligated to repay the principal and a specified rate of interest that is guaranteed to the Plan. The crediting interest rate is reset annually by AUL and is based on a formula defined in the contract, which considers factors such as current interest rates, investment performance, and market conditions. For the years ended December 31, 2024 and 2023, the interest rates credited to participant accounts were 1.25% and 1.75%, respectively.

AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan does not permit participants to direct transfers between the GIC and competing investment options. The Plan's ability to receive amounts due is dependent on AUL's ability to meet its financial obligations. AUL's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with AUL. Such events include a full or partial Plan termination, the insolvency of the Sponsor, or aggregate terminations in any contract year exceeding 20% of the full contract value as determined on the first day of that contract year. No events are probable occurring that might limit the ability of the Plan to transact at contract value with AUL and that also would limit the ability of the Plan to transact at contract value with the participants. As of December 31, 2024 and 2023, the contract value of the investment contract was \$248,183 and \$253,201, respectively.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor. AUL serves as the recordkeeper and custodian for the Plan. As such, it manages certain Plan investments, including the fully benefit-responsive investment contract disclosed in Note 5. Therefore, the Plan's payment of fees to AUL for these services qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 – INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by OneAmerica Financial Partners Inc. The non-standardized pre-approved profit-sharing plan obtained its latest opinion letter on August 19, 2020, in which the Internal Revenue Service stated that the pre-approved profit-sharing plan, as then designed, was acceptable under section 401 of the IRC for use by the employer for the benefits of its employees. Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the requirements of the IRC.

NOTE 7 – INCOME TAX STATUS (Continued)

GAAP requires plan management to evaluate tax positions taken by the Plan. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
