Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Stack Exchange, Inc. Retirement Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 17, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through March 17, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Stack Exchange, Inc. Retirement Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 17, 2023 and December 31, 2022, and for the period from January 1, 2023 through March 17, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stack Exchange, Inc. Retirement Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stack Exchange, Inc. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Stack Exchange, Inc. Retirement Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Company decided to merge the Plan into the Prosus 401(k) Plan (the "New Plan"), an existing retirement plan sponsored by the Company. Effective January 1, 2023, plan participants began participating in the New Plan and the Plan was terminated on March 17, 2023 (see Note 9).

The Plan is a defined contribution plan established effective May 1, 2010, as restated June 1, 2021. The Plan covered all employees, excluding employees covered by a collective bargaining agreement, nonresident aliens who received no earned income from the employer who constitutes income from sources within the United States and leased employees employees, of Stack Exchange, Inc. (the "Company") who are age 18 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Board of Trustees was responsible for oversight of the Plan. The Plan's investment committee determined the appropriateness of the Plan's investment offerings, monitors investment performance, and reported to the Plan's Board of Trustees.

Contributions

Each year, participants were permitted to contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may have designated all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants also may have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3 percent of eligible compensation

and their contributions invested in Vanguard Target Retirement until changed by the participant. The Company contributed a base rate of 100% up to 3% of compensation plus 50% for elective deferrals greater than 3% but less than or equal to 5%. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. For the year ended December 31, 2023, there were no profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined daily, was set at the Prime rate, as defined. Principal and interest were paid ratably through payroll deductions. Terms ranged up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may have elected to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance was less than or equal to \$5,000, the amount may have been automatically distributed in the form of lump sum or rollover. In addition, the Plan allowed for hardship distributions if certain criteria were met.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 15, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at March 17, 2023 and December 31, 2022.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Transfers Into or Out of the Plan

From time to time, employees may no longer meet the eligibility requirements of the Plan and become eligible to participate in another qualified plan sponsored by the Company, or vice versa. These employees have their account balances transferred between the Plan and another qualified plan sponsored by the Company. See Note 9 for discussion of the Plan merger and termination.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, Ascensus Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of March 17, 2023 and December 31, 2022, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2023 through March 17, 2023.

6. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Tax Status

The Plan adopted a pre-approved plan offered by Ascensus, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Plan Termination

The Company decided to merge the Plan into the New Plan, an existing retirement plan sponsored by the Company. Effective January 1, 2023, plan participants began participating in the New Plan.

As part of the plan merger process, the Company initiated the transfer of all assets from the Plan to the New Plan. The transfer of assets was executed in accordance with the rules and regulations stipulated by ERISA and under the supervision of the plan fiduciaries. The transfer was completed on March 17, 2023.

The Plan was effectively terminated on March 17, 2023. The Company had the right under the Plan to modify the benefits provided to participants, to discontinue contributions at any time, and to terminate the Plan, subject to the provisions set forth in ERISA.

In connection with your correspondence dated May 19, 2025, as a Plan Administrator, I am writing to provide a “Statement of Reasonable Cause” for your consideration in connection with our request for consideration of the abatement of any potential penalty.


Please note that, consistent with prior years, we had the full intention of complying with all reporting requirements and filing dates, however due to several circumstances, certain of which were outside of our control, we were unable to submit the filing by the required date and therefore request relief from any associated penalty.

Specifically, we were delayed in making the submission by the required date due to the following reasons:

1. During 2023, and pursuant to the acquisition of the Company, several retirement plans were merged into one single, unified plan resulting in a great deal of compliance and operational complexity which had not been present in previous years.
2. During the course of navigating the audits and compliance requirements associated with this merger of the retirement plans, the Company became aware, often months later, of documentation required to complete the filing. This resulted in delays associated with identifying the location and requesting and obtaining the information required. This situation was compounded by personnel changes both within the Company and within the audit firm.
3. During the timeframe of the 2023 audit, the Company experienced a significant reduction in force impacting its ability to allocate resources to the completion of the filing. In addition, certain of the entities which merged into the new plan were also downsized. As a result, many of the personnel who initially handled financial and payroll functions were no longer available to assist in the audit and filing preparation process.
4. The Company’s parent is based in Amsterdam, and as a result of the merging of the plans it became necessary to seek certain information from the parent company. It was very difficult to locate the appropriate personnel who could assist in gathering the required information, communicate the requirements to which the Company was subject in the U.S. jurisdiction, and receive the information necessary on a timely basis.

5. The audit firm which the Company has used historically changed ownership during the timeframe of the audits, and certain personnel who worked on the Company's account departed, further compounding the delays and complexity associated with the timely completion of the required filing.

We sent you a Notice of Rejection dated February 18, 2025, rejecting the Plan's Form 5500 annual report for the following reasons:

The Independent Qualified Public Accountant (IQPA) Report, required by the Department regulation Section 2520.103-1(b) was not included with the original filing. The IQPA report must include the Accountant's Opinion, Financial Statements, Notes to the Financial Statements, and Supplemental Schedules.

We acknowledge you submitted to the Department an amended filing on March 28, 2025. However, it was not acceptable because it contains the following deficiency:

Form 5500, Schedule H, Part IV, line 5b appears to be incorrect. Line 5b reports that the Plan transferred assets or liabilities during the 2023 plan year to "NNV New Ventures, Inc" with an EIN/PN of 36-4823047/001. However, Note 1 of Financial Statements attached to the IQPA report states that the Plan was merged into "Prosus 401(k) Plan."

Therefore, it appears that Schedule H, Part IV, line 5b may be inaccurate in its reporting of the transfer of plan's assets and liabilities.

We intend to assess a civil penalty because you have not filed a revised, satisfactory filing within 45 days of the Notice of Rejection.

Your annual report was due on October 31, 2024. Using this original due date, without regard to extension, the penalty amount is calculated as \$30/day for 200 days, which amounts to \$6,000.

Other Item (Schedule H, Part IV, Line 5b): \$30 per Diem for 200 days = \$6,000

You could be subject to additional civil penalties up to \$2,739 per day until you file an amended annual report satisfactory to the Department.²

YOUR NEXT TWO STEPS:

1. File a Statement of Reasonable Cause

As the Plan Administrator, you must file a written Statement of Reasonable Cause, **signed under penalties of perjury**, within 30 days from the date of receipt of this Notice.

Your written Statement of Reasonable Cause must:

- State that you, as Plan Administrator, complied with the reporting requirements, or explain why you did not;

² Plan Administrators are responsible for correcting the Form 5500 annual report. Failure to properly select and monitor service providers, including but not limited to qualified auditors and record keepers of employee benefit plans, exposes the Plan Administrator to potential fiduciary violations and civil penalty assessments.

- Offer all explanations for why the penalty should be reduced or eliminated;³
- Contain a declaration by the Plan Administrator that the “*Statement is made under penalties of perjury, as required under Section 2560.502c-2(e)*”; and
- Be signed by the Plan Administrator or by the Plan Administrator’s authorized representative where the representative has been granted that specific authority pursuant to a duly executed power of attorney (see last page).

Your sworn, written Statement of Reasonable Cause is deemed “*filed*” with the Department when it is:

1. Transmitted via online or email as described above; or
2. Sent Certified or Express mail via the U.S. Postal Service; or
3. Received by a designated private delivery service;⁴ or
4. Received by the Department at the address provided in this Notice.

We will determine whether to assess a penalty in this case after we review your timely filed statement. If you file a timely Statement of Reasonable Cause, the Department will not assess a penalty for any day starting from the date the Department serves this Notice until the day after the date the Department serves you with its determination on your Statement of Reasonable Cause.

2. File an Acceptable Amended Form 5500 Annual Report

You must electronically file an amended Form 5500 annual report including all schedules,

statements, and attachments for Plan Year 2023. You can find guidance on submitting a Form 5500 at efast.dol.gov.

In addition, email drc@dol.gov to confirm that you filed an acceptable, amended Form 5500 annual return/report. Include the Case Number 25-0294D in the subject line.

Plan Administrators in Bankruptcy

If you or the plan sponsor are currently a debtor in a bankruptcy petition, then provide us with detailed information concerning the bankruptcy proceeding, including but not limited to the following:

1. The petition filing date;
2. Case number;
3. Court where the petition was filed;
4. The chapter under which bankruptcy protection was sought;
5. Your bankruptcy counsel's contact information; and

IF YOU FAIL TO PROVIDE A SIGNED SWORN STATEMENT OF REASONABLE CAUSE

If you fail or refuse to file your signed, sworn written Statement of Reasonable Cause within 30 days from the date of receipt of this Notice, this penalty will then become a final order civil penalty without appeal rights to the Secretary.⁵ The above referenced intended penalty amount will then become due and payable.

The Department will assess additional costs of collection if you do not promptly remit payment.

When you pay this penalty, you must also notify the Office of the Chief Accountant at one of its addresses in this Notice.
