### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of 403(b) Thrift Plan of ENMRSH, Inc. Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1) Summary of Significant Plan Provisions**

The following description of the 403(b) Thrift Plan of ENMRSH, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 403(b) defined contribution plan covering all employees of ENMRSH, Inc. (the “Employer”), except for employees who are highly compensated as defined in the Internal Revenue Code (the “Code”). There is no minimum age or service requirement to participate in the Plan. Employees are eligible to begin deferring on the 1st of the month following the date of hire. Employees who have completed a year of service and are twenty-one or older are eligible to receive Employer contributions.

The Plan is designed to comply with Section 403(b) and the regulations thereunder of the Internal Revenue Code (the “Code”) as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer serves as the Plan administrator.

Contributions

Upon enrollment in the Plan, participants direct the investment of all contributions in a variety of investment options offered by the Plan. The Plan provides for employee contributions pursuant to a tax-deferred savings agreement. Each year, participants may contribute annual pretax compensation, as defined by the Plan, limited to the annual statutory maximum as determined by the Internal Revenue Service. Additional catch-up contributions may be made by participants who have attained age 50 before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Employer matches 100% of the participants’ elective contributions, up to 5% of the participant’s eligible compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer’s contribution, and allocations of Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

The Plan does not permit notes receivable from participants.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Employer's matching contribution, plus earnings thereon, is based on years of service as defined by the Plan. A participant is 100% vested after three years of credited service, with no partial vesting prior to full vesting.

Payments of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. A participant may take in-service distributions of Employer funds if they have at least five years of service. If the participant received Employer contributions prior to January 1, 2009, the funds may be withdrawn after completion of three years of service. Employee funds contributed prior to 1989 are allowed to be withdrawn at any time.

Mandatory Cash-Out

If a participant terminates employment and the participant's account balance not exceed \$1,000, the Plan administrator will authorize a single lump-sum benefit payment to the participant without the participant's consent.

Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used to pay Plan administrative expenses or reduce future Employer contributions. There were no unallocated and nonvested accounts at December 31, 2024 and 2023, and no forfeitures were available to be used.

**2) Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Risk and Uncertainties

The Plan invests in a variety of investment funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. At any time, the Employer may elect for the Plan to pay administration costs. The Employer paid a majority of the Plan's expenses for the years ended December 31, 2024 and 2023, which are excluded from these financial statements. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

#### Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through June 4, 2025, the date which the financial statements were available to be issued.

### 3) Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Separate Accounts:* The net asset value (NAV) of the separate accounts (SA) is based on unit values reported by the Plan trustee, which is principally the market value of the underlying investments; however, management has determined that the SA net asset value per unit is not a publicly quoted price. Assets measured using net asset value as a practical expedient are not assigned a level in the fair value hierarchy.

*General Account:* The Interest Accumulation Account is part of the general assets of Mutual of America Life Insurance Company and, as such, does not have a publicly quoted price. The investments underlying the interest accumulation account are valued by the Mutual of America Pricing Group on a daily basis. A unit value is calculated daily, based on a daily credited interest rate which is based on unit value tables entered into a database each time a rate change is announced. The account rate is guaranteed never to go lower than one percent. The value of a participant's fund balance is equal to the daily value multiplied by the number of units accumulated.

**4) Information Prepared and Certified by the Trustee (Unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, the trustee of the Plan, has certified to the completeness and accuracy of:

**5) Interest Accumulation Account**

Mutual of America Life Insurance Company offers several investment alternatives within the Plan that are held with the insurance company, including the Interest Accumulation Account. None of these investment alternatives are considered to be fully benefit-responsive investment contracts, stable value funds, or guaranteed investment contracts.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their balances to other investment options offered by the Plan or from the Plan in accordance with permitted rollovers, benefit payouts, or hardship withdrawals. The crediting interest rate was approximately 2.9% and 1.5% as of December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at current fair value with Mutual of America Life Insurance Company. Such events could include: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (c) the failure of the Plan to qualify for exemption from federal income taxes or any required or prohibited transaction exemption under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator does not believe that any events that would limit the Plan's ability to transact at fair value with Plan participants have occurred or are probable of occurring.

**6) Plan Termination**

Although it has not expressed intent to do so, the Employer, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

**7) Income Tax Status**

The Plan is operating under a prototype document with a nonstandardized 403(b) adoption agreement. The Internal Revenue Service (IRS) has determined and informed the prototype plan sponsor by letter dated March 31, 2017, that the prototype plan, as then designed, is in compliance with applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype sponsor. The Plan was amended after the IRS issued the opinion letter to the prototype sponsor. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan is no longer subject to income tax examinations for years prior to 2021.

**8) Related-Party and Party-In-Interest Transactions**

The Plan investments are managed by Mutual of America Life Insurance Company, the trustee. These transactions qualify as exempt party-in-interest transactions. In addition, the Employer provides certain accounting, administrative, and management services to the Plan for which no fees are charged.
