INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cemen Tech Holdings 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis of Opinion

NOTES TO FINANCIAL STATEMENTS

September 30, 2024 and 2023

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Cemen Tech Holdings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of Cemen Tech Holdings, Inc. (the Company or Plan Administrator) who have one month of service and are age eighteen or older. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company has contracted with Principal Trust Company (Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

Contributions

The Plan allows for employee contributions up to 100% of eligible compensation, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participant deferral rates are automatically increased 1% annually to a maximum of 10%. The Plan permits discretionary employer matching contributions, but there were none during the years ended September 30, 2024 and 2023.

Participant Accounts

Each participant's account is increased or decreased by the participant's contributions, withdrawals and an allocation of Plan earnings (losses), net of administrative expenses and an allocation of the Company's contributions. Allocations to participants are based on the funds selected by the participant, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become vested in Company discretionary matching contributions on a schedule beginning after two (2) years of vesting service, as defined in the Agreement. The initial vesting percentage is 20%, increasing by 20% annually, until becoming fully vested after six (6) years of vesting service, as defined in the Agreement.

NOTE 1 — DESCRIPTION OF THE PLAN (Continued)

Notes Receivable, Participants

Participants are permitted to borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Outstanding loans are limited to two (2) per participant at any given time, are secured by the balance in the participant's account, and bear a reasonable fixed interest rate, as determined by the loan administrator. Principal and interest are paid ratably through payroll deductions. Interest rates range from 3.25% to 8.50% for loans outstanding at September 30, 2024. The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) enacted March 27, 2020, allowed participants to borrow the lesser of \$100,000 or 100% of their vested balance through December 31, 2020.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum distribution or annual installments equal to the value of the participant's vested interest in his or her account, as defined. Participants who separate from employment with vested account balances less than \$5,000 will automatically receive their benefit in a single lump-sum. A participant may also withdraw a portion of his or her vested interest upon attaining age 59 1/2 while still employed by the Company. In addition, hardship distributions are permitted if certain criteria are met.

Forfeitures

Forfeited accounts may first be used to pay administrative expenses and then to reduce employer contributions. Any remaining forfeiture balance shall be allocated to participants. There are no forfeitures at September 30, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable, Participants

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued interest. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

Contributions

Contributions from the Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participants are responsible for certain transaction-related expenses, investment advisory and recordkeeping fees. Certain investment-related expenses are included as a reduction of net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 — INFORMATION CERTIFIED BY PRINCIPAL

The following is a summary of the unaudited information regarding the Plan as of and for the years ended September 30, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, that was prepared from information provided by Principal, the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that such information is complete and accurate.

NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023:

Mutual funds: Valued based on quoted prices of identical assets in active markets.

Pooled separate accounts: Valued based on quoted redemption values, also known as net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within thirty (30) days. Other than the Principal U.S. Property Separate Account, there are no limitations on redemptions.

The NAV of the Principal U.S. Property Separate Account is based on the underlying real estate assets, which are valued using discounted cash flow valuation models that utilize public real estate market data such as transaction prices, market rents, vacancy levels, leasing absorption, market cap rates and discount rates. In addition, each property is appraised annually by an independent appraiser. Principal has the ability to apply a contractual limitation, which delays the payment of withdrawal requests (Withdrawal Limitation). The Withdrawal Limitation has been in effect since July 1, 2022. As of September 30, 2024 there was one outstanding distribution request for \$2,547.

Collective investment trust: Valued based on quoted redemption values, also known as NAVs, determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. Participant-initiated transactions may take up to thirty (30) days to process. Plan sponsor-initiated transactions, such as terminating the fund as an investment option or terminating the Plan, may require a twelve-month (12) notice period.

Participant-directed brokerage account: These investments include exchange-traded funds that are publicly traded and valued based on quoted prices of identical assets in active markets.

NOTE 5 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Principal. Principal is the recordkeeper and custodian for the Plan and provides investment advice to the Company as to the selection of investment options. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Therefore, these transactions with Principal qualify as party-in-interest transactions. A participant who acquires a participant loan is also a party-in-interest. However, all such transactions are exempt and are not prohibited by ERISA.

NOTE 7 — INCOME TAX STATUS

The Plan was created from a prototype developed by Principal. The IRS has determined and informed Principal, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and therefore, is acceptable for use by employers for the benefit of their employees.

The letter also states that the IRS is not making a determination as to whether plans created from the prototype, such as this one, are designed in accordance with applicable sections of the IRC, but that such plans would be considered qualified provided all the terms of the prototype plan are followed and plan provisions are not more favorable to certain individuals. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. Plan management has not identified any uncertain tax positions.
