## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Employee Benefit Plan of Maine Association for Community Service Providers (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. ### 1. Description of the Plan

The following description of Employee Benefit Plan of Maine Association for Community Service Providers (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan, which became effective July 1, 2020, is a tax-exempt, defined contribution multiple employer plan. The Plan sponsor is the Maine Association for Community Service Providers (the Association). The Plan covers all eligible employees of adopting employers who are members of the Association. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. As of June 30, 2024, below are the adopting employers:

- Maine Association for Community Service
- Life Enrichment Advancing People
- Independence Association, Inc.
- Affinity
- MERT Enterprises, Inc.
- OHI
- Elmhurst, Inc.
- Gallant Therapy Services
- Northeast Residential Services, LLC
- Uplift, Inc.

Subsequent to June 30, 2024 one new employer, Personal Onsite Development, entered the Plan transferring assets of \$442,339.

Mutual of America Life Insurance Company, (MOA) is the recordkeeper and custodian of the Plan.

#### Contributions

Participants may contribute up to 100% of eligible compensation, as defined in the plan document, to the Plan, subject to the limitations established by the Internal Revenue Code (the Code). In addition, participant contributions may also consist of rollovers from other qualified retirement plans, as allowed by each adopting employers plan document. Employer contributions are outlined in each of the adopting employers plan document.

#### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Participants are subject to plan provisions for employer vested balances.

### **Forfeited Accounts**

As of June 30, 2024 and 2023, there were \$3,261 and no forfeited non-vested accounts, respectively. For the year ended June 30, 2024, there were no forfeitures used to offset employer contributions.

### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan offers investments in pooled separate accounts and an interest accumulation account.

### **Notes Receivable from Participants**

If allowed within the adopting employers plan document, participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, may be longer if used for the purchase of a primary residence. The loans are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Principal and interest are paid ratable through payroll deductions or direct payments.

### **Payment of Benefits**

Participants shall become eligible to receive their account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances as outlined in the adopting employers plan document, see specific plan provisions covering in-service and hardship requests.

## 2. **Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent asset and liabilities, at the date of the financial statements. Actual results could differ from those estimated.

### **Investments**

The Plan's investments are stated at fair value, except for the interest accumulation account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Administrative Expenses**

Substantially all administrative expenses are paid by the Association and adopting employers on behalf of the Plan.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through May 14, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Interest Accumulation Account**

The interest accumulation account is an investment contract, between participants and MOA, which is held in the general account of MOA. The contract is a fully benefit-responsive contract. The contract is included in the financial statements at contract value as reported to the Plan by MOA. This account represents the original contributions made under the contract, plus cumulative interest earnings, less participant withdrawals and administrative expenses. This account becomes part of MOA's general assets, which supports MOA's insurance and annuity obligations. MOA bears the full investment risk of all amounts participants allocate to the interest accumulation account. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### **4. Income Tax Status**

The Plan is a prototype non-standardized profit sharing plan sponsored by MOA. The Internal Revenue Service has determined and informed MOA by a letter, dated November 30, 2020, that the form of the prototype non-standardized profit sharing plan is designed in accordance with applicable sections of the Code. The Plan has been amended since MOA received the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

### 5. Information Prepared and Certified by Custodian

The investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by MOA as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

### 6. Party-in-Interest Transactions

Certain Plan investments are shares of diversified investment funds managed by MOA; therefore, these transactions qualify as party-in-interest transactions. The administrative expenses paid by the Plan for 2024 were \$10,878, and qualify as party-in-interest transactions as they are related to administration fees incurred by the Plan.

### 7. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts are valued at the quoted market price of the underlying assets and adjusted for administrative charges of the separate account.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
