## **INDEPENDENT AUDITOR'S REPORT**

To the Oversight Committee of the  
South Texas Lighthouse for the Blind 403(b) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the South Texas Lighthouse for the Blind 403(b) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the South Texas Lighthouse for the Blind 403(b) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to be independent of the South Texas Lighthouse for the Blind 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about South Texas Lighthouse for the Blind 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the South Texas Lighthouse for the Blind 403(b) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the South Texas Lighthouse for the Blind 403(b) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of September 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **South Texas Lighthouse for the Blind 403(b) Plan Notes to Financial Statements**

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of the South Texas Lighthouse for the Blind 403(b) Plan (the "Plan") provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of the South Texas Lighthouse for the Blind ("the Organization") for the benefit of its employees. The Plan was adopted effective April 1, 1995, and was most recently amended October 1, 2019. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Oversight Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance by utilizing investment advisory services from American Bank and Newport Group Consulting, LLC.

Some administrative functions are performed by employees of the Organization. No compensation is remitted to the Organization for these services.

Plan assets were formerly held and managed by Newport Trust Company, LLC and are currently held and managed by Ascensus Trust Company (the "Custodian") and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Oversight Committee and provides certain recordkeeping services. Ascensus, LLC (the "TPA") acts as the third-party administrator for the Plan, which performs certain Plan administration and annual ERISA compliance testing.

#### ***Merger***

On April 18, 2024, Newport Trust Company, LLC merged with Ascensus, LLC, an authorized representative of Ascensus Trust Company. As a result, on this date, all investments were transferred from Newport Trust Company, LLC to Ascensus Trust Company and the third-party administrator and record-keeper roles transferred from Newport Group, Inc. to Ascensus, LLC.

#### ***Eligibility***

Under the terms of the Plan, substantially all employees become eligible to make salary deferral contributions upon date of hire. However, employees must be at least 21 years of age, work a minimum of 20 hours a week, and have completed one year and 1,000 hours of service to be eligible for Organization discretionary matching or non-elective contributions.

#### ***Contributions***

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Code ("IRC") that would not cause the Plan to be in violation of regulations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan does not include an auto-enrollment provision and all employees must affirmatively elect whether to participate in the Plan.

### Note 1: DESCRIPTION OF THE PLAN (Continued)

#### *Contributions (Continued)*

In addition, participants with at least 15 years of service with the Organization are permitted to make qualified organization catch-up contributions up to the lower of (i), (ii) or (iii) below:

- (i) \$3,000; or
- (ii) The excess of \$15,000 over the total special 403(b) catch-up elective deferrals made for the qualified employee by the qualified organization for prior years, or
- (iii) The excess of \$5,000 multiplied by the number of years of service of the qualified employee with the qualified organization, over the total salary reduction contributions made for the employee by the qualified organization.

The Organization has the option to make discretionary matching contributions. For the years ended September 30, 2024 and 2023, the Organization elected to make matching contributions equal to 5% of the first 100% of eligible participating employees compensation totaling \$231,403 and \$205,585, respectively. For the years ended September 30, 2024 and 2023, total contributions on behalf of a participant should not exceed \$69,000 or \$66,000, respectively, or 100% of the participant's compensation for the year. No contributions for any employee exceeded these limits for the years ended September 30, 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Organization has the option to make discretionary non-elective contributions to the Plan. No discretionary non-elective contributions were made for the years ended September 30, 2024 and 2023.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, an allocation of the Organization's contributions (if any), an allocation of investment earnings and losses, and charged with withdrawals and administrative fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant salary deferrals may be treated as either "pre-tax" or "Roth" (after tax) contributions. This election can be made upon entrance to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service as follows:

Years of Service	Vested Benefits
Less than 3 years	0%
3 years	100%

#### *Plan Loans*

Participant loans are not permitted by the Plan.

### **Note 1: DESCRIPTION OF THE PLAN (Continued)**

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or a direct rollover to another eligible plan or Individual Retirement Account (IRA). For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In certain limited circumstances, participants may make in-service withdrawals of their vested accounts on or after attainment of age 59 ½.

#### ***Forfeitures***

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$959 and \$3,733, respectively. The Plan provides that forfeitures of nonvested employer contributions, if any, shall be used to offset expenses and employer contributions as such obligations accrue. In 2024 and 2023, administrative expenses were reduced by \$5,873 and \$4,459 from forfeited nonvested accounts, respectively.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are presented at fair value as determined by the Custodian, based on the quoted market prices of the underlying securities within each fund at September 30, 2024 and 2023, respectively. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements. The Plan's Oversight Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

## South Texas Lighthouse for the Blind 403(b) Plan Notes to Financial Statements

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### *Administrative Expenses*

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Organization. During the years ended September 30, 2024 and 2023, expenses of \$4,599 and \$4,734, respectively, were paid by the Plan and allocated to participant accounts.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, June 11, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC and Ascensus Trust Company, the qualified institutions:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at September 30, 2024 and 2023;
- b) Investment income information included in the statement of changes in net assets available for benefits for the year ended September 30, 2024;
- c) All amounts included in Note 4, *Fair Value Measurements*
- d) All information included in the supplemental schedule of assets (held at end of year) as of September 30, 2024.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1* - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

### Note 4: FAIR VALUE MEASUREMENTS (Continued)

*Level 2* - Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Registered Investment Companies:* The fair values of registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the Securities and Exchange Commission (level 1 inputs). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5: TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated March 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are netted against net appreciation in value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**Note 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
