**Scope and Nature of the ERISA Section 103(a)(3)(c) Audit for the 2022 Financial Statements**

We have performed an audit of the accompanying financial statements of Navajo Preparatory Schools Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Navajo Preparatory Schools Inc. 401(k) Plan's (the Plan) 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion on the 2022 Financial Statements**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the predecessor auditor not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. Their report dated April 11, 2022, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and supplemental schedules, and (b) the form and content of the information included in the financial statements and supplemental schedules other than that derived from the certified information, were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

#### 1. Description of Plan

The following description of the Navajo Preparatory Schools Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General – The Plan is a defined contribution plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers employees of Navajo Preparatory Schools, Inc., referred to as the “Employer” The Plan was established and began operations in 2003.

Eligibility – Employees are eligible for participation in the Plan once they have reached three months of service and attainment of age 18 years. Eligible employees become participants of the Plan on the 1<sup>st</sup>, 4<sup>th</sup>, 7<sup>th</sup>, or 10<sup>th</sup> month of the plan year following satisfaction of the eligibility requirements.

Contributions – Under the Plan, the participant and the Employer are both allowed to make contributions. The participants are allowed to contribute a portion of their salary in pre-tax and Roth contributions to the Plan subject to those limitations provided for in Section 402(g) of the Internal Revenue Code.

The Employer makes safe harbor matching contributions equal to 100% of salary deferrals that do not exceed five percent of compensation. The Employer has the option to make discretionary matching contributions, profit sharing contributions, and qualified non-elective contributions.

During the years ended June 30, 2022 and 2021, the Employer made safe harbor matching contributions only.

Forfeitures – Forfeitures are the non-vested portion of the Employer matching contributions of a terminated participant's account balance. These may be used to reduce matching contributions or to pay administrative expenses of the Plan. The Plan has no forfeitures as all contributions are employer safe harbor contributions.

Participant Accounts – Each participant has one account that will consist of sub-accounts designated for participant contributions, Employer matching contributions, and rollover contributions. Participant contribution accounts are credited with the participant's contributions, the earnings of the specific investment vehicles selected, and forfeitures of terminated participant's nonvested accounts, as defined. Participants may self-direct their contributions to several investment vehicles, including mutual funds.

Employer matching and profit sharing contribution accounts are credited with the Employer's matching contribution and an allocation of the Employer's discretionary profit sharing contribution. Allocations are made in the same ratio as each participant's compensation bears to the total of such compensation of all participants. Participants may also self-direct the Employer account to several investment vehicles, including mutual funds.

Vesting – Participants are immediately vested in their voluntary contributions and Employer safe harbor matching contributions, plus actual earnings thereon.

If a participant dies or becomes disabled, the participant's accrued benefit derived from Employer contributions becomes 100% vested without regard to the above schedule. In the event of full or partial termination of the Plan, an affected participant's rights to the accrued benefit shall be 100% non-forfeitable.

Payment of Benefits – Upon normal retirement age or death, a participant or beneficiary may elect to receive either a lump-sum amount equal to the vested balance of the participant's account, or substantially equal installments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and spouse. Participants may receive distributions prior to separation of service after normal retirement age is reached.

Hardship distributions are allowed under the Plan. After a hardship withdrawal, the participant is not allowed to make contributions to the Plan for six months. Loans are not permitted under the Plan.

**2. Summary of Accounting Policies**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Benefits are recorded when paid.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

**3. Administration of Plan Assets**

The Plan assets are held by the Trustee of the Plan. Employer and participant contributions are invested by the Trustee as directed by the participants. The administrative expenses associated with the third-party administrator for the Plan are paid directly by the Employer. Other expenses associated with the Trustee of the Plan are paid by the participants. Certain fees are paid by the participants' investment funds to their affiliated investment advisors, transfer agents and recordkeeper as further described in each fund prospectus, plan service agreements, or other published documents. These fees were deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

**4. Information Prepared and Certified by Trustee**

The following information included in the accompanying financial statements and supplemental information was obtained from data that has been prepared and certified to as complete and accurate by the Lincoln National Life Insurance Company, the Trustee. The following table represents fair value of investments at June 30, 2022 and 2021.

**5. Fair Value Measurements**

Financial Accounting Standards Board (FASB), *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022 and 2021.

*Pooled Separate Accounts:* The Net Asset Value (NAV) of the pooled separate accounts is used as a practical method to determine fair value for these accounts. Each pooled separate account provides for redemptions by the Plan at reported NAV per share, with no advance notice requirement; therefore, these funds are classified within Level 2 of the valuation hierarchy. Investments in this category can be transferred once every 30 days at the current NAV per share based on the fair value of its underlying investments. Participants are not allowed to transfer back into this category until the 30-day period has expired. New contributions are allowed during this time period.

*Stable Value Fund:* The NAV of a stable value fund is provided by the Trustee and is used as a practical method to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This fund is classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Net Asset Value (NAV) Per Share**

Under the amended guidance of FASB ASU No. 2009-12, *Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)* (ASU 2009-12), entities are permitted, as a practical method, to estimate the fair value of investments within its scope using the NAV per share of the investment as of the reporting entity's measurement dates. The amended guidance also requires additional disclosures to better enable users of the financial statements to understand the nature and risks of the reporting entity's investments that fall under these rules.

In accordance with ASU No. 2009-12, the Plan expanded its disclosure to include the category, fair value, redemption frequency, and redemption notice period for those assets whose fair value is estimated using the net asset value per share or its equivalent for which the fair value is not readily determinable at June 30, 2022 and 2021. For the Plan, such assets include investments in pooled separate accounts.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**9. Tax Status**

The Plan is operating under a Volume Submitter Profit Sharing Plan with CODA filed by Dataair Employee Benefit Systems, Inc. The Plan administrator and Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan adopted the "uncertain tax positions" provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not, that its tax positions would be sustained upon examination by the Internal Revenue Service (IRS), or other State taxing authority. There were no penalties or interest recognized during the year ended June 30, 2022 and 2021. The Plan is no longer subject to U.S. federal income tax examinations by federal taxing authorities for years before 2018.

**10. Related Party Transactions**

Certain Plan investments are shares of mutual funds that are managed by Ascensus Trust Company. Ascensus Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. June 30, 2022 and 2021 fees that were paid by the Plan for the investment management services amounted to \$16,072 and \$15,356, respectively.

**11. Subsequent Events**

The Plan's management has evaluated subsequent events through May 2, 2025, the date which the financial statements were available for issue.

Subsequent to year end, the Plan changed recordkeepers and transferred its plan assets from Lincoln National Life Insurance Company to BOK Financial.
