## INDEPENDENT AUDITORS' REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Blount Fine Foods Corp. 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Blount Fine Foods Corp. 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

**1. Description of Plan**

The following description of Blount Fine Foods Corp. (the “Company”) 401(k) and Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all eligible employees of the Company who have completed one month of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company sponsors a profit sharing plan which was effective September 1, 1964. A 401(k) feature was effective September 18, 1995. The Board of Trustees is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

**Contributions**

Participants may contribute up to 75% of their pretax and/or post-tax annual compensation, up to the limits set by the Internal Revenue Code (“IRC”). The maximum will change each year indexed to inflation (the maximum was \$23,000 and \$22,500 in 2024 and 2023, respectively). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to the Internal Revenue Service (“IRS”) limit of \$7,500 for the years ended September 30, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic escalation provision whereby at the beginning of each Plan year, participant deferral percentages are increased by one percentage point until the participant reaches a deferral of ten percent. At that point, the automatic escalation is no longer applicable for that participant. The Company contributes 100% of each participant’s contribution up to 4% of eligible compensation. In addition to the 401(k) portion of the Plan, the Company may make discretionary profit sharing contributions as determined by the Board of Directors. There were no discretionary contributions for the Plan years ended September 30, 2024 and 2023.

**Participant accounts**

Each participant’s account is credited with the participant’s contributions, Company employer matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of Plan (continued)**

**Vesting**

Participants are immediately vested in their contributions as well as the employer matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contributions plus actual earnings thereon is based on the number of years of continuous service. A participant is 100% vested in the Company's profit sharing contributions after six years of credited service, upon reaching the age of sixty-three, or disability or death prior to termination of employment.

**Notes receivable from participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance not including their profit sharing contributions account balance. The maximum aggregate dollar amount of loans outstanding to any participant may not exceed \$50,000, reduced by the excess of the participant's highest outstanding participant loan balance during the 12-month period ending on the day before the new loan is made, over the outstanding balance of the participant's loans from the Plan on the day the loan is made. Loan transactions are treated as a transfer to (from) the investment fund, from (to) the Participant Notes fund. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. Participants may only have one loan outstanding at any given time. Participants have the option of refinancing in limited circumstances as noted in the Plan's Participant Loan Program. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan is made. Principal and interest is paid ratably through weekly payroll deductions.

**Payment of benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, receive substantially equal installment payments over a specified period of time, or defer payment until further notification if the account balance is in excess of \$5,000.

For termination of service for other reasons, the Plan reserves the right to distribute the vested interest in the participant's account as a lump sum distribution if less than \$5,000.

**Forfeited accounts**

For the Plan years ended September 30, 2024 and 2023, forfeited non-vested accounts totaled \$37,337 and \$11,176, respectively. These accounts may be used to reduce future employer contributions and administrative expenses. For the Plan years ended September 30, 2024 and 2023, \$350 and \$36,286, respectively, of forfeitures were used to offset Company contributions and \$13,703 and \$2,701, respectively, of forfeitures were used to pay administrative expenses.

**2. Summary of significant accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Estimates are principally used in the determination of the fair value of investments. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value, except for common collective trust assets, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and held during the year while net realized gains includes gains and losses on investments sold during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from their compensation.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, that participant loan balance is reduced, and a benefit payment is recorded.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Recordkeeping and custodian/trustee fees are paid quarterly. These fees are deducted on a pro-rata basis across all sources and all funds, except for the participant loan accounts, under the Plan from participants with account balances on both the last day of the quarter and the day the fee is assessed. Fees related to the administration of notes receivable from participants and distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events**

The Plan did not have any subsequent events, except as disclosed in Note 10, through May 7, 2025, the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended September 30, 2024.

**3. Information prepared and certified by the trustee**

Certain information presented in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, net realized gains, interest and dividends for the years ended September 30, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan). The contract value of the common collective trust fund at September 30, 2024 and 2023 was certified by Charles Schwab Trust Bank.

These schedules also included schedules of investment and inter-fund transfers.

**4. Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan investments. There have been no changes in the methodologies used at September 30, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust fund:** Valued at the NAV of units of a bank common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5 for more information.

**Money market fund:** Valued at amortized cost.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Investment contract with common collective trust**

The Plan invests in the Galliard Stable Return Fund C. This fund is a fully benefit-responsive investment contract through a common collective trust in the 401(k) and profit sharing portions of the Plan. An investment contract is a contract issued by a financial institution to provide a stated rate of return, without principal volatility, to the purchaser of the contract for a specified period of time. The contract value is based on the NAV of the fund, as reported by the investment manager. The common collective trust's contract value is a relevant measurement attribute since the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Therefore, this is the value included in Plan investments for the Plan years ending September 30, 2024 and 2023. One of the primary risks involved with investment contracts is credit risk of the contract issuer; there are no reserves against contract value for credit risk of the contract issuer or otherwise if termination of the contracts were to occur.

**6. Related party and party-in-interest transactions**

Certain Plan investments are shares of funds managed by Charles Schwab Trust Bank for the years ended September 30, 2024 and 2023, and their respective sub-custodians. Charles Schwab Trust Bank is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the balances in their accounts.

The Plan is administered by directed trustees appointed by the Board of Directors of the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all amounts allocated to their accounts.

**8. Tax status**

The Company has adopted a non-standardized pre-approved profit sharing plan and is relying on the non-standardized pre-approved profit sharing plan sponsor's favorable opinion letter from the IRS dated September 21, 2020. The letter states that the non-standardized pre-approved profit sharing plan and related trust are designed in accordance with applicable sections of the IRC. Although the non-standardized pre-approved profit sharing plan has been amended since receiving the opinion letter, the Plan's administrator and the Plan's tax counsel believe that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**8. Tax status (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. Subsequent event**

The Plan was amended effective January 1, 2025 to incorporate certain optional elections from the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0). These elections enhance the types of distributions allowed under the Plan, broaden the rules governing the maximum amount of loans which participants can take out and subsequent repayment, and allow for re-contribution into the Plan for certain hardship withdrawals.
