#### Note 1 - Description of the Plan

The following description of the Experience Learning Community 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility and other matters.

**General** - The Plan is a defined contribution plan that was established by Experience Learning Community (the Sponsor) for the benefit of eligible employees of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility** - Employees who are at least 18 years of age and who have completed three months of service, as defined by the plan provisions, are eligible to make salary deferral contributions to the Plan and receive the Sponsor matching contribution. Employees are admitted to the Plan beginning the first day of the month following attainment of eligibility requirements. Employees that are ineligible to participate in the Plan include union employees, nonresident aliens, and leased employees.

**Contributions** - Participants may elect to contribute up to 60% of their eligible compensation as pretax or Roth contributions. Participants over the age of 50 are eligible to make catch-up contributions and defer up to 100% of their eligible compensation. The Plan includes a provision whereby all newly eligible employees are automatically enrolled at 3% pre-tax deferral rate unless they elect a different deferral rate or not to participate in the Plan. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

The Sponsor may make discretionary matching contributions. For the year ended December 31, 2024, the Sponsor elected to match 50% of employees' deferrals up to 8% of eligible compensation. Catch-up contributions are not matched.

The Sponsor may also make discretionary nonelective contributions. There were no nonelective contributions made for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Sponsor's nonelective contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$25,616 and \$18,296, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses of the Plan. During 2024, employer contributions were reduced by \$26,720 from forfeited nonvested accounts.

**Payment of Benefits** - Upon termination of service, death, disability or retirement, a participant or beneficiary may elect to receive a lump-sum or installment distribution of the participant's vested interest in their account. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

**Notes Receivable From Participants** - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loans are secured by the balance in the participant's account. Interest rates are set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. The Plan's investments are subject to management fees based on a percentage of investment assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and not separately disclosed in the accompanying financial statements.

**Subsequent Events** - The Plan's management has evaluated subsequent events through May 14, 2025, the date on which the Plan's financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish the daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund - Valued using the NAV provided by the fund's trustee. The fund's trustee calculates NAV in a manner consistent with the measurement principles applicable to investment companies under GAAP. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily.

- (a) Participant Redemptions - The Fund is structured with the objective to provide participant liquidity without penalty on a daily basis. Redemption requests are generally accommodated at the Fund's NAV which is expected to be \$1.00. Transfers by participants to competing investment options are required to first be transferred to noncompeting investment options for a period of 90 days. A competing investment is generally considered to include any option that allows participants to access a similar investment profile. Plans may make withdrawals from the Fund upon 12 months' advance written notice to the Trustee (generally referred to as a 12-month put feature). In some cases, the 12-month put can be waived at the discretion of Goldman Sachs Trust Company.

#### Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

#### Note 6 - Tax Status

The Sponsor adopted an FMR, LLC pre-approved plan document. FMR, LLC received an approval letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity and its affiliates. Fidelity is the trustee of the Plan and Fidelity Workplace Services is the recordkeeper of the Plan. Therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to Fidelity and also issues loans to participants. These transactions are party-in-interest transactions.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
