*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Cherry Hill Company/LRC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cherry Hill Company/LRC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of the Cherry Hill Company/LRC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

**General.** The Plan, which became effective January 1, 2000 and was most recently restated March 1, 2022, is a defined contribution plan covering all employees of Cherry Hill Company (the Company) who have attained the age of 21 and have completed one year of eligible service with at least 1,000 service hours. Long-term part-time employees are eligible to participate in the Plan once they have completed three consecutive years of at least 500 hours of service. Entry is available on the first day of each quarter subsequent to the employee's completion of the participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Oversight Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Elective Contributions.** Each year eligible employees may make pre-tax salary reduction contributions to the Plan, not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 34 mutual funds under one pooled separate account and one guaranteed investment account as investment options for participants.

**Employer Contributions.** The Company may make discretionary matching and profit sharing contributions to the Plan. Discretionary matching contributions are determined on a per pay period basis. Any discretionary matching or profit sharing contributions made are made on behalf of all participants. For the year ended December 31, 2024, the Company elected to make a matching contribution equal to 50% of employee deferrals up to 8%. During the year ended December 31, 2024, the Company made discretionary matching contributions totaling \$254,215 to the Plan and did not elect to make discretionary profit sharing contributions.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service over a 6-year graded scale. A participant is 20% vested after two years of service, 40% after three years, 60% after four years, 80% after five years, and 100% vested after six years of credited service or upon death.

**Payment of Benefits.** On separation of service due to death, disability, retirement, or termination, a participant may elect to receive a cash distribution in the form of: (a) a lump sum, (b) substantially equal installments, or (c) partial withdrawals with no minimum required. Distributions may be made to a participant who has not separated from service upon reaching age 59½. Distributions may be made as soon as administratively feasible at the participant's election.

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN - CONTINUED**

Termination of employment prior to normal retirement requires distribution if the account balance does not exceed \$5,000. The participant can elect (a) direct rollover to an IRA or another qualified retirement plan or (b) payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If no election is made and that balance is less than \$5,000, the benefit will be rolled over to an IRA. If the account is greater than \$5,000 the participant may defer distribution until normal retirement age or further defer to age 73.

Hardship withdrawals are permitted for the purposes specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that are fully vested.

**Forfeited Accounts.** Forfeitures are first used to pay administrative expenses. Any remaining forfeitures are used to reduce the Company's discretionary contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,935 and \$3,860, respectively. In 2024, forfeitures were used to pay Plan expenses of \$2,800 and reduce the Company's discretionary contributions by \$3,000.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's oversight committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance companies.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

**Investment Valuation and Income Recognition. – Continued**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefits are recorded when paid.

**Expenses.** Expenses incurred for the administration of the Plan are the responsibility of the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The remaining expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**NOTE C - FAIR VALUE**

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled separate account:* The pooled separate account is valued using net asset value (NAV) as a practical expedient.

The underlying funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAVs are received daily from fund managers, and the managers stand ready to transact at these quoted amounts. The insurance company custodian transacts in these funds on a daily basis as part of the separate account trading activity.

Were the plan to initiate a full redemption of the trust, the insurance company custodian reserves the right to temporarily delay payment from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The calculation of the NAV for funds composed of other funds (e.g., retirement target date funds) is essentially the same as the calculation of the NAV for any other fund: the total market value of assets across all underlying funds less any liabilities is divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices. The Plan does not have any unfunded commitments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - INVESTMENT AT CONTRACT VALUE**

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria; therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

With traditional investment contracts, the Plan owns only the contract itself and not the underlying assets of the contract. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is the weighted average of all new and renewal rates of the contract for each calendar quarter. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participant.

Under no event may the issuer terminate this contract and settle at an amount different from contract value.

**NOTE E - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

All Plan investments are managed by Ameritas Life Insurance Corporation. Ameritas Life Insurance Corporation is the custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees for recordkeeping services paid to Ameritas Life Insurance Corporation were \$4,350 for the year ended December 31, 2024.

NOTES TO FINANCIAL STATEMENTS

**NOTE E - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS - CONTINUED**

Ameritas Life Insurance Corporation also receives fees for investment management services, which are included as a reduction of the return earned in each investment. Ameritas Life Insurance Corporation pays indirectly, through their investment fees earned, a commission to Antonio J. Ojeda, the Plan's Investment Advisor, and to Preferred Product Network, Inc., a broker dealer partner of Midlands Financial Benefits, for the sale of Ameritas Accumulation Group Annuity Contracts – Allocated (Guaranteed Investment Contracts). These commissions paid were \$3,033 and \$28,709 to Antonio J. Ojeda and to Preferred Product Network, Inc., respectively, for the year ended December 31, 2024.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE G - TAX STATUS**

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan of Ameritas Life Insurance Corporation, which received a determination letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's federal returns for 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
