INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Plan Trustees
M. Simon Zook 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of M. Simon Zook 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the qualified institutions as of October 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Notes to Financial Statements

October 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the M. Simon Zook 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of M. Simon Zook Company (Company) who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan entry dates are the first day of the quarter coinciding with or next following the date that the eligibility requirements have been satisfied.

Contributions

Participants may contribute up to 100% of their compensation, not to exceed the annual maximum deferral amount and annual additions amounts as set forth by the Internal Revenue Code (IRC). Participants may contribute pre-tax and after-tax amounts. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the calendar year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Effective January 1, 2023, the Plan was amended to include automatic escalation of employee deferrals from 2% to 8% into a default investment, unless they elect otherwise on the first day of each calendar year.

The Company may make discretionary matching contributions to be determined each year. A participant must complete one year of service before they are eligible to receive the discretionary matching contribution. For the period of November 1, 2022 to December 31, 2022, the matching contribution was 25% of the participant's salary deferral up to a maximum of 4% of the participant's eligible compensation. Effective January 1, 2023, the matching contribution is 25% of the participant's salary deferral up to a maximum of 5% of the participant's eligible compensation. Therefore, the employer matching contribution was \$95,702 and \$82,123 for the years ended October 31, 2024 and 2023, respectively.

Also, the Company may elect to make a discretionary profit-sharing contribution. An employee must be employed on the last day of the plan year and have worked 1,000 hours of service to be eligible to participate in the allocation of the profit-sharing contribution. The contribution is allocated based on an age-weighted method. There was no employer discretionary profit-sharing contribution for the years ended October 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the participant's share of (a) the employer's contribution, (b) an allocation of investment earnings or losses based on the participant's directed investment accounts and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Each participant directs the investment for their account.

Vesting and Forfeitures

A participant is 100% vested at all times in the participant's salary deferral amounts, rollover contributions, qualified non-elective contributions, and any earnings thereon, regardless of the number of years of service. If a participant ceases participation except by retirement, death or disability, the vested interest in employer contributions and earnings thereon is dependent upon the years of credited service.

Each participant is vested in the employer's match and profit-sharing contributions according to the following schedule based upon years of service.

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Any amounts forfeited may be used to pay administrative expenses or to reduce the employer's contributions. The forfeitures must be used in the plan year following the year in which the forfeitures occur.

At October 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,697 and \$904, respectively. For the years ended October 31, 2024 and 2023, forfeitures of \$4,255 and \$4,572 were used for administrative expenses, respectively.

Payment of Benefits

Upon termination of employment, a participant may elect to receive either a lump sum amount of the vested portion of the account balance or a direct rollover.

If the vested account balance is less than \$5,000, the vested account balance is paid out in the form of a lump sum distribution. Rollover portions of the account are excluded in determining the \$5,000 amount. In the event of a mandatory distribution greater than \$1,000, the Plan Administrator will pay the distribution in a direct rollover to an individual retirement arrangement designated by the Plan Administrator if the participant does not elect a direct rollover or lump sum distribution.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Payment of Benefits

Benefit payments to participants and beneficiaries are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are discussed in Note D. Purchases and sales are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities of the Plan are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in value of investment securities, it is at least reasonably possible that changes in risks in the near-term would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits. As of October 31, 2024, one investment fund represented 20% of total investments. As of October 31, 2023, two investment funds represented 33% of the total investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP), requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE C - INVESTMENTS

The Plan's investments were held in trust and administered by AdvisorTrust, the former trustee, for the period of November 1, 2022 through May 31, 2023. The Plan's investments are held in trust and administered by Charles Schwab Trust Company, the current trustee, for the period of June 1, 2023 through October 31, 2023 and as of and for the year ended October 31, 2024. The investments and investment income disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the former and current trustees.

NOTE D - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs for identical assets and have the lowest priority. The Plan uses valuation techniques based on the available inputs to measure the fair value of its investment. When available, the Plan measures fair value using Level 1 inputs because they provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 and Level 2 inputs are not available.

Gains and losses (realized and unrealized) are reported in net appreciation in fair value of investments in the statements of changes in net assets available for benefits.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes to the methodologies used on October 31, 2024 and 2023.

Money Market Account: Valued at cost, which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Should the Plan terminate at some future time, participants would become fully vested in their employer benefits.

NOTE F - PLAN TAX STATUS

The Plan had adopted the volume submitter profit sharing plan sponsored by Professional Capital Services, LLC. On January 1, 2021, the Plan was restated to the most recent volume submitter profit sharing plan sponsored by Professional Capital Services, LLC, which has received an advisory letter dated June 30, 2020. On June 1, 2023, the Plan was restated to the non-standardized defined contribution pre-approved plan sponsored by Sentinel Benefits Group, Inc., which has received an advisor letter dated November 30, 2020. No provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE G - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain plan investments were managed by AdvisorTrust, Inc. until May 31, 2023, and Charles Schwab Trust Company starting from June 1, 2023 (the former and current trustees of the Plan) and, therefore, these transactions qualify as party-in-interest transactions. Transactions resulting in plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption exists. AdvisorTrust, Inc. and Charles Schwab Trust Company are parties-in-interest as defined by ERISA as a result of investing plan assets in its funds and accounts and providing administrative services. However, these transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in administrative fees. Fees related to the administration of notes receivable from participants and investment related expenses are charged directly to the participant's account and are included in administrative expenses.

NOTE H - NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are reported at unpaid balances plus any unpaid accrued interest. Effective January 1, 2023, participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 and may only have one outstanding loan at any one time under the Plan's loan provision. The loans may not exceed one-half of the employee's vested account balance and are generally limited to five years. Interest rates are determined by the Plan Administrator in accordance with the Plan's loan provisions. Loan repayments are made through payroll deductions. There is no credit risk involved with these loans as any defaults are then deemed taxable distributions to the participant. Loans are considered in default when they are not paid within the terms stated on the agreement, typically within 90 days. No allowance for credit losses has been recorded as of October 31, 2024. These loans satisfy the statutory exemption from the prohibited transaction rules.

NOTE I - SUBSEQUENT EVENTS

Management has evaluated subsequent events through the date of the independent auditors' report, the date the financial statements were available to be issued.
