The purpose of this attachment is to explain why the above referenced return does not include the report of an independent qualified public accountant ("IQPA Audit") as is generally required under the relevant Department of Labor regulations. The reason no IQPA Audit is included with the filing is that this Plan qualifies for an exception from the requirement to file an IQPA Audit with the annual 5500 return under Field Assistance Bulletin (FAB) 2009-02 and Field Assistance Bulletin (FAB) 2010-01.

The plan in question has been frozen to all contributions since January 1, 2004. Further, the involvement of Candler Health System in connection with the Plan was and has continued to be minimal, involving only confirmation to the insurance company and custodian (Transamerica) when an employee terminates employment. Since the Plan was frozen, the employer has not been involved in processing payroll withholdings of deferrals or to repay plan loans and thus makes no contributions to the Plan of any kind, nor has it done so since 2003.

In accordance with the requirements under the FABs for an exemption from completion of an IQPA Audit, the annuity contracts and custodial accounts held through Transamerica relative to the Plan were issued long before January 1, 2009; the employer ceased having any obligation to make contributions and in fact ceased making contributions to the contracts as of 2004; all of the benefits under the contracts are enforceable by the individual employees and former employees with account balances held in this frozen Plan pursuant to individual certificates issued to those participants; and all participants are and have been for some time fully vested in their accounts under the Plan.

The Plan therefore qualifies for an exemption from the requirement to secure an IQPA Audit under Field Assistance Bulletin (FAB) 2009-02 and Field Assistance Bulletin 2010-01. Under these Field Assistance Bulletins, the plan administrator is not required to include in the Plan's annual report a contract or an account that meets the requirements of FAB 2009-02, even if that contract is known and can be identified (FAB 2010-01, Q3). However, as permitted by FAB 2010-01, Q4, Candler Health System has elected to report on the accounts to the extent it has the information. Nothing in either Field Assistance Bulletin suggests that doing so, however, would then require abandoning any of the relief that the two FABs allow. Accordingly, an IQPA Audit report is not required to be filed with respect to this Form 5500 return.
