### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of RTEC 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024, and for the year then ended, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

### Basis for Opinion on the 2024 Financial Statements

**RTEC 401(k) PLAN  
NOTES TO FINANCIAL STATEMENTS  
JUNE 30, 2024 AND 2023**

**(1) DESCRIPTION OF THE PLAN**

The following description of the RTEC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified, defined contribution plan covering all full-time employees of Rural Transit Enterprises Coordinated, Inc. (the “Company”) who have attained age 18 and have completed 1 month of service. Employees may enroll in the Plan upon attaining the service requirements.

The Plan is a prototype plan sponsored by Empower Retirement, LLC with the assets maintained by Empower Trust Company (“Empower”) as custodian. Broker’s commissions associated with investment transactions and investment management fees are paid by the Plan. The Plan is regularly updated to comply with tax legislation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Each year, participants are able to contribute a percentage of their pay to the Plan, up to the maximum allowable contribution, as defined in Federal legislation. This amount is then deposited in the participant’s account as a 401(k) contribution. Participants may rollover amounts from other eligible retirement plans to the Plan. The amounts transferred shall be allocated to the participant’s rollover contribution account. Such amounts and any earnings or losses shall be fully vested at all times.

Matching Contribution

Each plan year or, if the Company so chooses, at the same time tax-deferred contributions are contributed or any other time as permitted by law and regulation, the employer will make a regular matching contribution to the participant’s account of 100% of the participant’s 401(k) contribution up to 9% of the participant’s compensation. Compensation earned before first becoming eligible to participate is excluded in determining the amount of the match.

Participant Accounts

Each participant’s account is credited with (a) the participant’s contribution, (b) the Company’s contribution and (c) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

### Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options available to the Plan as advised by Empower. Participants may change their allocation percentages at any time.

### Payment of Benefits

Employees are eligible for retirement benefits upon reaching age 62 and are also eligible for benefits due to death or disability. Participants or their beneficiaries may elect a single lump sum payment of their entire vested account balance, or a portion of their vested account balance. Participants may make hardship withdrawals under prescribed circumstances, up to the value of their vested account balance. Withdrawals after the attainment of age 59 ½ can be made without penalty.

On termination of service before normal retirement age, participants will also receive their account balance in a lump-sum payment in cash. Participants whose account balance does not exceed \$1,000 will receive a distribution as soon as administratively feasible following termination of employment.

### Forfeited Accounts

Nonvested accounts of terminated employees are used to offset plan expenses or reduce the employer's contributions. Forfeited nonvested accounts totaled \$4,749 at June 30, 2024 and \$11,469 at June 30, 2023. During 2024, forfeitures of \$25,193 were utilized to reduce the employer's contributions.

### Revenue Sharing

The Plan has an account totaling \$0 and \$0 at June 30, 2024 and 2023, respectively, that includes excess revenue sharing funds received from certain investments. These amounts are held to pay for Plan expenses or allocated to plan participants, but cannot be used to reduce employer contributions. The Plan received excess revenue sharing funds totaling \$10,058 during the year ending June 30, 2024.

## **(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles and the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Reclassifications

Certain reclassifications have been made to June 30, 2023 information to conform to the 2024 presentation.

#### Subsequent Events

Subsequent events have been evaluated through June 12, 2025, which is the date the financial statements were available to be issued.

### **(3) INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

Empower Trust Company, LLC (the "Custodian") held the Plan's investment assets as of June 30, 2024 and 2023 and executed investment transactions during the year June 30, 2024. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's Custodian.

### **(4) FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

- Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) quoted prices for similar assets or liabilities in active markets, b) quoted prices for identical or similar assets or liabilities in inactive markets, c) inputs other than quoted prices that are observable for the asset or liability, d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Pooled separate accounts* - Valued at the account's net asset value (NAV), based on the net asset value of shares of the underlying fund, the fund's dividends and separate account charges. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments in pooled separate accounts are maintained by Talcott Resolution Life Insurance Company, who files a Form 5500 as a direct filing entity. As a result, the Plan has not disclosed the investments' significant investment strategies.

## (5) FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan maintains a traditional investment contract (“General Account”) with Talcott Resolution Life Insurance Company (“Talcott”). Contributions to the General Account are maintained as part of Talcott’s General Fund Account. The General Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The value of the General Account is reported in the accompanying financial statements at contract value, as reported to the Plan by Talcott. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan:

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The General Account held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is adjusted annually but may not be less than 3 percent.

Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. A withdrawal charge may apply to any type of distribution unless waived as follows:

- Withdrawals due to retirement, separation from service, loans, hardship, death, disability, minimum distribution
- Return of excess Plan contributions

The contract issuer or the plan sponsor may terminate the contract at any time with advance written notice to the other party. However, contract termination or Plan termination initiated by the Plan Sponsor may limit the ability of the Plan to transact at contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

## (6) RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

RTEC, the plan sponsor, provides to the Plan certain accounting and administrative services for which no fees are charged. Additionally, RTEC paid certain consulting and advisory fees on-behalf of the Plan.

As of June 30, 2024, Empower Retirement, LLC and its affiliate Empower Trust Company, LLC (“Empower”) are the Plan’s third party administrator and custodian, respectively. Therefore, transactions with Empower qualify as party-in-interest transactions. The Plan paid fees of \$263 to Empower during the year ending June 30, 2024.

Edward Jones provides investment advisory services to the Plan. Fees paid by the Plan to Edward Jones totaled \$13,369 for the year ended June 30, 2024.

**(7) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**(8) TAX STATUS**

The Plan is a prototype plan offered by Empower Retirement, LLC. Empower Retirement, LLC obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**(10) RISKS AND UNCERTAINTIES**

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
