## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of Round One Entertainment 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Round One Entertainment 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, for the year ended December 31, 2024, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## NOTES TO FINANCIAL STATEMENTS

### AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the Round One Entertainment 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

**General**—The Plan is a defined contribution plan covering all full-time employees with a minimum of three months of service and part-time employees who are credited with at least 500 hours of service during the year with Round One Entertainment, Inc. (the “Company” and “Plan Sponsor”). The Plan was amended, effective January 1, 2024, to clarify eligibility. The Plan Sponsor has established the Round One Entertainment 401(k) Plan Committee (the “Committee”) to control and manage the operations and administration of the Plan.

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the trustee (“Trustee”). The recordkeeper is Principal Life Insurance Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company; and (iii) participant rollovers from another qualified plan.

Participants may elect to contribute a percentage of their compensation (wages subject to income tax) to the Plan each year, subject to the limitations defined in the plan document. Such contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Participants, who have attained age 50 before the end of the plan year, are eligible to make catch-up contributions.

The Company makes a matching contribution to each participant’s account equal to 100% of a participant’s elective contribution not to exceed 3% of the participant’s compensation, plus 50% of each participant’s elective contribution between 3% and 5% of a participant’s compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution, related matching contributions, and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**—Participants may direct the investment of their contributions and the matching contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers mutual funds, pooled separate accounts and a guaranteed investment contract.

**Vesting**—Participants are always fully vested in their accounts at all times.

**Notes Receivable from Participants**—The Plan does not allow participant loans.

**Payment of Benefits**—On termination of service, due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a portion payable as a lump-sum withdrawal and the remaining balance as a direct rollover.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Plan Termination**—Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Participants are 100% vested in their accounts at all times.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**—The Plan's investments are stated at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 5). See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**—Employee contributions and employer matching contributions are recorded when withheld.

**Administrative Expenses**—Administrative expenses of the Plan are paid by either the Plan or the Plan Sponsor, as provided in the plan document. Plan participants pay administrative costs for distributions, special handling charges and qualified domestic relation orders.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024.

**Excess Contributions Payable**—The Plan is required to return contributions received during the Plan year in excess of the IRC limits. There were no amounts due to participants as of December 31, 2024 and 2023.

**Subsequent Events**—Subsequent events were evaluated through May 2, 2025, the date the financial statements were available to be issued.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule that were prepared by or derived from information prepared by Principal Trust Company, the trustee, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to

measure fair value as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

**Pooled Separate Accounts**—Pooled separate accounts are measured at Net Asset Value (NAV) per share. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held in the account, less its liabilities. Participant transactions (purchases and sales) may occur daily with no other restrictions, notice periods, and there are no unfunded commitments. In accordance with GAAP, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. The fair value of the pooled separate accounts as of December 31, 2024 and 2023, is \$89,104 and \$153,050, respectively.

**Collective Trust Funds**—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

**5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds a guaranteed investment contract (GIC) with the trustee. The GIC meets the criteria of a fully benefit-responsive investment, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Certain events limit the ability of the Plan to transact at contract value, such events include premature termination of the contract by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. The Plan does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable.

**6. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan’s recordkeeper and trustee, as well as the Company and Plan participants, are each a “party-in-interest” to the Plan as defined by ERISA.

Fees charged to the Plan for investment management services are reflected as a reduction of the return on each fund or included in administrative fees. The Plan also holds a FBRIC investment which is managed and sponsored by the recordkeeper to the Plan (see note 5). Each of these transactions qualifies as an exempt party-in-interest transaction under ERISA.

**7. FEDERAL INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by the BSG Benefits, Inc., third party administrator. BSG Benefits, Inc., received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.
