### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of W.W. Wood Products, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of W.W. Wood Products, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants and all others should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established on January 1, 1996. The Plan is available to all employees of W.W. Wood Products, Inc. (the Company) except those who are union employees, nonresident aliens, leased employees, or residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may make before-tax contributions from 1% to 100% of their annual compensation, as defined by the Plan Document, subject to certain limitations by the Internal Revenue Service (IRS). Participants age 50 or older may make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for the Company to make a discretionary matching contribution. The discretionary matching contributions for the years ended December 31, 2024 and 2023 was 50% of a participant's deferral percentage not to exceed 6% of a participant's eligible compensation.

The Plan also provides for a discretionary profit-sharing contribution to be determined annually by the Company. Each eligible participant employed by the Company for the entire Plan year will receive a portion of the discretionary profit-sharing contribution based on their eligible compensation. The Company did not make a discretionary profit-sharing contribution to the Plan during the years ended December 31, 2024 or 2023.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions and allocations of the Plan's earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes To Financial Statements (*Continued*)

#### **Vesting**

Participants are immediately vested in their elective deferral and rollover contributions plus actual earnings thereon. Participants become fully vested in the Company's contributions after three years of service, as defined by the Plan Document. Participant also become immediately vested upon death, reaching normal retirement age or total disability. Nonvested amounts are forfeited if an employee terminates prior to full vesting.

#### **Unallocated Accounts**

Unallocated accounts consist of a forfeitures account and an expense budget account.

The forfeiture account represents forfeited nonvested balances that are used to reduce future Company contributions or pay Plan expenses. There were \$16,310 and \$29,341 of forfeitures available to reduce future Company contributions or pay expenses as of December 31, 2024 and 2023, respectively. During 2024 and 2023, \$102,285 and \$70,989, respectively, in forfeitures were used to reduce Company contributions. During 2024 and 2023, \$9,566 and \$7,215, respectively, in forfeitures were used to pay Plan expenses.

The Plan also utilizes an expense budget account to pay Plan expenses. The account is maintained in a cash account with a balance totaling \$523 and \$1,077 as of December 31, 2024 and 2023, respectively. Plan expenses paid from this account totaled \$5,957 and \$3,772 for the years ended December 31, 2024 and 2023, respectively.

#### **Payments Of Benefits**

Upon termination of employment, death, disability or retirement, a participant may elect to receive a distribution of his or her vested account as a single lump payment or partial payments.

#### **In-Service Withdrawals**

Participants who reach age 62 may withdrawal all or part of their vested account balance. Hardship distributions are not permitted.

#### **Administrative Expenses**

Plan expenses not paid by the Company are deducted from Plan assets. Administrative expenses paid by the Plan include recordkeeper fees, service fees, professional fees, and transaction fees.

## **2. Summary Of Significant Accounting Policies**

### **Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation And Income Recognition**

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received in an asset sale or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive investment contracts are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Transamerica Stable Value Option is a fully benefit-responsive investment contract and is reported at contract value in the Statement Of Net Assets Available For Benefits.

### **Payment Of Benefits**

Benefits are recorded when paid.

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### 3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Transamerica Trust Company, Reliance Trust Company and Transamerica Life Insurance Company, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Transamerica Trust Company as of December 31, 2024 and for the period beginning June 29, 2024 through December 31, 2024, Reliance Trust Company as of December 31, 2023 and for the period January 1, 2023 through June 28, 2024 and Transamerica Life Insurance Company as of December 31, 2024 and 2023 and for the years then ended that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

#### **4. Fully Benefit-Responsive Investment Contracts**

The Plan offers as an investment option a stable value fund through Transamerica Life Insurance Company that is an investment in Transamerica Life Insurance Company's general account. As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported to the Plan by Transamerica Life Insurance Company, is the beginning balance plus any contributions and credited interest, less any withdrawals, charges or expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of Transamerica Life Insurance Company or otherwise. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and with no set maturity. The effective crediting interest rate is reset monthly and effective on the first day of the month. For the years ended December 31, 2024 and 2023, the average crediting interest rates were 1.58% and 1.18%, respectively.

Certain events limit the ability of the Plan to transact at contract value with Transamerica Life Insurance Company. Such events include the following: (1) the Plan is changed so as to significantly affect Transamerica obligations under the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract requirements, (5) failure to provide information, (6) the sum of the contract account values at any time equals \$20,000 or less, or (7) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator is not aware of any events, which would limit the Plan's ability to transact at contract value with participants that are probable of occurring.

#### **5. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

#### **Registered Investment Companies**

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Income Taxes

The Plan uses a non-standardized pre-approved plan document sponsored by Transamerica Retirement Solutions, LLC, who received an opinion letter from the IRS dated June 30, 2020, stating the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (the Code). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become 100% vested in their accounts.

#### 8. Party In Interest Transactions

The Plan invests in an investment contract managed by Transamerica Life Insurance Company. Transactions with this investment contract qualify as party in interest transactions allowable under ERISA.

#### 9. Risk And Uncertainties

The Plan provides for various investment options. Investments, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
