records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note A - Description of Plan

The following description of Impact Group, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The plan is a 401(k) defined contribution plan covering all employees of Impact Group, LLC (the Organization). It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Employees are eligible to participate in the Plan and receive matching contributions upon employment.

Contributions

Participants may elect to defer up to the maximum allowable under the Internal Revenue Code of eligible compensation and contribute these amounts to the Plan. In addition, participants over age 50 before the close of the Plan year are eligible to defer an additional catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. For each plan year, the Company will contribute to the Plan an amount of matching contributions determined by the Company at its discretion.

Plan Merger

On July 12, 2021, Impact Group, LLC was acquired by Acosta Inc. In connection with this transaction and through action by an officer of Impact Group, LLC, Acosta, Inc. merged the Impact Group, LLC 401(k) Plan into the Acosta, Inc. 401(k) Plan effective October 25, 2021. As a result, net assets available for benefits of \$48,298,493 were transferred out of the Plan on October 22, 2021. The transfer of all plan assets (including forfeited nonvested accounts), liabilities and benefits out of the Plan was completed on October 22, 2021. The merger does not impact participant benefits as the benefit provisions were incorporated into the Acosta, Inc, 401(k) Plan. Active participants’ accounts were transferred to the Acosta, Inc. 401(k) Plan and participants did not have an option to receive a distribution. As such, the assets, liabilities and benefits of the Impact Group, LLC Plan were not settled, but rather continue as part of the Acosta, Inc. 401(k) Plan.

Note A - Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earning thereon. The discretionary matching contribution is vested by each participant based on years of continuous service. A participant is 100% vested after three years of credited service. Credited service includes years of service at predecessor employers as named in the plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest. The loans are secured by the balance in the participant's account and bear interest at a rate between 4.25% and 6.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or installments over a period of time. Unless an optional form of benefit is selected pursuant to a qualified election within the election period, the automatic form of benefit payable to or on behalf of a participant shall be a single lump sum payment.

Forfeited Accounts

At December 31, 2021 and 2020, forfeited non-vested accounts totaled \$0 and \$119,786. These amounts will be used to reduce future employer contributions or Plan administrative expenses. During the year ended December 31, 2021 forfeitures of \$164,712 were used to offset employer contributions.

Administrative Expenses

Expenses of administering the Plan are the responsibility of the Plan's management these fees are all paid by the plan. Investment related expenses are deducted from the individual participant accounts.

Note B - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Note B - Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions are included in the dividend income. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 18, 2022 which is the date the financial statements were available to be issued.

Note C - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value instrument.

Note C - Fair Value Measurements (Continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's investments are held in mutual funds as of December 31, 2020. Mutual funds are valued as Level 1 inputs using unadjusted quoted prices for identical funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Great-West Trust Company, LLC, the Trustee of the Plan, has certified the completeness and accuracy of the investment balances presented on the schedule of assets available for benefits, the net investment gain on the statement of changes in assets available for. Additionally, the following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2020.

The Plan did not have any assets or liabilities measured on a recurring or nonrecurring basis as of December 31, 2021.

Note D - Related Party Transactions

The Plan invests in shares of mutual funds managed by an affiliate of Empower Retirement (Great-West Trust Company, LLC). They act as trustee for only those investments as defined in the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid by the Plan for investment management and plan administration services for the year ended December 31, 2021, amounted to \$111,855.

Note F - Income Tax Status

The Plan is intended to be a qualified plan under Section 401(a) of the Internal Revenue Code, and the Plan is interpreted, applied and administered consistent with the intent to qualify. The Plan was established through a prototype plan of Pinnacle Pension Services Inc., who had received a letter from the Internal Revenue Service indicating the Plan is acceptable. The Plan has been subsequently amended, however, the Plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (assets) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2021, there are no uncertain positions taken or expectation to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2018.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note H - Non Exempt Party-In-Interest Transactions

It was noted in 2020 there were delays by the Company in submitting employee contributions to the custodian in the aggregate amount of \$190,866. The Company filed Form 5330 with the IRS and paid the required excise tax on the transaction. In addition, participant accounts have been credited with the amount of investment income that would have been earned had the participant contribution been remitted on a timely basis.
