Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Tax Deferred Investment Program for Employees of Cotton Incorporated (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

1. Plan Description

The following description of the Tax Deferred Investment Program for Employees of Cotton Incorporated (the “Plan”) provides only general information about the Plan’s provisions. Cotton Incorporated (the “Company”) is the Plan Sponsor. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

Type of Plan

The Plan is a defined contribution plan available to all eligible employees of Cotton Incorporated. The Plan became effective January 1, 1984 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan is John Hancock Retirement Plan Services LLC (the “Trustee”). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Company Benefits Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility and Vesting

The Plan includes an auto enrollment provision whereby all eligible employees, as defined by the Plan Document, who are 21 years of age and who have completed 30 days of service are automatically enrolled into the Plan unless they affirmatively elect not to participate. Eligible employees enter the Plan on the first day of the calendar month following the date the eligibility requirements are met. Previous Plan participants who are rehired are immediately eligible to participate. Participants are immediately vested in both their own salary reduction and Employer safe harbor matching contributions to the Plan and earnings thereon.

Contributions

The Plan allows for eligible participants to contribute a percentage of their salary into the Plan. These contributions are described as “elective deferrals” and can be before or Roth after-tax to the participant. These salary reduction contributions may not exceed 75 percent or be less than 1 percent of an eligible participant’s compensation for the year.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5 percent of pre-tax eligible compensation.

The Plan includes an automatic escalation deferral provision whereby all participants are subject to the provision unless they affirmatively elect not to participate. Under this provision, elective deferrals will automatically increase by 1 percent each year until the participant’s deferral percentage reaches 15 percent.

The Company makes a safe harbor matching contribution equal to 100 percent of the participant salary deferrals that do not exceed 3 percent of eligible compensation plus 50 percent of salary deferrals between 3 percent and 5 percent of eligible compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer safe harbor matching contributions, and an allocation of Plan earnings and expenses thereon. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the participant's vested account balance. The Plan offers mutual funds, common collective trusts and a guaranteed interest account as investment options for participants. The Plan also allows participants to perform up to two in-plan Roth conversions during the Plan year.

Payment of Benefits

The Plan permits withdrawals in the event of termination of employment, the attainment of normal retirement age, the attainment of age 59½, financial hardship, disability or death. A participant may elect to receive a lump-sum amount equal to the value of their account less tax withholdings, have their balance rolled into another qualified retirement plan, elect for installment payments or take partial termination withdrawals. Participants whose accumulated plan benefit is less than \$7,000 may be rolled into an individual retirement account at the discretion of the Employer. Participants whose accumulated plan benefit is less than \$1,000 may have their balance paid to them directly. Participants may elect to have their withdrawals taken from their pre-tax and/or Roth after-tax balance.

Additionally, the Plan permits participants to withdraw all, or a portion of, their account balance directly attributed to rollover contributions made into the Plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the origination of notes receivable from participants, direct management of participant's account and qualified domestic relations orders (QDRO) are charged directly to the participant's account and are included in administrative expenses.

Notes Receivable from Participants

The Plan allows participants to borrow from their account balance. Participants are permitted to borrow up to 50 percent of their vested balance with a minimum value of \$1,000 and a maximum of \$50,000. The loans are secured by the balance in the participant's vested account and bear interest at prime plus 1 percent. Participants may only have a maximum of two loans outstanding at one time. Principal and interest are paid ratably through biweekly payroll deductions over a period of up to 5 years, or no more than 15 years if the loan was for the purchase of a personal residence.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance and interest accrued. Interest income is recorded on the accrual basis. Origination fees are recorded as administrative expenses and are expensed when they are incurred. Collectability is assessed annually by management and no allowance was warranted for the years ended December 31, 2024 and 2023. Defaulted notes receivable from participants are deemed distributed when the participant is not continuing payment under the loan and is recorded as benefits paid to participants in the statements of changes in net assets available for benefits. There were no such deemed distributions during the year ended December 31, 2024. During the year ended December 31, 2023, there were \$13,783 in deemed distributions.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value with the exception of fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company Benefits Committee determines the Plan’s valuation policies utilizing information provided by its investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

The Plan’s fully benefit-responsive investment contract (see Note 4) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Capital gains are recorded on the ex-date. Interest income is recorded on the accrual basis. Net appreciation in fair value of assets includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Fees paid by the Plan for investment management, including 12(b)1 fees and rebates as well as other fund management fees are included in net appreciation in fair value of assets on the statements of changes in net assets available for benefits.

Fair Value of Financial Instruments

The carrying value of the Company's financial instruments, including employer contribution receivable, at December 31, 2024 and 2023, approximate their fair values due to their short term nature.

ERISA Account

At December 31, 2024 and 2023, the Plan held unallocated assets that were invested in the guaranteed interest account totaling \$28,532 and \$17,989, respectively. This balance is used to pay investment manager fees due and then allocated to participant accounts on a pro-rata basis, if available.

3. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

A financial instrument's level within the fair value hierarchy is based on the lowest level input that is significant to the fair value measure in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

During the year ended December 31, 2024, the Plan changed its investment options, replacing certain mutual funds with common collective trusts. Although both investment types are valued using net asset value (“NAV”), the common collective trusts are valued using NAV as a practical expedient in accordance with ASC 820. The use of the practical expedient for common collective trusts is considered consistent with GAAP and does not materially affect the valuation of Plan investments. Prior period amounts have not been restated as the change in investment options and related valuation methodology occurred subsequent to the year ended December 31, 2023.

The following is a description of the valuation methodologies used for instruments measured at fair value:

Mutual Funds

Mutual funds represent investments with various investment managers. The fair value of these investments are determined by reference to the mutual fund’s underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at NAV as of December 31, 2024 and 2023 and are included in level 1 of the hierarchy.

Common Collective Trusts

Common collective trusts are measured at NAV. NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no common collective trusts held as of December 31, 2023.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The objective of Plan investments in common collective trusts that are measured at NAV is to offer participants investment alternatives with lower investment management and administrative fees compared to similar mutual fund options. The common collective trusts are managed by the same investment managers as the corresponding mutual funds and are designed to mirror the investment objectives, strategies and underlying holdings of those funds. These investments are valued on a daily basis and are fully redeemable on a daily basis with a redemption notice period of 1 day.

4. Fully Benefit-Responsive Investment Contracts

In July 2010, the Plan entered into a fully benefit-responsive investment contract with New York Life Insurance Company (“New York Life”). New York Life maintains the contributions in a general account. New York Life is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a continuous basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Only upon certain events, such as a Plan termination, merger or spin-off, are the participants limited in their ability to transact at contract value and a market value adjustment is made. These events are determined by the Employer. No such events have occurred or are probable as of December 31, 2024 and 2023. New York Life cannot terminate the investment contract and settle participant balances for a balance other than contract value.

Participant-initiated transactions are permitted on a daily basis. Transfers to competing funds must first go through a non-competing investment option for at least 90 days.

5. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of assets, capital gains, interest and dividends and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Retirement Plan Services LLC, a qualified institution.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contribution.

7. Income Tax Status

The Plan has adopted the Non-Standardized Defined Contribution Pre-Approved Plan for John Hancock Retirement Plan Services LLC and is relying on the prototype's opinion letter dated June 30, 2020. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Party-in-Interest and Related Party Transactions

Certain Plan administrative expenses and certain Plan investments are managed by the Trustee, therefore, these transactions qualify as party-in-interest transactions. The Plan also made payments to its investment advisor, MMA Securities LLC, who serves in a co-fiduciary role; these transactions are considered as exempt party-in-interest. Notes receivable from participants also qualify as party-in-interest transactions.
