The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of the Plan

The following description of the HTC America, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreement for more complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

General - The Plan is a defined contribution plan established January 1, 2008, by HTC America, Inc. (Plan Sponsor), for the benefit of its employees and the employees of participating affiliates HTC America Innovation, Inc., and HTC America Content Services Inc. (collectively, the Company).

The Plan excludes leased employees, employees covered by a collective bargaining agreement, temporary employees, independent contractors, and nonresident aliens who receive no earned income. Employees who are at least 18 years of age and who do not meet any of the aforementioned classes of individuals excluded from the Plan are eligible to participate in the Plan. Employees can enter the Plan beginning the second pay period following attainment of the eligibility requirement.

Contributions - Participants may contribute to the Plan through voluntary deferrals of earned compensation. Eligible employees may contribute from 1% to 100% of their compensation to the Plan, not to exceed annual limitations prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company will match an amount equal to 100% of the first 4% of participant compensation contributed to the Plan. Participants may also rollover amounts representing distributions from other qualified plans.

The Plan allows participants to make Roth contributions. Such contributions are subject to existing annual contribution limits prescribed under IRC 402(g). All Roth contributions and earnings are separately identified in the participant account balance records to facilitate compliance with the regulations prescribed for the tax treatment of distributions.

The Plan also has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are fully vested at all times in their contributions as well as all employer contributions and earnings thereon.

Payment of Benefits - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive a distribution of their vested account balance. Participants who have attained age 59½ can receive distributions while still employed by the Company. The Plan also provides for hardship withdrawals in accordance with provisions specified in the plan document. Distributions may only be in the form of a lump-sum payment.

Note 1 - Continued

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts using their vested balance as collateral for the loans. The maximum amount that a participant may borrow is equal to the lesser of 50% of their entire vested account balance or \$50,000. The minimum amount required to be borrowed is \$500. Loan terms range from one to five years unless it is used to acquire a principal residence. The loans bear interest at the prime rate plus 1% at the effective date of the loan. Principal and interest are paid ratably through payroll deductions.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure on contingent assets and liabilities at the date of financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Revenue Sharing Recapture Account - The Plan holds certain assets in an unallocated account which is primarily used to recapture a portion of the expense ratios charged by the Plan's mutual funds (revenue sharing payments). Revenue sharing payments can only be used to pay eligible administrative expenses of the Plan. During 2024, the Plan used \$27,518 in revenue sharing dollars to pay a portion of the Plan's administrative expenses. There were \$23,578 and \$1,235 of unallocated assets in the account at December 31, 2024 and 2023, respectively.

Investment Management and Administrative Expenses - Asset custodian, recordkeeping, and audit fees are paid for using the Plan's revenue sharing recapture account. Administrative costs for investment, consulting, and legal services are paid by the Plan and the Company. Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Transaction based fees for loans and distributions are charged directly to participant accounts. The Company may elect to pay other expenses related to the Plan's administration.

Subsequent Events - The Plan's management has evaluated subsequent events through June 10, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides a consistent framework for determining fair value measures for financial assets and liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3 - Continued

Collective Trust Fund - Valued using the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding at the valuation date. Participant transactions (purchases and sales) may occur daily. The fund may impose plan level redemption restrictions.

Note 4 - Collective Trust Fund

The collective trust fund invests in a group annuity contract ("GAC") which includes underlying assets that are held in a trust owned by MetLife. The contract provides that participants execute Plan transactions at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. The investment is stated at fair value as reported by MetLife. The GAC's fair value equals the fluctuating value of the separate account of the assets backing the contract. The Plan's fair value of the investment equals the Plan's guaranteed value times the ratio of the GAC's guaranteed value to the GAC's fair value.

Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other Plan investment options, and payments because of retirement, termination of employment, disability, death, and in-service withdrawals as permitted by the Plan. Certain events, such as Plan termination or a Plan merger initiated by the Plan sponsor, may limit the ability of the Plan to transact at contract value. The Plan sponsor does not believe any events that may limit the ability of the Plan to transact at contract value are probable.

Note 5 - Information Certified by the Trustee

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (Matrix), a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Company adopted a CCH Incorporated pre-approved plan document. CCH Incorporated received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan’s management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-in-Interest Transactions

Northwest Plan Services (NPS) provides recordkeeping services for the Plan. As such, fees paid by the Plan to NPS qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. The Plan also issues loans to participants; these transactions are party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Delinquent Contributions

Defined contribution plans are required to remit employee contributions (and loan repayments) to the Plan as soon as they can be reasonably segregated from the employer’s general assets. While the Company remitted all employee contributions to the Plan, the Company also determined that there were instances during the year ended December 31, 2024, in which participant contributions were not deposited by the Company as Plan assets within the time limitation stipulated under the Department of Labor’s regulations. The Company restored lost earnings associated with the delinquent contributions during 2024.
