Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SilverBow Resources, Inc. 1. Description of Plan

The following description of the SilverBow Resources, Inc. Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions, a copy of which is available from SilverBow Resources, Inc. (the “Company”).

General

The Plan, which became effective January 1, 1987, is a profit sharing plan as defined by Section 401(a) of the Internal Revenue Code (IRC) and contains a provision for salary reduction contributions under Section 401(k) of the IRC. The Plan allows Roth elective deferrals from participants that are recorded, separately, to a Roth account in the participant’s account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by an administrative committee that is appointed by the Company’s board of directors. The trustee for the Plan is Charles Schwab Trust Bank.

Plan Merger

The Company merged with Crescent Energy Company effective July 30, 2024. In December 2024, the Plan merged with and into the Crescent Energy Management LLC 401(k) Plan. Total net plan assets of \$17,430,470 were transferred to the trustee of the Crescent Energy Management LLC 401(k) Plan in December 2024.

Eligibility

Employees of the Company, except those employees covered by a collective bargaining agreement or those who are nonresident aliens with no U.S. income, are eligible to participate in the Plan upon the later of their employment date or attainment of age 21.

Contributions

Participants may elect to contribute up to the maximum percentage allowable by the IRC. Participants age 50 or over in the plan year may also make catch-up contributions into the Plan. The Plan also allows rollover contributions. Participants direct the investment of their contributions in the various investment options offered by the Plan. Participants may change their contribution rates and investment options at any time.

Pursuant to the Plan agreement, the Company may make a discretionary matching and/or profit sharing contribution. Participants must be employed on the last day of the plan year to receive a profit sharing contribution. During 2024, the Company elected to match 100% of each participant’s contributions up to 7% of eligible compensation on a pay period basis. An additional annual matching contribution was made for 2024 based on this formula, taking into account annual eligible compensation and deferrals less amounts previously contributed on a pay period basis. There was no profit sharing contribution for 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting and Forfeited Accounts

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 100% vested after one year of credited service. Effective January 1, 2024, certain participants affected by previous partial plan terminations became fully vested. In addition, all active participants at January 1, 2024 with matching contribution accounts became 100% vested.

Forfeitures result from the termination of a Plan participant. Forfeitures of non-vested employer contributions may be used to pay Plan expenses, reduce the employer matching contributions, add to employer contributions, or reallocate among participant accounts. At December 31, 2023, total forfeitures were \$166. In 2024, forfeitures of \$166 were used to offset employer matching contributions. No forfeitures were reallocated among participant accounts.

Benefit Payments

A participant shall become immediately vested upon retirement, disability, or death. Normal retirement age under the Plan is 65. Upon retirement, disability, death, or termination of employment, participants are eligible for a benefit payment. The Plan also allows in-service withdrawals upon the attainment of age 59 ½ and hardship withdrawals. Benefit payments are distributed in a lump-sum amount.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range from 1 to 5 years, or up to 30 years for the purchase of a primary residence. The notes are secured by the participant's vested account balance and bear interest at the prime rate plus 2% determined at the date of borrowing. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect amounts reported in the financial statements and, accompanying notes. Actual results could differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain administrative expenses are paid directly by the Company and are excluded from these financial statements. Fees related to investment advisors, trustees, and record keepers are charged to the Plan and allocated to participants. Certain investment transaction fees are charged directly to the participants' accounts and are included in net appreciation in fair value of investments.

Benefit Payments

Benefit payments are recorded when distributed.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan provides for various investments in mutual funds, common/collective trust funds, and a self-directed brokerage account. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

3. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, clarifies the definition of fair value for financial reporting, establishes a framework for measuring fair value, and requires additional disclosure about the use of fair value measurements in an effort to make the measurement of fair value more consistent and comparable.

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. In addition, ASC 820 establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. The asset or liability's fair value measurement level within the

fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category, and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Account: Composed of a short-term money market investment valued at deposits received plus interest.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following investments valued at NAV per share (or its equivalent) practical expedient are excluded from presentation in the fair value hierarchy described above.

Common/Collective Trust Funds: Valued at NAV, based on the market value of the underlying investments held by the funds less liabilities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The funds allow for daily liquidity with no additional days' notice required for redemption for participant-directed transactions. Were the Plan to initiate a full redemption of the funds, the trustee reserves the right to temporarily delay withdrawal from the funds in order to ensure that securities liquidations will be carried out in an orderly manner. The Plan has no unfunded commitments or further obligations to invest in the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodology used for valuing securities are not an indication of the risk associated with investing in those securities.

As described in Note 1, all of the Plan's investments were transferred to the Crescent Energy Management LLC 401(k) Plan in December 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023:

4. Information Certified

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

5. Income Tax Status

The Plan has adopted a volume submitter prototype plan, which obtained its latest opinion letter dated September 21, 2020 in which the Internal Revenue Service (IRS) stated that the prototype document satisfies the applicable provisions of the IRC. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party in Interest

Certain Plan investments are in cash accounts held by entities related to Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Plan's trustee, as defined by the Plan. Therefore, these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

7. Subsequent Events

Management has evaluated subsequent events through June 18, 2025, the date the financial statements were available to be issued.
