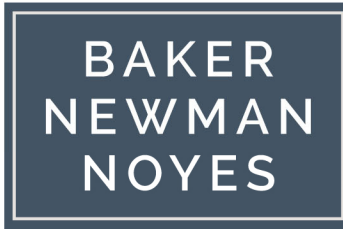

1. Description of Plan

The following description of National Distributors, Inc. Profit Sharing and Employees Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a pre-approved defined contribution plan covering eligible employees of National Distributors, Inc. (the Company). Full-time employees who have 3 months of service and are 21 years of age are eligible to participate in the Plan and certain part-time seasonal or temporary employees who have completed at least 1,000 hours of service, in addition to completing 3 months of service and attaining age 21, are also eligible.

The *SECURE ACT 2.0* expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed at least 500 hours of service in the three most recent consecutive years (2021 – 2023) are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to the two most recent consecutive years (2023 – 2024).

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Eligible participants can also make Roth deferral contributions, which are contributions based on after-tax compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Safe harbor match contributions are 100% of the amount of a participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the amount of a participant's elective deferrals in excess of 3%, but not more than 5% of the participant's compensation. The Company also may make a profit-sharing contribution at management's discretion. There were no profit-sharing contributions for the years ended December 31, 2024 or 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Employees are automatically enrolled in the Plan once the Plan's eligibility requirements are met. Participants are initially enrolled at 5% of their eligible compensation and may execute a salary deferral agreement at any time to select an alternative deferral amount or elect not to defer under the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's profit-sharing contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, Company matching contributions and rollover accounts. Vesting in the Company profit-sharing contribution portion of their accounts is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. A participant is 100% vested after 6 years of service.

Forfeitures

Forfeited nonvested accounts may be used to pay administrative expenses under the Plan at any time. Any forfeitures not used to pay administrative expenses under the Plan shall be applied to reduce employer contributions for the immediately following Plan Year. Forfeitures used to reduce employer contributions and to pay administrative expenses were not material for the years ending December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited nonvested accounts included in net assets available for benefits were not material.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the time the loan is established. Participants may only have one loan outstanding at any given time. No loan shall be for a term exceeding five years unless the proceeds are used to acquire a primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan provides benefits to participants upon death, disability, retirement or termination of employment. Participants may elect to receive a lump-sum payment, partial withdrawal, or payments under a systematic withdrawal plan (installments), up to the value of the participant's vested interest in their account. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, to the extent they are not paid by the Company. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

Basis of Accounting

The accrual basis of accounting is utilized for reporting purposes.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP), requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from participants are recorded in the year in which payroll deductions are made. Employer matching contributions are recorded in the same year as the corresponding participant contributions.

Notes Receivable From Participants

Notes receivable are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and becomes eligible for a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options which invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through June 16, 2025, which is the date the financial statements were available to be issued.

3. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The Plan has adopted a pre-approved defined contribution plan sponsored by Fidelity Management & Research Company. The pre-approved plan provider has received an opinion letter from the IRS, dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Information Certified and Provided by the Trustee

The Plan's assets, including investments and notes receivable from participants, related investment income, and investment and notes receivable transactions, including net appreciation in fair value of investments and interest income on notes receivable from participants, were certified by Fidelity Management Trust Company (Fidelity), the trustee, as of and for the years ended December 31, 2024 and 2023. The Plan Administrator has determined that Fidelity meets the requirements of a qualified institution as defined by the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan Administrator and as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to generally accepted auditing procedures by the Plan's independent public accountants.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, has established a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs that are unobservable inputs for the asset.

The money market fund and mutual funds are valued at the closing price reported in the active market in which the security is traded. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.
