### Opinion

We have audited the financial statements of **WEHCO Media Group Insurance Plan (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the benefit obligations and net assets available for benefits of the Plan as of August 31, 2024 and 2023, and the changes in its benefit obligations and net assets available for benefits for the year ended August 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

## **NOTE 1: DESCRIPTION OF PLAN**

The following brief description of the WEHCO Media Group Insurance Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

### **General**

The Plan is a defined benefit health and welfare plan covering substantially all full-time employees of WEHCO Media, Inc. and affiliated companies (the Employer, Plan Sponsor and Plan Administrator) who have met eligibility requirements as defined in the Plan. The Plan was approved and adopted by the Plan Sponsor effective September 1, 2001, and amended and restated effective September 1, 2015. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees of the Plan are the Employer's Board of Directors.

As permitted by the Plan agreement, the Plan Administrator has executed a contract with a third-party administrator to provide certain administrative services, including underwriting enrollment applications, maintaining current Plan data, billing, processing claims for payment, filing reinsurance reimbursement claims and providing the Plan Sponsor with any other information deemed necessary. BlueAdvantage Administrators served as the third-party administrator to the Plan during 2024 and 2023. Although health claims are processed by the third-party administrator, the responsibility for payment of claims is retained by the Plan Sponsor.

### **Benefits**

The Plan provides health benefits, including hospital, surgical, major medical, prescription drug benefits and life insurance benefits to full-time employees of the Plan Sponsor and their covered dependents once they have met eligibility requirements as defined in the Plan agreement.

Terminated employees may elect to continue coverage under the Plan, as provided in the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) and its amendments.

The Plan is responsible for all medical and prescription drug claims up to \$175,000 for each eligible participant, subject to a maximum specific reimbursement of \$1,000,000 for each covered person. For the year ended August 31, 2024, medical and prescription drug benefits provided under the Plan were partially insured through Berkley Life and Health Insurance Company, as specified in the related stop-loss policy. Life insurance benefits provided under the Plan are fully insured through Cigna.

### **Contributions**

The cost of funding the Plan is shared between the Plan Sponsor and participants. The Plan Sponsor determines employer and employee contribution rates based on insurance premiums, administrative fees, and anticipated cost of claims.

## **NOTE 1: DESCRIPTION OF PLAN (Continued)**

### **Plan Expenses**

All significant administrative expenses are paid from Plan assets. Accounting personnel of the Plan Sponsor incur time in administering the Plan, the value of which is not reflected in these statements since it is not susceptible to objective measurement.

### **Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify benefits provided under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

In the event of termination of the Plan, assets held in the Trust established under the Plan must be used to satisfy liabilities of the Plan, which may include payment of claims, insurance premiums and administrative expenses. Any remaining assets must be used to provide benefits to participants and may not revert to the Plan Sponsor.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

### **Investment Valuation and Income Recognition**

The Plan's investment in the money market mutual fund is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Interest income is recorded on the accrual basis.

### **Benefit Obligations**

The Plan's benefit obligations include an estimate of claims payable, and claims incurred prior to year-end, but not reported as of year-end as well as post-employment benefits for terminated employees electing coverage under COBRA. Management's estimate of claims payable, claims incurred but not reported and post-employment benefits are based on prior claims experience and other factors, as provided by the third-party administrator.

The Plan provides that, to be considered for payment, claims must be incurred within the Plan year and reported not later than twelve months after year end.

### **Payment of Benefits**

Claim payments are recorded when submitted to the Plan by the claim's processor for reimbursement. Claims paid by the claims processor prior to year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable (a benefit obligation) in the accompanying statements of benefit obligations and net assets available for benefits.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

### **Stop Loss**

Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in benefit obligations and net assets available for benefits. Stop loss refunds totaling approximately \$157,000 have been netted with medical claims in the accompanying statement of changes in benefit obligations and net assets available for benefits for the year ended August 31, 2024.

### **Refunds**

Refunds and pharmacy rebates due are recorded when earned. Refunds and pharmacy rebates due as of the financial statement date are reported as a receivable, with the offset being netted against medical claims. Refunds and pharmacy rebates due to the Plan as of August 31, 2024 and 2023 totaled approximately \$225,000 and \$119,000, respectively. Refunds and pharmacy rebates totaling approximately \$579,000 have been netted against medical claims in the accompanying statement of changes in benefit obligations and net assets available for benefits for the year ended August 31, 2024.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Plan obligations for claims payable, claims incurred but not reported and post-employment benefits are significant estimates that are based on certain assumptions pertaining to prior claims experience and other factors, all of which are subject to change. Due to uncertainties inherent in estimating these balances, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

## **NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2      Inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets

- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023:

Mutual fund

Valued at the daily closing price as reported by the fund. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

**NOTE 4: TAX STATUS**

The Trust established under the Plan to hold the Plan’s assets has not received an exemption letter from the Internal Revenue Service stating that the Trust is tax exempt under Section 501(c)(9) of the Internal Revenue Code (IRC) as a Voluntary Employee Beneficiary Association, and is, therefore, a taxable trust.

As an employee welfare benefit plan, the Plan and Trust are required to operate in conformity with the IRC and ERISA. The Plan Administrator believes the Plan and Trust are operating in conformity with the IRC and ERISA.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of August 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability (or asset) or disclosure in the financial statements. The Plan may be subject to audit by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

## ***NOTE 6: RELATED PARTY AND PARTY IN INTEREST TRANSACTION***

The Plan's stop loss policy is issued through a member-owned group captive in which the Plan Sponsor owns less than 10% of the voting stock. For the years ending August 31, 2024 and 2023, the Plan had a security deposit with the group captive totaling approximately \$297,000 and \$358,000, respectively. Additionally, the Plan had a receivable from the group captive totaling approximately \$62,000 due to a reduction in the Plan's required deposit with the captive group which is reported as "Other receivable" on the statement of net assets available for benefits as of August 31, 2024.

## ***NOTE 7: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through June 16, 2025, the date the financial statements were available to be issued.

Subsequent to the year end, the Plan Sponsor transitioned from BlueAdvantage to Cigna Health and Life Insurance Company. This change was made to enhance the benefits offered to plan participants and to achieve cost efficiencies. The new insurance provider will be responsible for administering the Plan's benefits effective September 1, 2024.
