We have performed audits of the financial statements of Lac du Flambeau Band of Lake Superior Chippewa Indians Enterprise 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Note 1: Description of Plan

The following description of the Lac du Flambeau Band of Lake Superior Chippewa Indians Enterprise 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the commercial employees of Lac du Flambeau Band of Lake Superior Chippewa Indians (the "Tribe") who have six months of service and are age 21 or older. The Plan is maintained in reasonable and good faith operational compliance with the Employee Retirement Income Security Act of 1974 (ERISA), as required by Section 906 of the Pension Protection Act (PPA) and the Tribal transition relief announced by the Internal Revenue Service (IRS) in Notice 2006-89 and Notice 2007-67.

Contributions

Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the maximum amount allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated default investment fund until changed by the participant.

The Tribe contributes an enhanced safe harbor match equal to 100% of the first 5% of each participant's compensation contributed to the Plan. The Tribe may also make a discretionary profit sharing contribution as declared by the Tribal Council and a discretionary matching contribution based on a uniform percentage at a rate as declared by the Tribal Council. Contributions are subject to certain IRS limitations. There were no discretionary profit sharing or discretionary matching contributions for the years ended September 30, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Tribe's safe harbor matching contribution, and allocations of (a) the Tribe's discretionary contributions and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings (losses) thereon, regardless of a participant's years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount, partial lump sum amount, or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

In-service distributions are also allowed for a qualified birth or adoption (QBAD) in an amount not to exceed \$5,000 for each eligible child or adoptee. Any participant who receives a QBAD may make rollover contributions to the Plan within three years after the QBAD in an aggregate amount that does not exceed the amount of the QBAD for the purpose of restoring the participant's account balance and seeking a refund of income taxes paid by the participant in connection with the QBAD.

Forfeitures

All participant accounts are fully vested and nonforfeitable. Forfeitures arise as a result of adjustments made to safe harbor matching contribution allocations. These forfeitures shall be used to reduce the amount of Tribe contributions in accordance with the plan document. At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$19, respectively. Forfeitures in the amount of \$20 were used to reduce Employer contributions for the year ended September 30, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Tribe. Expenses that are paid by the Tribe are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account. Investment advisory expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through June 11, 2025, which is the date the financial statements were available to be issued.

Effective October 1, 2024, the Plan was restated for the following changes:

- Removal of auto enrollment
- Eligibility after 90 days of service and enrollment allowed at the beginning of each pay period
- Increased the dollar limit on mandatory distributions for terminated participants from \$5,000 to \$7,000
- Limit the spousal consent requirements for withdrawals and distributions that equal or exceed \$7,000

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 3: Fair Value Measurements (Continued)

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Key Guaranteed Portfolio Fund: Valued by using a discounted cash flow valuation methodology where the interest rate for the portfolio investment contract is reset at least as frequently as annually.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of September 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and its affiliate, Empower Annuity Insurance Company of America, collectively the Trustee of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Tribe has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the terms of the Plan and the Tribe's reasonable and good faith operational compliance with ERISA.

Note 6: Tax Status

The IRS has determined and informed the Tribe by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Tribe's benefits counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.
