Report of Independent Auditors

To the Administration Committee of Texas Instruments Incorporated

Opinion

We have audited the financial statements of Texas Instruments Incorporated Welfare Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Texas Instruments Incorporated Welfare Benefits Plan (the Plan) provides only general information as to the various benefits provided by the Plan. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan provides certain health and welfare benefits to eligible employees of Texas Instruments Incorporated and participating subsidiaries (the Company) and their dependents.

Northern Trust Company (the Trustee) is the trustee of the Plan's trusts (collectively, the Trusts) and provides trust services to the Plan. Investments are held by the Trustee. The Plan is administered by the Administration Committee of the Company. The Retirement Investment Committee (RIC) of the Company is responsible for the Plan's investments.

It is the intent of the Company that the Plan shall meet the requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA), but only as those provisions apply to welfare plans.

Eligibility

Full-time employees and part-time employees who work a minimum of 20 hours per week become eligible to participate in the Plan upon hire. Eligible dependents can be covered on the employee's first day of hire.

Benefits

The Plan provides medical (including prescription drug), dental, vision, short- and long-term disability, life insurance, employee assistance, group accidental death and dismemberment, dependent care reimbursement, health care reimbursement, business travel accidental death and dismemberment, and survivor benefits. The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Notes to Financial Statement (continued)

1. Description of the Plan (continued)

Contributions

Participant contributions are received in the form of payroll deductions or premiums submitted directly to the Company or Fidelity Workplace Services LLC, the Plan's recordkeeper. The amounts contributed are based on the coverage options selected under the Plan. Company contributions are made to the Plan to fund the difference between the participant contributions and the actual benefits and administrative expenses paid. Such contributions and related income, if any, are used for the exclusive benefit of participants, as well as the payment of any administrative expenses incurred by the Plan. The excess of benefit obligations over net assets will be funded by Company contributions.

Reimbursement Accounts

The health care reimbursement and dependent care reimbursement benefits allow eligible participants of the Plan to reduce federal income taxes by paying certain health care and dependent care expenses on a pretax basis.

Participant contributions are received in the form of payroll deductions. All contributions are promptly deposited in the Plan's Trusts and are used to reimburse participants for eligible expenses. Forfeited amounts are used to pay administrative expenses or for any other purpose that the Company may elect, subject to applicable law.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting under US Generally Accepted Accounting Principles (US GAAP). Claims paid are recorded upon distribution.

Subsequent Events

Management evaluated subsequent events for the Plan through June 19, 2025, the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies (continued)

Expenses

Administrative expenses are paid by the Plan to the extent not paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedules. Actual results could differ from those estimates.

Related-Party Transactions

The Plan's investment in the Northern Trust Global Investments Short-Term Investment Fund is managed by Northern Trust Investments, Inc., an affiliate of the Trustee and, therefore, these transactions qualify as party-in-interest transactions.

Investment Valuation and Income Recognition

The Plan measures and reports financial assets and liabilities at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Valuation methodology used for the Plan assets are:

Common/collective trusts: Valued at net asset value as a practical expedient based on the fair value of the underlying investments of the trusts as determined by the sponsor of the trusts.

The valuation methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Administration Committee believes this valuation methodology is appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in a different fair value measurement at the reporting date.

Notes to Financial Statement (continued)

2. Summary of Significant Accounting Policies (continued)

All investments of the Plan as of December 31, 2024 and 2023 were in common/collective trusts and therefore not subject to disclosure by level.

The plan administrator has the ability to redeem investments as needed, unless specifically restricted by the fund.

Investment purchases and sales are recorded on the trade date. Dividend and interest income is recorded as earned on the accrual basis.

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

3. Benefit Obligations

The estimated liability for incurred but not reported claims of active participants and dependents is calculated based on historical claims lag experience. Claims payable represents claims paid by the claims administrators prior to December 31 that are not reimbursed by the Plan as of December 31.

The benefit obligations for disability claims are actuarially determined. Significant assumptions used by the Plan's actuaries in determining the benefit obligations for disability claims were: (a) discount rate of 5.43% for 2024 and 5.28% for 2023; (b) assumptions as to the incidence of disabilities (based on a blend of the Company's historical experiences and the 1987 Commissioner's Group Disability Table) and rates of recovery from disabilities (based on the 2012 Group Long-Term Disability Valuation Tables); and (c) Social Security approval (85% approval for disabilities).

The obligation for COBRA benefits is estimated by an actuary based on the actual number of employees utilizing COBRA benefits as of the measurement date and claim payment history.

3. Benefit Obligations (continued)

The actuarial present value of benefit obligations is reported based on assumptions pertaining to interest rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, reasonable notice shall be given to all participants as to the date that benefits and Company contributions shall cease. Upon dissolution of the Plan, and after allowing a reasonable period of time for outstanding and unpaid claims to be filed and cleared, assets remaining in the Plan shall be disposed of in accordance with ERISA and the directions of the Company.

5. Income Tax Status

The Trusts have received exemption letters from the IRS (Internal Revenue Service) dated March 9, 1981, and April 5, 2002, stating that they are tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code) as Voluntary Employee Beneficiary Associations (VEBAs). The Plan and the Trusts are required to operate in conformity with the Code to maintain the tax-exempt status of the Trusts. The Administration Committee believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related Trusts are tax-exempt.

5. Income Tax Status (continued)

US GAAP requires the Administration Committee evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Administration Committee has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
