As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 16, 2024 and December 31, 2023, and for the period January 1, 2024 to December 16, 2024, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cardinal Management Group, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As discussed in Note 1 to the financial statements, a resolution was approved for the termination of the Cardinal Management Group, Inc. 401(k) Profit Sharing Plan effective as of May 31, 2024; and the assets of the Plan were fully distributed as of December 16, 2024. In accordance with accounting principles generally accepted in the United States of America, the plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cardinal Management Group, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan

The following description of the Cardinal Management Group, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. A complete description of the Plan is contained in the Plan Document which governs the operation of the Plan.

General

The Cardinal Management Group, Inc. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code) established for employees of Cardinal Management Group, Inc., and its affiliates (the Company or Plan Sponsor). The Plan became effective on January 1, 1992. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective as of January 1, 2022.

Effective April 24, 2023, the Plan sponsor replaced Reliance Trust Company as trustee of the Plan and appointed Empower Trust Company, LLC as the new trustee of the Plan.

Plan Termination

On May 31, 2024, RealManage, LLC acquired the Plan Sponsor. In conjunction with the acquisition, a resolution was adopted to terminate the Plan effective as of May 31, 2024. As a result of the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan and ceased new issuance of any loans. Employees were notified of the plan termination and their distribution options. Management completed the termination procedures and distributed all Plan assets in accordance with the provisions of the Plan as of December 16, 2024.

Contributions

Prior to the Plan termination, participants were eligible to make 401(k) deferrals on the first day of the calendar quarter after completing three months of employment. Participants could contribute up to the maximum percentage allowable, not to exceed the limits of Code Sections 401(k), 402(g), 404 and 415 (\$23,000 for 2024 and \$22,500 for 2023). Participants who are age 50 or older could make additional catch up contributions up to the maximum amount allowed (\$7,500 for both 2024 and 2023). Participant rollover contributions were also allowed under the Plan.

The Company could make a discretionary matching contribution as determined by the Company each year. The eligibility requirement for the discretionary matching contribution was three months of service. Matching contributions were calculated and deposited each pay period.

The Company could also make non-elective (profit-sharing) contributions and qualified non-elective contributions to the Plan. To be eligible to receive profit-sharing contributions, the participant must have completed one year of eligible service.

Participant deferral contributions were \$272,397 and \$549,901 for the period January 1, 2024 to December 16, 2024, and the year ended December 31, 2023, respectively. Participant rollover contributions were \$0 and \$184,928 for the period January 1, 2024 to December 16, 2024, and the year ended December 31, 2023, respectively.

Contributions (Concluded)

For the period January 1, 2024 to May 31, 2024 (the termination date), and for the year ended December 31, 2023, the Plan declared matching contributions in the amount of 25% of deferrals up to 4% of compensation per pay period. Employer matching contributions were \$42,147 and \$80,467, net of forfeitures applied of \$856 and \$6,082 for the period January 1, 2024 to May 31, 2024 and for the year ended December 31, 2023, respectively.

Employer profit-sharing contributions were \$0 for the period January 1, 2024 to December 16, 2024, and the year ended December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and earnings on these contributions, and charged with benefit payments and transaction fees related to distributions, and allocations of administrative expenses. Allocation of plan earnings is based on the individual investment returns and account balances and is allocated based on the proportion of each participant's account balance as it bears to all participant account balances in that particular investment.

Vesting

Participants are immediately vested in their salary deferral and rollover contributions. Prior to termination, the vesting of employer profit sharing and discretionary matching contributions were based on the following schedule.

Participants became fully vested at the Plan termination date.

Investment Elections

Participants may elect to have their contributions invested in various investment options offered by the Plan's trustee.

Benefit Payments

The Plan provided for benefit payments upon termination, death and/or disability, after attaining age 59 1/2 and after obtaining the normal retirement age of 65, based on the vested balance in the participant's account. Hardship withdrawals and participant loans were also permitted, if certain conditions are met, as outlined in the Plan Document. Amounts included in net assets available for benefits, which are allocated to accounts of terminated participants who have withdrawn from the Plan, were zero as of December 16, 2024, and not significant as of December 31, 2023.

Forfeitures

Prior to the Plan termination, under the provisions of the Plan, a participant who terminates employment before becoming fully vested in the employer's contribution forfeits these amounts when any vested amounts are distributed. Forfeited amounts may be used to reduce employer contributions to the Plan or to pay administrative expenses. Forfeited amounts available to reduce employer contributions to the Plan or to pay administrative expenses were \$0 and \$23,679 at December 16, 2024 and December 31, 2023, respectively.

Forfeited amounts that were used for payment of employer contributions and Plan administration expenses, totaled \$30,067 and \$6,082 for the period January 1, 2024 to December 16, 2024, and the year ended December 31, 2023., respectively. All forfeiture amounts were used prior to December 16, 2024.

Notes Receivable from Participants

Prior to the Plan termination, participants could borrow up to one-half of their vested account balance with a maximum of \$50,000. The loans were secured by an assignment of a portion of the participant's vested account balance and bore interest at a reasonable rate established by the Plan administrator. Loans are generally repaid within five years; however, principal residence loans may allow for a longer repayment term.

Administrative Expenses

In 2024 and 2023, the Company paid for specific administrative costs of the Plan, and the remaining administrative costs of the Plan were paid from the assets of the Plan and allocated to the Plan participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

On May 31, 2024, a decision was made to terminate the Plan. As a result, the financial statements as of and for the year ended December 31, 2023 have been prepared on the ongoing basis, and the financial statements as of December 16, 2024 and for the period January 1, 2024 to December 16, 2024 have been prepared on the liquidation basis of accounting, in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There were no material changes to the financial statements as a result of the change under the liquidation basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Concluded)

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 16, 2024 or December 31, 2023.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3. Income Tax Status

Effective as of January 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing plan document and adoption agreement designed by The Retirement Advantage, Inc., which was a restatement of the previously adopted plan. The pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Prior to the restatement, the Plan adopted a volume submitter plan which obtained its latest opinion letter on March 31, 2014.

The Plan has been amended and restated since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded as of December 16, 2024 and December 31, 2023, there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification Topic 820, *Fair Value Measurement* (ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of inputs other than quoted prices in an active market that are observable, and Level 3 inputs are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The stable value fund is valued at NAV, which is used as a practical expedient to estimate fair value. There have been no changes in the methodologies used at December 16, 2024 or December 31, 2023.

Note 5. Information Certified by Plan Trustee

Accordingly, Empower Trust Company, LLC (the Plan Trustee for the period from April 24, 2023 December 31, 2023, and from January 1, 2024 through December 16, 2024), and Reliance Trust Company (the Plan Trustee for the period from January 1, 2023 through April 23, 2023), have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate.

Note 6. Exempt Party-In-Interest Transactions

Certain Plan investments are in mutual funds managed by J.P. Morgan, and a stable value fund managed by Reliance Trust. J.P. Morgan serves as the recordkeeper of the Plan, and Reliance Trust was the Trustee of the Plan through April 23, 2023, therefore transactions related to these investments qualify as exempt party-in-interest transactions.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks, including, but not limited to, interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Note 8. Delinquent Contributions

Contributions totaling \$650 were inadvertently not timely remitted during the year ended December 31, 2023. The Plan Sponsor self-corrected the issue and remitted the lost earnings on these deposits in 2023.

There were no delinquent contributions during the period January 1, 2024 to December 16, 2024.

Note 9. Subsequent Events

The Plan evaluated subsequent events through June 4, 2025, the date the financial statements were available to be issued. The Plan determined that there was no event occurring subsequent to December 16, 2024, that requires recognition or disclosure in the financial statements.
