INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of
the Arrowhead Dental Laboratory, Inc. 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Arrowhead Dental Laboratory, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Arrowhead Dental Laboratory 401(k) Retirement Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 

1. Description of Plan

The following brief description of Arrowhead Dental Laboratories, Inc. 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and trust covering employees of Arrowhead Dental Laboratories, Inc. (the "Plan Sponsor") who have completed 1,000 hours of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Custodian and Administration of the Plan

The record-keeper of the Plan is Principal Life Insurance Company. The administrator of the Plan is the Plan Sponsor.

Principal Life Insurance Company (the "Custodian") holds the assets of the Plan and acts as the Custodian and Trustee.

Contributions and Participant Accounts

Under the provisions of the Plan, participants may enter into a written salary deferral agreement with the Plan Sponsor in an amount not to exceed 100 percent of compensation, up to the maximum allowable amount as determined yearly by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). Participant contributions may not exceed the limits established by Internal Revenue Service guidelines which was \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 or will attain age 50 before the end of the calendar year are eligible to defer additional amounts ("catch-up contribution") to the Plan. The maximum catch-up contribution that an eligible participant can make was \$7,500 for 2024 and 2023. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Plan Sponsor can provide a discretionary matching contribution for all participants employed by the company on the last day of the fiscal year. In 2024 the Plan Sponsor elected to make a discretionary match contribution of the lesser of 5% of 40% of total compensation at year end, or 50% of employee deferrals at year end. The employer match in 2024 was \$182,068.

An account is maintained for each participant. The participant's account is credited with the participant's contribution, the Plan Sponsor's matching contribution, and the participant's plan earnings and losses. Each participant directs employee and employer contributions to his or her account in mutual funds, pooled separate accounts, or in investments in common collective trust accounts.

1. Description of Plan (continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Vesting

Participants are immediately 100% vested in their accounts attributable to the elective deferrals including catch-up contributions and rollover contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary match of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service, 20% each year. A participant is 100% vested at normal or early retirement age, or in the event of disability or death. Additionally, in the event of a plan termination, a participant will be 100% vested.

Forfeitures

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,866 and \$1,260, respectively. During 2024, \$1,275 was paid out to offset employer match.

Administration Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. During 2024, Plan administrative expenses totaled \$62,462.

2. Significant Accounting Policies

Basis of Presentation & Use of Estimates

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and present the net assets available for plan benefits and the changes in those net assets in accordance with accounting principles accepted in the United States of America. The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates and assumptions.

2. Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments at fair value consist of investments in mutual funds and pooled separate accounts. See note 4 for additional information. Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the ex-dividend date on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Corrective benefits payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding increase to distributions.

Payment of Benefits

Benefits are recorded when paid.

3. Information Prepared and Certified by Custodian

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Custodian (Principal Life Insurance Company):

- a. Total investments as shown in the accompanying Statements of Net Assets Available for Plan Benefits of \$13,990,960 and \$13,101,805 as of December 31, 2024, and 2023, respectively.
- b. Net investment income as shown in the accompanying Statement of Changes in Net Assets Available for Plan Benefits of \$1,544,387 for the year ended December 31, 2024.

Investment information is also included in the Schedule H. Line 4i - Schedule of Assets (Held at End of Year) – December 31, 2024.

The Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As such, the Plan's independent auditor did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

As noted in Note 2 above, the accompanying Statements of Net Assets Available for Plan Benefit report the Plan's investments at fair value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued using the published daily value of underlying assets. These investments are determined to have a readily determinable fair value and are classified within Level 2 of the valuation hierarchy.

The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Based on Management's assessment the investments elected to be valued at NAV meets the requirements for the NAV as a practical expedient. In accordance with Subtopic 820-10, these investments have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at net asset value:

Common collective trust accounts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily.

All Plan investments are managed by the Custodian and, therefore, qualify as party-in-interest transactions.

6. Tax and Plan Status

On June 30, 2020, the Internal Revenue Service advised the Record Keeper that the form of the Prototype Plan was acceptable under Section 401(a) of the IRC and was therefore exempt from federal income taxes. Although the Plan has been amended since receiving the IRS determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable taxing authorities. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of plan termination, participants will have a 100% vested interest in their accounts. The plan administrator will facilitate distribution of account balances in single lump sum payments in accordance with Plan provisions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
