**Opinion**

We have audited the accompanying financial statements of the 403(b) Thrift Plan of Northeast Missouri Community Action Agency, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the 403(b) Thrift Plan of Northeast Missouri Community Action Agency as of August 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 403(b) Thrift Plan of Northeast Missouri Community Action Agency and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 403(b) Thrift Plan of Northeast Missouri Community Action Agency's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Notes to the Financial Statements  
August 31, 2024 and 2023

**NOTE A: DESCRIPTION OF THE PLAN**

The following description of the 403(b) Thrift Plan of Northeast Missouri Community Action Agency (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is the retirement plan provided for employees of Northeast Missouri Community Action Agency (“Agency”).

- 1) General - The Plan was restated effective October 1, 2012. The Plan is a defined contribution plan covering all employees of Northeast Missouri Community Action Agency with no age or service requirements to participate. The Plan is subject to the provisions of ERISA. The Board of Directors is responsible for oversight of the plan.
- 2) Contributions – Each year, participants may contribute as much as they want of pretax annual compensation, as defined in the Plan, up to IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distribution from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an auto-enrollment provision whereby all newly hired eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan within thirty days of hire. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated target date retirement fund until changed by the participant. Contributions are subject to certain IRS limits. The employer will contribute a nonelective contribution equal to a percentage of the Participant’s elective deferrals based on years of service for vesting as set forth in the table below.

<u>Years of Service</u>	<u>Contribution Rate</u>
0-4	1%
5-9	2%
10 or More	3%

- 3) Participant Accounts - Each participant's account is credited with the participant's contribution as stated in 2) above. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- 4) Vesting – Participants are 100% vested upon participation.
- 5) Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account or rollover amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or rollover.

**NOTE A: DESCRIPTION OF THE PLAN** (Continued)

- 6) Forfeited Accounts – Participants are immediately 100% vested, therefore there are no forfeitures for the plan.

**NOTE B: SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Payments of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Agency. Expenses that are paid by the Agency are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE C: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE C: FAIR VALUE MEASUREMENTS** (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as August 31, 2024 and August 31, 2023.

**Pooled Separate Accounts:** Pooled separate accounts (PSAs) of the custodian invest in registered investment companies, which are invested in debt and equity securities of U.S. and foreign companies at various levels of market capitalization. The Mutual of America Money Markey Fund invests in money market instruments and other short term securities. Units held in PSAs are valued using the NAV of the fund. The NAV is based on fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a pooled separate account is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. Accordingly, the unit value for a collective investment fund is classified within level 2 of the valuation hierarchy.

**Interest Accumulation Account:** The IAA is valued at fair value as of the last day of the Plan year. Fair value approximates contract value and is the total of all amounts allocated under the contract through contributions plus accrued interest, minus withdrawals, transfers and administrative charges. Amounts allocated to the IAA become part of the general assets of the custodian (General Account). The General Account supports insurance and annuity obligations of the custodian. The General Account consists of all general assets, other than those in separate accounts and other segregated asset accounts of the custodian.

The custodian guarantees the value and bears full investment risk for all amounts that participants allocate to the General Account. The custodian guarantees a minimum interest credit, which was 3.00% at August 31, 2024 and 1.60% at August 31, 2023, respectively. Interest is credited on dates determined by the custodian, but not less frequently than once each calendar month. Accordingly, investment is classified within level 1 of the valuation hierarchy.

**NOTE D: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Mutual of America Financial Group. Mutual of America is the Plan Administrator and recordkeeper as for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Other service providers include Jarred, Gilmore, and Phillips, PA, the plan auditor, and Northeast Missouri Community Action Agency, the plan sponsor.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE E: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their Plan account.

**NOTE F: TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

**NOTE G: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H: PROHIBITED TRANSACTIONS**

During the year ended August 31, 2024, there was a pay period that resulted in contributions being delinquent. The total amount of delinquent contributions was \$1,355.77.

**NOTE I: SUBSEQUENT EVENTS**

The Plan evaluated events and transactions occurring subsequent to August 31, 2024, through June 13, 2025, the date the financial statements were available to be issued and noted no material subsequent events requiring disclosure. Additionally, there were no nonrecognized subsequent events requiring disclosure.
