Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Harmac Medical Products, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). December 31, 2024 and 2023

(1) Description of Plan

The following description of Harmac Medical Products, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a safe harbor defined contribution plan sponsored by Harmac Medical Products, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee, which is composed of members of the Company's Board of Directors and management, is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan was amended and restated effective February 17, 2022.

(b) Contributions

Entry into the Plan requires a participant to attain the age of 18 and have 5 months of service. Participants may make voluntary pre-tax or post-tax contributions to the Plan up to 100% of their eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover contributions representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they formally elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in one of Principal Life Insurance Company's (Principal Life) pooled separate accounts based on the participant's expected date of retirement until changed by the participant. The deferral rates of automatically enrolled participants are automatically increased by 1% each year, up to a maximum of 10%, unless they opt to contribute a different percentage.

The Company makes safe harbor matching contributions equal to 100% of elective deferral contributions up to 3% of participant's eligible compensation, plus 50% of elective deferral contributions which are over 3%, but are not in excess of 5% of participant's eligible compensation, as defined by the Plan. The Plan permits the Company to make discretionary contributions. The Company did not make discretionary contributions for the years ended December 31, 2024 and 2023.

Contributions are subject to certain limitations as provided by the Internal Revenue Code (the Code). Participants direct the investment of contributions into various investment options offered by the Plan.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, as well as allocations of (a) the Company's discretionary contribution, (b) Plan earnings, and (c) charged with an allocation of investment and administrative expenses. Accounts are also reduced for benefits paid and charged directly for benefit processing fees. Allocations of Plan earnings and investment management and recordkeeping fees are based on the investments held by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Company contributions become 40% vested after two years of credited service, as defined by the Plan, with vesting increasing at 20% increments each year thereafter, to 100% after five years of credited service.

A participant also becomes 100% vested if the Plan is terminated, upon reaching normal retirement age of 65, upon reaching an early retirement age of 55 and completing five years of service, or if he or she dies or becomes disabled while still employed by the Company.

(e) Forfeited Accounts

Forfeitures of non-vested Company contributions are used to pay administrative expenses of the Plan or to reduce the Company's contributions. There were no forfeitures of non-vested contributions during the year ended December 31, 2024. Forfeitures of non-vested Company contributions amounted to \$3,638 during the year ended December 31, 2023. Company contributions were reduced by \$142 in 2023 and administrative expenses of \$3 and \$3,555 were paid during the years ended December 31, 2024 and 2023, respectively. At December 31, 2023, there was \$3 of forfeitures available for future use.

(f) Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or an annuity equal to the value of their account. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and for participants who have attained age 59½.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received from the sale of an asset in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the custodians. See note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

(e) Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Services (IRS) are recorded as a liability with a corresponding reduction to contributions. No liability was required to be recorded at December 31, 2024 and 2023.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment management fees are included in net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan.

(h) Subsequent Events

The Plan has evaluated subsequent events through the date of the report, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

(3) Fair Value Measurements, Continued

- Pooled separate accounts - Valued at the NAV of units of the pooled separate account. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised primarily of shares of registered investment companies held through sub-accounts of a separate account of an insurance company. The Plan has concluded that the NAV, as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company, is used as a practical expedient to estimate fair value. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemption rights may be restricted or eliminated in the future. These investments file as direct filing entities.
- Collective investment trust funds - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. These investments file as direct filing entities.

(5) Party-In-Interest Transactions

A party-in-interest is defined under the Department of Labor’s regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, certain participants, and others.

Certain Plan investments are held or managed by Principal Life. Principal Life is one of the custodians as defined by the Plan and, therefore, transactions within these investment funds qualify as party-in-interest transactions. Fees paid by the Plan to Principal Life amounted to \$28,305 and \$30,257 for the years ended December 31, 2024 and 2023, respectively. Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

(7) Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Principal Financial Group. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status dated June 30, 2020. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investments which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
