Changes in Assumptions and Methods since the Last Actuarial Valuation The interest rates used for determining the funding target were 4.75%, 5.00% and 5.74%. These rates were updated to the rates required for the current plan year and to reflect the provisions of ARPA.

The mortality table for the funding target was changed as required under PPA '06.

Justification for Changes in Actuarial Assumptions The only assumption changes were to prescribed actuarial assumptions or as a result of At-Risk status. Therefore, the plan did not need IRS approval to change assumptions and there is no need to disclose any “Change in Actuarial Assumptions.”



A Participant who continues to work beyond his Normal Retirement Date eligible for a Late Retirement Benefit in an amount equal to his Accrued Benefit as of his Late Retirement Date.

Early Retirement Benefit

Eligibility:

A Participant is eligible for an Early Retirement Benefit, if he has:

1. Both attained age 55 and completed at least 15 years of Accumulated Service, or
2. Attained age 60, or
3. Completed at least 30 years of Accumulated Service.

Monthly Benefit:

A Participant may elect to receive his Early Retirement Benefit at any time after his Early Retirement Date in a reduced amount. The benefit will be reduced by 4.00% for each year that the Benefit Start Date precedes Normal Retirement Date. Zelenople Participants who have both attained age 62 and completed 25 or more years of continuous employment shall be entitled to their Early Retirement Benefits without reduction for early commencement.

Termination Benefit

Eligibility:

Upon termination of employment prior to retirement after completion of at least 5 years of Accumulated Service.

Monthly Benefit:

The vested benefit commences in full at age 65, or in a reduced amount under the early retirement provisions.



Appendix A (Continued)

Death Benefit

Eligibility:

Participant must be vested and married at the time of death.

Monthly Benefit:

The survivor's benefit payable for the spouse's lifetime is an amount equal the Participant's Accrued Benefit as of date of death, reduced as if the Participant had retired on the benefit start date and elected to receive a Qualified Joint and 50% Survivor Annuity as of his Early Retirement Date.

Optional Forms of Benefit

50% Joint and Survivor
75% Joint and Survivor
100% Joint and Survivor

Mortality rates used to compute optional forms of payment shall be the unisex rates from the 1994 GAR Mortality Table.

Benefits Available as Lump Sum

The Plan pays only small benefit amounts (lump sums less than \$5,000).

Lump sums are determined using the assumptions as defined in 417(e). Interest rates used for lump sum payments shall be the graded interest rates in effect for 5th month before the month that the Participant elects a lump sum.

Maximum Benefit Limit

The Internal Revenue Code Section 415 Maximum Benefit payable as a life annuity at Social Security Normal Retirement Age.
