### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of American Academy of Neurology 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the American Academy of Neurology 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution Plan originally effective January 1, 2001. The Plan has been amended and restated throughout the years to comply with tax legislation. The Plan was last amended and restated effective January 1, 2024. The Plan covers substantially all employees of the Plan Sponsor, American Academy of Neurology (the Employer). Employees are immediately eligible upon employment to make pre-tax and/or Roth contributions to the Plan. Effective January 1, 2024, long-term, part-time employees (an employee who completes at least 500 hours of service during three consecutive years starting in the 2021 Plan year but has never completed 1,000 hours during a Plan year), are eligible to make pre-tax and/or Roth contributions after attaining age 21. They will be entered into the Plan on January 1<sup>st</sup> or July 1<sup>st</sup>. Collectively bargained employees and non-resident aliens who receive no U.S. source are excluded from eligibility as long-term, part-time employees. Employees are eligible for the Employer nonelective contribution and safe harbor contribution the first of the month immediately following or coinciding with one month of service. Prior to April 1, 2023, the Plan excludes leased employees, individuals considered by the Employer to not be a common law employee or a self-employed individual and part-time, seasonal and temporary employees hired after April 1, 2019 whose regularly scheduled service is less than 1,000 hours of service each year. Effective April 1, 2023, the Plan excludes leased employees and part-time (an employee who normally works less than 30 hours per week), seasonal and temporary employees hired after April 1, 2019, and employees deemed to be residents of Puerto Rico. The Plan recognizes prior service with the participating companies. The Plan is subject to the provisions of the ERISA, as amended.

**Contributions**

Participants may elect to contribute a percentage of eligible compensation to the Plan, up to the maximum amount allowed under the Plan. The Employer automatically withholds 4% as pre-tax contributions unless the participant elects otherwise. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Participants who have an automatic deferral amount and also whose elective deferral amount is greater than 0% and less than 8% will be subject to an automatic increase of 1% each year unless or until the participant's deferral amount reaches 8% of the participant's compensation.

The Employer makes a safe harbor contribution of up to 3% of the employee's eligible compensation. In addition, the Employer made a discretionary contribution of 7.5% of the employee's eligible compensation for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

**NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts**

The Plan permits participants to direct the investment of their account balance under the Plan. Each participant's account is credited with the participant's contribution, and allocations of (1) the Employer contributions, (2) Plan earnings or losses, and (3) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately fully vested in all contribution types. Participants hired on or after April 1, 2019 are 25% vested in nonelective contributions after one year of credited service, 50% vested after two years of credited service, and 100% vested in nonelective contributions after three years of credited service.

**Benefit Payments**

Upon termination of employment, including death, disability or retirement, participants may elect to receive the value of their account in the form of a lump sum payment, installment payments, an annuity payment option (allowable through March 31, 2023) or a partial withdrawal (allowable effective April 1, 2023). The Plan provides for mandatory distributions in the form of a lump sum distribution for balances that do not exceed \$5,000. The Plan allows for in-service distributions at age 59½ and for hardship distributions, subject to Plan provisions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Notes issued on or after April 1, 2023 will bear interest at a rate of prime plus 2%. For notes issued prior to April 1, 2023, principal and interest are paid ratably through payroll deductions or paid directly by participants through ACH payments. Principal and interest for notes issued on or after April 1, 2023 are paid directly by participants through ACH payments.

**Forfeited Accounts**

Forfeited nonvested accounts can be used to pay administrative expenses, reduce Employer contributions, or allocated to participants as discretionary additional matching contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$2 and \$4, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$18,971 and \$11,371 were used to reduce Employer contributions, respectively. There were no forfeitures allocated to participants and no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Employer pays certain administrative expenses on behalf of the Plan.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through June 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Nationwide Trust Company, FSB, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants presented in the accompany statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the year ended December 31, 2024 and the period of April 1, 2023 through December 31, 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Delaware Charter Guarantee and Trust Company dba: as Principal Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants presented in the accompanying statement of changes in net assets available for benefits for the period of January 1, 2023 through March 31, 2023.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Through March 31, 2023, the Plan investments were held by Delaware Charter Guarantee and Trust Company dba: as Principal Trust Company, the trustee of the Plan. Effective April 1, 2023, the Plan investments are held by Nationwide Trust Company, FSB, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.
