Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

1. PLAN DESCRIPTION:

The following description of the Santa Fe Christian Schools 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan which covers all eligible employees of Santa Fe Christian Schools (the Sponsor). All employees who work more than 20 hours per week and are not considered student employees are immediately eligible to participate in the Plan. Employees who have attained 21 years of age and completed one year of service are eligible to receive employer matching contributions. Employees are credited with a year of service for eligibility purposes upon the completion of a minimum of 1,000 hours of service during a consecutive twelve-month period. The Plan was established effective January 1, 2002, and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The 403(b) Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Finance Committee oversees Plan operations.

CONTRIBUTIONS

Participants may contribute amounts on a pre-tax basis, post-tax basis, or combination of the two options up to the annual limits established by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 or have completed 15 years of service with the School may make catch-up contributions. Participants direct the investment of all contributions into various investment options offered by the Plan. The Sponsor makes employer matching contributions equal to 100% of elective deferrals up to 3% of compensation by employees who have 1 to 9 years of service, up to 4% of compensation for employees who have 10 to 14 years of service, up to 5% of compensation for employees who have 15 to 19 years of service, and up to 6% of compensation for employees who have 20 or more years of service. As of July 1, 2024, this policy was updated to employer matching contributions equal to 100% of elective deferrals up to 4% of compensation by employees who have 1 to 9 years of service, up to 5% of compensation for employees who have 10 to 14 years of service, up to 6% of compensation for employees who have over 15 years of service. The Sponsor may make discretionary contributions to the Plan. No discretionary contributions were made during the year ended December 31, 2024.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocation of: (a) the Sponsor's contributions and (b) the Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participant's contributions and related earnings are fully vested at all times. Employer contributions, plus related earnings, are subject to the following vesting schedule:

This policy was updated on July 1, 2024 to state that employees with less than one year of service are 0% vested, while those with over one year of service are 100% vested. Terminated employees and employees no longer active as of July 1, 2024 are still subject to the previous vesting schedule.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions. Participant loans are included in notes receivable from participants on the statements of net asset available for benefits.

PAYMENTS OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, apply the lump-sum amount towards the purchase of an annuity from the trustee, or maintain the balance in the Plan. Upon termination, unless otherwise elected, if a participant's vested account balance is equal to or less than \$1,000, the balance is immediately distributed as a lump-sum payment. Participants may also receive an in-service distribution upon reaching age 59 1/2. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

FORFEITED ACCOUNTS

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,100, and \$4, respectively. These accounts are used to reduce future employer contributions or to pay Plan expenses. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or pay administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsible investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value represents contributions made under a contract, plus interest, less participant withdrawals and administrative expenses. See Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

The Plan paid administrative fees of \$90,537 during the year ended December 31, 2024. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Professional fees and service fees are reported as administrative expenses in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments. The expense ratio for investment related expenses range from 0 basis points to 70 basis points.

3. INFORMATION PREPARED AND CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF), the qualified institution, has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity and interest on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024. TIAA Trust, N.A. is the custodian of the portion of the Plan assets investment in mutual fund shares and have authorized TIAA to certify investments held by TIAA Trust, N.A. TIAA and CREF is the issuer of the remaining assets in the Plan.

4. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements and Disclosure topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

4. FAIR VALUE MEASUREMENTS, continued:

The fair value of mutual funds is based on quoted prices in active markets for identical assets.

Changes in valuation techniques for the year ended December 31, 2024: None.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has a benefit-responsible guaranteed investment contract with TIAA. TIAA maintains the contributions in a general account. The contract provides a guaranteed minimum rate of interest of between 1% and 3%. The account is credited with earnings on the underlying investment and charged for participants' withdrawals and administrative expenses. Contract value is the relevant measurement attribute for net assets available for benefits held in this fund. Contract value represents accumulated cash contributions made under the contract, plus interest credited to the contracts, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or with TIAA are probable at this time.

Subject to the terms of the contract, the contract holder or TIAA may discontinue the contract. Payment of the contract accumulation may be made from 90 days up to two years after such discontinuance is processed, as described in the contract.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Sponsor contribution portion of their account.

7. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by TIAA. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated August 8, 2017, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PARTY-IN-INTEREST:

ERISA defines parties-in-interest similarly to a related party under financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

As of December 31, 2024 and 2023, certain investments for the Plan are managed by TIAA and CREF. TIAA and CREF perform recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. The value of these assets were \$527,499 and \$575,148 as of December 31, 2024 and 2023, respectively. Direct fees paid by the Plan for these services amounted to \$66,712 for the year ended December 31, 2024. In addition, the Plan paid \$23,825 to LPL Financial LLC for plan servicing.

10. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through June 19, 2025, which represents the date the financial statements were available to be issued.
