We have performed an audit of the accompanying financial statements of W.W. Wallwork, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 PLAN DESCRIPTION**

The following description of the W.W. Wallwork, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering qualified employees of W.W. Wallwork, Inc. and Valley Imports (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. Third Party Administrators serve as the trustee of the Plan, maintain the records of participant data and hold the Plan assets.

**Eligibility**

Employees of the Company are eligible to participate in the Plan upon attainment of 18 years of age and 1 month of service for employee and employee match contributions. In order to be eligible for nonelective employer contributions, employees must be 21 years of age and have completed one year of service (defined as 1,000 service hours). Employees can enroll in the Plan on the first day of the month coinciding with the date on which an employee satisfies the eligibility requirements.

**Contributions**

Each year, participants may contribute up to one hundred percent (100%) of pretax annual compensation, as defined in the plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes a matching contribution of 50 percent of the first 6 percent of base compensation that a participant contributes to the Plan. In addition, the Company may contribute a discretionary profit-sharing contribution. No such additional discretionary contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, increasing 1% on the second payroll following January 1, increasing up to a maximum of 12%. The participant has their contributions invested in a designated fund until changed by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and an allocation of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service.

**Payment of Benefits**

Upon retirement, termination, disability or death, a participant or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of substantially equal periodic installments. Additionally, participants may take an in-service distribution of employee deferrals upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000 prior to February 1, 2024. Effective February 1, 2024, this limit was increased to \$7,000. Any vested participant balance exceeding \$1,000 may be distributed to an Individual Retirement Account or Annuity and any amount less than \$1,000 may be directly distributed as a lump-sum. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

**Notes Receivable from Participants**

Participant loans are not permitted in the Plan.

**Forfeitures**

Forfeitures can be used for any manner the Plan deems necessary (reduce employer contributions, pay plan expenses, allocate among participants, etc.). At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$122,892 and \$101,286, respectively. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$113,387 and \$106,892, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participant accounts are assessed a separate fee for the administration of benefit payments.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Markets: Valued at cost plus interest earned.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the net asset value (NAV) of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self Directed Brokerage Accounts: Accounts primarily consist of mutual funds, money market funds, corporate bonds, common stocks, and ETF stocks and are valued at the closing price reported on the active market on which the individual securities are traded.

Alerus Managed Accounts: Based upon participants' risk tolerance, retirement age, and other preferences, funds are invested in these accounts. Accounts primarily consist of mutual funds and are valued at the closing price reported on the active market on which the individual securities are traded.

Life Insurance Policies: Valued at cash surrender values, which approximate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 AMENDMENT AND TERMINATION OF PLAN**

The Company has the right to amend the Plan if it determines that it is necessary or desirable to do so. Further, although the Company intends to continue the Plan, it reserves the right to terminate it. Any termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 6 INCOME TAX STATUS**

The Plan is a pre-approved plan sponsored by Alerus Financial, N.A. The Internal Revenue Service informed the Provider by an opinion letter dated June 30, 2020, that the pre-approved plan is acceptable under section 401 of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter, however, the Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTION WITH PARTIES IN INTEREST**

Alerus Financial, N.A. and Alerus Investment Advisors are the trustee and investment advisor, respectively, of the Plan as defined by the plan document. As such, transactions with these providers qualify as party-in-interest transactions. Total fees paid to these providers for the years ended December 31, 2024 and 2023, amounted to \$102,625 and \$90,402, respectively.

Alerus Financial, N.A. receives revenue from mutual fund service providers for services Alerus Financial, N.A. provides to the funds. This revenue is used to offset certain amounts owed to Alerus Financial, N.A. for administrative services Alerus Retirement and Benefits provides to the Plan.

Certain Plan participants have a life insurance policy through General American Life Insurance Co. with a fair value of \$53,272 and \$52,217 at December 31, 2024 and 2023, respectively. The Plan pays expenses related to these investments in life insurance policies.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through June 9, 2025, which is the date these financial statements were available to be issued.

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 PLAN DESCRIPTION**

The following description of the W.W. Wallwork, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering qualified employees of W.W. Wallwork, Inc. and Valley Imports (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. Third Party Administrators serve as the trustee of the Plan, maintain the records of participant data and hold the Plan assets.

**Eligibility**

Employees of the Company are eligible to participate in the Plan upon attainment of 18 years of age and 1 month of service for employee and employee match contributions. In order to be eligible for nonelective employer contributions, employees must be 21 years of age and have completed one year of service (defined as 1,000 service hours). Employees can enroll in the Plan on the first day of the month coinciding with the date on which an employee satisfies the eligibility requirements.

**Contributions**

Each year, participants may contribute up to one hundred percent (100%) of pretax annual compensation, as defined in the plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes a matching contribution of 50 percent of the first 6 percent of base compensation that a participant contributes to the Plan. In addition, the Company may contribute a discretionary profit-sharing contribution. No such additional discretionary contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, increasing 1% on the second payroll following January 1, increasing up to a maximum of 12%. The participant has their contributions invested in a designated fund until changed by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and an allocation of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service.

**Payment of Benefits**

Upon retirement, termination, disability or death, a participant or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of substantially equal periodic installments. Additionally, participants may take an in-service distribution of employee deferrals upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000 prior to February 1, 2024. Effective February 1, 2024, this limit was increased to \$7,000. Any vested participant balance exceeding \$1,000 may be distributed to an Individual Retirement Account or Annuity and any amount less than \$1,000 may be directly distributed as a lump-sum. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

**Notes Receivable from Participants**

Participant loans are not permitted in the Plan.

**Forfeitures**

Forfeitures can be used for any manner the Plan deems necessary (reduce employer contributions, pay plan expenses, allocate among participants, etc.). At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$122,892 and \$101,286, respectively. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$113,387 and \$106,892, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participant accounts are assessed a separate fee for the administration of benefit payments.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Markets: Valued at cost plus interest earned.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the net asset value (NAV) of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self Directed Brokerage Accounts: Accounts primarily consist of mutual funds, money market funds, corporate bonds, common stocks, and ETF stocks and are valued at the closing price reported on the active market on which the individual securities are traded.

Alerus Managed Accounts: Based upon participants' risk tolerance, retirement age, and other preferences, funds are invested in these accounts. Accounts primarily consist of mutual funds and are valued at the closing price reported on the active market on which the individual securities are traded.

Life Insurance Policies: Valued at cash surrender values, which approximate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 AMENDMENT AND TERMINATION OF PLAN**

The Company has the right to amend the Plan if it determines that it is necessary or desirable to do so. Further, although the Company intends to continue the Plan, it reserves the right to terminate it. Any termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 6 INCOME TAX STATUS**

The Plan is a pre-approved plan sponsored by Alerus Financial, N.A. The Internal Revenue Service informed the Provider by an opinion letter dated June 30, 2020, that the pre-approved plan is acceptable under section 401 of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter, however, the Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTION WITH PARTIES IN INTEREST**

Alerus Financial, N.A. and Alerus Investment Advisors are the trustee and investment advisor, respectively, of the Plan as defined by the plan document. As such, transactions with these providers qualify as party-in-interest transactions. Total fees paid to these providers for the years ended December 31, 2024 and 2023, amounted to \$102,625 and \$90,402, respectively.

Alerus Financial, N.A. receives revenue from mutual fund service providers for services Alerus Financial, N.A. provides to the funds. This revenue is used to offset certain amounts owed to Alerus Financial, N.A. for administrative services Alerus Retirement and Benefits provides to the Plan.

Certain Plan participants have a life insurance policy through General American Life Insurance Co. with a fair value of \$53,272 and \$52,217 at December 31, 2024 and 2023, respectively. The Plan pays expenses related to these investments in life insurance policies.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through June 9, 2025, which is the date these financial statements were available to be issued.
