## Report of Independent Auditors

To the Plan Administrator and Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Sterilite Corporation Retirement Income Partnership, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). December 31, 2024

### 1. Description of Plan

The following brief description of the Sterilite Corporation Retirement Income Partnership (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement and to the Plan's summary plan description for more complete information.

#### General

The Plan is a defined contribution plan covering all eligible employees of Sterilite Corporation and subsidiaries (the Company). To be eligible, participants must have attained the age of eighteen. Participants enter the Plan as of the beginning of each payroll period for purposes of elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions and Funding Policy

Each year, participants may contribute up to 60% of pretax annual compensation earned during the respective payroll period in which the contribution is deferred, subject to limitations established by the Plan and the Internal Revenue Service (the IRS). Changes to employee contribution percentages may be made prospectively on the next entry date. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan also permits Roth elective deferrals. Roth elective deferrals are treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not "pre-tax" deferrals as defined in the Code.

The Plan also includes an automatic enrollment feature. Individuals hired by the Company who do not affirmatively elect not to participate are automatically enrolled in the Plan and will have their compensation reduced by 5% and invested in age-appropriate Freedom Funds unless electing otherwise. In addition, these employees will have their deferrals increased by 1% per year, not to exceed 10% of their compensation, unless the employee affirmatively elects not to increase their contributions.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Contributions and Funding Policy (continued)

The Plan employer contribution is a safe harbor matching contribution for eligible participants in accordance with statutory requirements. The safe harbor matching contribution will be equal to 100% of the first 3% of employee contributions, and 50% of the next 2% of employee contributions. These safe harbor contributions are also immediately 100% vested.

#### Participants Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution, and plan earnings. Forfeited balances of terminated participant's non-vested balances are used to offset future employer contributions to the Plan. The balance of the forfeiture account was \$21,781 and \$31,848 at December 31, 2024 and 2023, respectively. Forfeitures used during the years ended December 31, 2024 and 2023 were \$7,755 and \$34,079, respectively. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings. Effective January 1, 2019, participants are immediately vested in the Company safe harbor contribution plus the actual earnings thereon.

Prior to January 1, 2019, vesting in the Company's employer fixed and employer matching contribution portion of their accounts plus actual earnings thereon was based on years of continuous service through December 31, 2018. A participant was 100% vested after 5 years of credited service, based on a gradual vesting schedule, as defined in the Plan.

#### Payment of Benefits

Upon separation of employment due to termination, death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum amount. Prior to termination of employment, a participant can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age.

### 1. Description of Plan (continued)

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 2. Summary of Accounting Policies (continued)

#### Administrative Expenses

Effective August 1, 2022, the Plan entered into fixed pricing with Fidelity Workplace Services, LLC. The fees related to recordkeeping services are fixed at \$15 per participant per quarter or \$60 per year. In addition, any excess revenue sharing generated from the various mutual fund investments above this amount is credited back to participant accounts. The Company will pay the quarterly net fee should the revenue sharing credit not cover the recordkeeping and other Plan fees. For the years ended December 31, 2024 and 2023, the amount of excess revenue above the fixed basis pricing amount was \$109,188 and \$46,907, respectively. The Plan allocated the quarterly excess revenue to participant accounts.

Certain other administrative expenses such as participant specific fees are deducted directly from participant accounts. The amounts deducted from participant accounts in 2024 and 2023 amounted to \$8,100 and \$9,700, respectively.

#### Plan Administration

The Company is the Plan Sponsor and has appointed Fidelity Management Trust Company as the Plan's trustee. Recordkeeping services are provided by Fidelity Workplace Services, LLC.

### 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of mutual funds, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

### 4. Fair Value Measurements

Accounting Standards Codification 820 “Fair Value Measurements” (ASC 820) defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 Inputs are quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2024 and 2023.

Mutual funds are valued at the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Notes to Financial Statements (continued)

### **4. Fair Value Measurements (continued)**

All mutual fund investments held at December 31, 2024 and 2023, are Level 1 within the fair value hierarchy.

### **5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **6. Parties-In-Interest**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, the management of investments held by the trustee is considered party-in-interest transactions.

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Management Trust Company, the plan trustee. In addition, Fidelity Workplace Services, LLC is the plan recordkeeper. These investments and transactions are considered to be party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

### **7. Income Tax Status**

The Plan has adopted the non-standardized pre-approved profit-sharing plan of Fidelity Management & Research LLC. The non-standardized pre-approved profit-sharing plan sponsor received an advisory letter from the IRS dated June 30, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

#### **7. Income Tax Status (continued)**

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Subsequent Events**

The Company has evaluated all subsequent events through June 23, 2025, the date the financial statements were available to be issued. During this period, there have been no material events that would require recognition in the financial statements or disclosures to the financial statements.
