### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Huntwood Industries 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Huntwood Industries 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of Huntwood Industries 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a single employer defined contribution plan covering substantially all eligible employees of T.R.A. Industries, Inc., dba Huntwood Industries ("Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The management group oversees governance of the Plan. The Plan's Trustee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's management group.

**Eligibility**

The employees are eligible to participate after attaining age 21 and following 500 hours of service in a six-month period. If this service requirement is not met, the participant will be eligible after completing one year of eligible service or 1,000 hours. Once participants have satisfied the eligibility conditions, they are eligible to participate under the Plan on their Entry Date, meaning the first of January, April, July, or October coinciding with or next following the date they satisfy those criteria.

**Contributions**

Each year, participants may voluntarily elect to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan and subject to Internal Revenue Code limitations. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants direct their contributions to the various options offered by the Plan. The plan currently offers pooled separate accounts as investment options for participants.

The Company's matching contributions, if any, are equal to that percentage of each contributing participant's elective deferral which the employer, in its sole discretion, determines from year to year. The Company may elect to make a Profit-Sharing Contribution each year, based on the Company's discretion. Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the plan year, to be eligible to receive any profit-sharing contributions. The Company may also make discretionary qualified non-elective contributions.

All Plan contributions are subject to IRS regulatory limitations and may be made in cash only.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

The Plan permits participants to borrow a minimum of \$1,000 up to 50% of their vested account balance and not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with the average prevailing rate used for similar personal loan transactions by several commercial banks in the general geographic area of the Plan. Principal and interest are paid ratably through regular payroll deductions. Interest rates of current loans range from 5.50 to 9.50 percent. Interest is recorded on the accrual basis of accounting and is presented in dividends and interest on the statement of changes in net assets.

**Vesting**

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in employer matching contributions and related earnings are based on years of service as follows:

**Forfeited accounts**

Any available forfeitures shall be used to pay administration expenses or reduce employer matching contributions, if applicable. At December 31, 2024 and 2023, there was \$3,107 and \$9,261, respectively, in forfeitures available to offset employer contributions. During the year ended December 31, 2024, \$11,330 were used to offset Administration Fees.

**Payment of Benefits**

The full value of each participant's account is payable at the participants Normal Retirement Age. A participant may receive a lump sum distribution of their entire vested balance or a single sum distribution of a portion of their vested account balance.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan include both the profit sharing and incentive savings 401(k) components. The Plan's financial statements have been prepared in accordance with U.S. generally accepted accounting principles (US. GAAP).

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the pooled separate account, which is reported at net asset value, and the fully benefit-responsive guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's investment committee determines the plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value investments.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Investment Income**

Net appreciation or depreciation of investments includes realized and unrealized gains and losses and interest and dividends added to the Plan's investments and is recognized as investment income or loss in the annual statement of changes in net assets available for plan benefits. The components of investment earnings are not separate out as required by GAAP because the custodian does not provide separate information for each element. However, management does not believe that this GAAP departure is material to the financial statements.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not distribute any excess contributions.

**Payment of Benefits**

Benefits are recorded when approved or deemed a distribution.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

Subsequent events have been evaluated through the date of the auditor's report. This is the date the financial statements were available to be issued.

**NOTE 3 – INVESTMENT INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 4– FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Inputs used to determine fair value refer broadly to the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability based on the best information available. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels are described as follows:

Level 1 inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the plan can access at the measurement date.

Level 2 inputs consist of other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) quoted prices for similar assets or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in inactive markets c) inputs other than quoted prices that are observable for the asset or liability or d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 includes inputs that are unobservable for the asset or liability.

The plan had no level 1, 2 or 3 inputs during 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at net asset value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual fund shares held in pooled separate accounts:* These investments held in sub-accounts are maintained by an insurance company that operates apart from and is insulated from the general assets or liabilities of that company. The sub-accounts are held in mutual fund pools and invest in the underlying mutual fund. The investments in the sub-accounts are valued at the daily closing price as reported by the fund. The mutual funds are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held in the sub-accounts are deemed to be actively traded. The pooled separate accounts all have a daily redemption frequency.

**NOTE 5 – GROUP ANNUITY CONTRACT WITH LINCOLN NATIONAL LIFE INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Lincoln Financial. Total values on December 31, 2024 and 2023 of \$18,077 and \$29,722 were outstanding respectively. Lincoln Financial maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln Financial, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amount due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 5 – GROUP ANNUITY CONTRACT WITH LINCOLN NATIONAL LIFE INSURANCE COMPANY (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 –RISKS & UNCERTAINTIES**

Investment securities are exposed to various risks that can affect the value of the Plan's investments such as interest rate risk, custodial credit risk, and concentration of credit risk. The Plan invests in registered investment companies (mutual funds). Mutual fund holdings in equity securities respond to such factors as economic conditions, individual company earnings performance, and market liquidity, while holdings in debt securities are particularly sensitive to credit risk and change in interest rates.

**Interest rate risk**

Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed-rate security and adversely affect the selling price of the security prior to maturity. The price of a debt security typically moves in the opposite direction of the change in interest rates. As of December 31, 2024, the Plan had the following investments subject to interest rate risk:

**NOTE 7 – PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, cash and cash equivalents managed by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company is the plan administrator, as defined by the Plan. Therefore, transactions with Lincoln National Life Insurance Company are considered to be party-in-interest transactions.

The Plan also has notes receivable from participants, which also qualify as party-in-interest transactions.

**NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the plan and the amounts credited to participants account will continue to be 100% vested.

**NOTE 9 – TAX STATUS**

The Plan document is a prototype standardized, defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on November 30, 2020, which stated the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
