INDEPENDENT AUDITOR'S REPORT

To the Trustees
MEDIC EMS Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the MEDIC EMS Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023, and the related statements of changes in net assets available for benefits for the years then ended (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MEDIC EMS Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of MEDIC EMS Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting

As discussed in Note 10 to the financial statements, the governing body of the MEDIC EMS Retirement Plan approved a plan of liquidation on January 1, 2024, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the accrual basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about MEDIC EMS Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of MEDIC EMS Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about MEDIC EMS Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

December 31, 2024 and 2023

NOTE 1 – PLAN DESCRIPTION

The following description of the MEDIC EMS Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established April 1, 1994 covering all permissible employees of MEDIC EMS (referred to as the Company) as defined in accordance with the universal eligibility standards. Eligible employees with 1,000 hours of service are able to make elective deferrals and are able to participate in employer contributions once they have completed one year of service. Participation in the Plan is voluntary and employees can enroll in the Plan on January 1 or July 1, after having met the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions - Participants may contribute a percentage of pre-tax annual compensation (subject to federal limitations) in the form of a salary reduction. The Plan was amended effective October 2016 to include an auto-enrollment provision. The provision increased all employee deferrals to 4%, if not already at 4% or higher, in addition to auto-enrolling newly eligible participants unless the participant affirmatively elected not to participate or chose another deferral rate. Contributions are automatically invested in a designated balance fund until changed by the participant. The Company also contributes 25% of each eligible participant's contribution up to 4% of the employee's eligible compensation. The Plan also allows for additional Company contributions at the discretion of the Company's Board of Directors for eligible participants, which was 6% of the employee's compensation as defined in the Plan document for each of the years ended December 31, 2024 (in liquidation) and 2023.

Employee contributions, matching employer contributions, and employer discretionary contributions are invested in one or more investment fund options offered by the Plan as directed by the individual participant.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) Plan earnings, and charged with the participant's withdrawals. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Forfeited balances of terminated participant's nonvested accounts are used to pay for the Plan's general administrative expenses and/or to reduce employer contributions. Total forfeitures used to reduce employer contributions and/or pay administration expenses amounted to \$0 in 2024 and \$12,826 in 2023. Forfeitures included in net assets available for benefits as of December 31, 2024 and 2023 amounted to \$-0- for both years.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – (Continued)

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100 percent vested after three years of credited service. See Note 10 regarding termination of the Plan as participants become 100% vested in all contributions as a result of the termination.

Payment of Benefits - On death, disability, retirement or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive as a distribution from his or her account the value of their account in installments, as a joint or survivor annuity, or in a lump sum payment.

Administrative Expenses and Participant Loans - Certain administrative expenses relating to investment management fees are paid by the Plan and are recorded in the statement of changes in net assets available for benefits. Certain other expenses relating to the general administration of the Plan are paid by the Company and are excluded from the statement of changes in net assets available for benefits.

Participant loans are not permitted under the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan for the year ended 2024 were prepared under the liquidation basis of accounting, in accordance with Accounting Standards Codification (ASC) 205-30, *Presentation of Financial Statements – Liquidation Basis*. See Note 10 regarding termination of the Plan. The financial statements of the Plan for year ended 2023 were prepared under the accrual basis of accounting. The Plan evaluated subsequent events through June 23, 2025 which is the date the financial statements were available to be released.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are held by Principal Trust Company (Custodian) who allocates plan assets to the individual accounts of each participant as directed by the participant.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

NOTES TO FINANCIAL STATEMENTS

NOTE 2 – (Continued)

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract (Principal Fixed Income Guarantee Option) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date. The fair value of investments is based on quoted market prices of national securities exchanges. Where marketable securities are not listed on an exchange, price quotations are obtained from securities brokerage firms. Contract value represents contributions made under the contract plus earnings at the contract rate of approximately 0.2% in 2024 and 1.63% in 2023 less participant withdrawals and administrative expenses. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefit payments to participants are recorded when paid.

NOTE 3 – FAIR VALUE MEASUREMENTS – UNAUDITED

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access at the measurement date.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTES TO FINANCIAL STATEMENTS

NOTE 3 – (Continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted share prices in an active market.

Investment contract: Valued at the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates (Level 3 inputs).

The Plan's investment contract is measured at contract value in accordance with the provisions of ASU 2015-12 regarding Plan Accounting for Employee Benefit Plans, contract value is designated as the only required measure for fully benefit-responsive investment contracts and is excluded from the fair value hierarchy.

NOTE 4 – INFORMATION CERTIFIED BY TRUSTEE – UNAUDITED

The following information is certified by Principal Trust Company, the custodian of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

- Investments, at fair value and contract value as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income as shown in the Statement of Changes in Net Assets for the years ended December 31, 2024 and 2023.

The Plan's investment contract is a traditional fully benefit-responsive guaranteed investment contract with Principal Trust Company (Principal) who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 4%. Such interest rates are reviewed on a quarterly basis for resetting.

NOTES TO FINANCIAL STATEMENTS

NOTE 4 – (Continued)

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring in 2024. As discussed in Note 10, the Plan was terminated. See further discussion therein.

NOTE 5 – TAX STATUS

The Plan is designed for tax-exempt organizations described in Code Section 501(c)(3) to satisfy the requirements for an arrangement described in Code Section 403(b) that may include employee elective deferrals and matching employer contributions. The Plan has been designed using the pre-approved prototype 403(b) plan document as prescribed by the Internal Revenue Service in Revenue Procedure 2007-71 and 2013-22. The Plan administrator and Plan management believe the Plan is currently designed and operating in compliance with applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan evaluates the tax benefits of a tax position using the "more likely than not" threshold. As of December 31, 2024, management is not aware of any uncertain tax positions and related tax benefits which would be material to the Plan's financial statements. The Plan files annual information returns which for years subsequent to 2018 are subject to examination by taxing authorities.

NOTES TO FINANCIAL STATEMENTS

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect the amounts reported in the financial statements.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company as the custodian as defined by the Plan and, therefore, transactions with them qualify as party-in-interest transactions. See Note 9 for administrative fees paid to Principal Trust Company which qualify as exempt party-in-interest transactions.

NOTE 9 – ADMINISTRATIVE EXPENSES

Plan administrative expenses related to participant loan administration, member requested services, withdrawal charges and personal retirement accounts are charged to participant accounts. In March 2018, the Plan made a change to a different share class of investments. The previous share class of investments paid revenue to Principal Trust Company (Principal), which was used by Principal to offset administrative expenses. The new share class of investments does not pay any revenue to Principal. Accordingly, Principal now charges plan participants approximately 40 basis points for their share of administrative expenses. Fees paid by the Plan for administrative services for the years ended December 31, 2024 and 2023 amounted to \$18,279 and \$54,748, respectively, and qualify as party-in-interest transactions.

NOTE 10 – PLAN TERMINATION

The Scott County Board of Supervisors passed an ordinance for MEDIC EMS to become a department of Scott County, which is known as MEDIC EMS of Scott County. Scott County formally acquired MEDIC EMS on January 1, 2024, upon which date the Corporation officially terminated. As a result of the acquisition by Scott County, MEDIC EMS, the Plan sponsor, approved the termination of the Plan. A resolution that the Plan should be terminated was made effective January 1, 2024 via a termination amendment to the Plan document. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan, including the Plan's investment contract. As of December 31, 2024, substantially all of the Plan's assets had been distributed to participants in the amount of \$14,048,157, in accordance with the provisions of the Plan and applicable regulations. Any residual assets, such as forfeitures or pending settlement amounts, are recorded at their estimated realizable values. As of the financial statement date, the Plan had no outstanding liabilities or contingent obligations. The final Form 5500 will be filed with the U.S. Department of Labor reflecting the Plan's termination.

NOTES TO FINANCIAL STATEMENTS

NOTE 11 –DELINQUENT FILING OF FORM 5500

As discussed in Note 10, the Plan terminated with an effective date of January 1, 2024. As part of the Plan termination, the third-party administrator distributed all remaining participant balances on April 30, 2024. As a result of this distribution of all plan assets, the Form 5500 was required to be filed by February 17, 2025. The Company was unaware of this distribution of plan assets and as such, the filing has not been completed as of the date of the issuance of these financial statements and is therefore not in compliance with DOL and IRS regulations. As of the date of issuance of the financial statements it is unknown as to the penalties and fees that will result from this delinquent filing. However, any subsequent fees will be paid by the Company and not by the Plan.

We are writing to respectfully request abatement and forgiveness of any penalties associated with the delinquent filing of the Form 5500 for the above-referenced Plan. The Plan was formally terminated with an effective date of January 1, 2024. As part of the termination process, all remaining participant account balances were fully distributed by the third-party administrator, Principal, on April 30, 2024. In accordance with IRS and DOL regulations, this distribution triggered a final Form 5500 filing requirement, due by February 17, 2025.

Unfortunately, the Company and the Plan's auditor were not made aware at the time that the distribution of plan assets had occurred. As a result, we were unaware that the final Form 5500 filing requirement had been triggered. Consequently, the Form 5500 had not been filed and the Plan is not in compliance with the applicable filing requirements.

We understand the importance of timely and accurate reporting and regret this oversight. We respectfully request that any penalties assessed be abated due to reasonable cause. Our Company has a history of timely and compliant filings and the late filing was not due to willful neglect, but rather to an unintentional lapse in communication during the plan termination process. The Company is committed to rectifying the situation and ensuring compliance going forward.
