### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Nielsen & Bainbridge Employees' Retirement Income Plan (the Plan), an employee defined benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of April 18, 2024 and December 31, 2023 (in liquidation), and the related statements of changes in net assets available for benefits for the period from January 1, 2024 to April 18, 2024 and for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 18, 2024 and December 31, 2023, and for the period from January 1, 2024 to April 18, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

### ***Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting***

As discussed in Note 1 of the financial statements, the plan sponsor filed for Chapter 11 bankruptcy petition in the United States Bankruptcy Court for the Southern District of Texas on February 8, 2023. The termination of the plan occurred in October 2023 and assets of participant accounts were fully distributed as of April 18, 2024. As a result, the Plan has changed its basis of accounting from going concern basis to liquidation basis of accounting, starting with the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of the Plan

The following description of Nielsen & Bainbridge Employees' Retirement Income Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined benefit pension plan providing retirement, disability and death benefits to all eligible employees. The Plan sponsor is Nielsen & Bainbridge, LLC (the Company) and the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan includes all employees of the Company. Effective December 31, 2001, and July 31, 2004, the Company amended the Plan to freeze participation for non-bargaining employees and bargaining employees, respectively.

#### *2023 Plan Termination*

On February 8, 2023, the Plan sponsor filed a Chapter 11 bankruptcy petition in the United States Bankruptcy Court for the Southern District of Texas (Houston Division). When the Plan sponsor emerged from bankruptcy in July 2023, Bradley Scher of Ocean Ridge Capital Advisors, LLC, was appointed solely as Bankruptcy Plan Administrator and then trustee for the Plan. The Pension Benefit Guaranty Corporation (PBGC) approved a standard termination.

The Plan was amended on September 1, 2023, to establish a temporary lump-sum payment window during which a participant, surviving spouse or beneficiary who met certain requirements could elect to receive a distribution of benefit in a lump sum. To meet requirements for the temporary lump-sum payment, the participant could not have a qualified domestic relations order, have not met the requirements to receive a benefit on the required beginning date and a lump-sum payment exceeded \$1,000. The temporary lump-sum window began on September 15, 2023, and ended on October 31, 2023.

The Plan was terminated effective October 31, 2023, and assets of remaining participant accounts were purchased and converted to annuities by the end of December 31, 2023. In January 2024, the Plan made annuity payments to the participants on behalf of the group annuity insurance carrier and fully distributed any remaining assets by April 18, 2024.

#### *Funding Policy*

The Company's funding policy is to make contributions to the Plan sufficient to satisfy the minimum funding statutory requirements of ERISA, while not exceeding the maximum tax deductible contribution limit. Contributions to the Plan made by the Company are accrued based on annual funding amounts determined by the Plan's actuary. Such amounts meet minimum requirements of ERISA and include a provision for prior service costs.

#### *Pension Benefits*

All Plan participants become fully vested in their traditional benefit after completing five years of credited service. Participants become fully vested in their cash balance benefit after completing three years of credited service. Participants transferring from the Esselte Group U.S. Retirement Income Plan for non-bargaining employees retained the vesting status achieved under that plan.

### 1. Description of the Plan (Continued)

#### *Pension Benefits (Continued)*

Under the Plan provisions, amounts are credited by the Company to the participants' hypothetical accounts. The accounts are allocated compensation credits, transition credits and investment credits at the end of each plan year. The rates allocated are detailed in the amendment noted below.

The Plan was amended on December 31, 2007, to suspend the crediting of traditional benefits for all employees. Effective January 1, 2008, the Plan provided additional benefit accruals under a cash balance formula, which are comprised of transition credits (4% of the participant's eligible compensation if age plus years of service was greater than 60 years), compensation credits (a percentage of eligible compensation based on age) and interest credits (cash balance multiplied by the 30-year Treasury bond rate, as defined). The Plan was further amended so that no compensation credit or transition credit will be credited to the cash balance account of any participant after July 31, 2009.

Employees may elect to receive the value of their benefits as a life annuity payable, joint and survivor annuity payable or a 10-year certain and life annuity payable monthly from retirement. Lump-sum distributions of the accrued cash balance are also permitted, subject to certain limitations.

Eligibility for normal retirement benefits begins at age 62, provided the participant has at least five years of service, as defined. The Plan also permits early retirement, with reduced retirement benefits, within the 10-year period preceding the participant's normal retirement date. The Plan provides for all employees to receive an unreduced early retirement benefit if a participant's separation from service is on or after the attainment of age 62. If a participant is between the ages of 55 and 62, there is a 3% per year reduction of the early retirement benefit from age 60 to 62, a 4% per year reduction of the early retirement benefit from age 58 to 60 and a 5% per year reduction of the early retirement benefit from age 55 to age 58. If employees terminate employment prior to completing three years or five years of credited service, they forfeit their years of credited service and their rights to receive their accumulated plan benefits attributable to their cash balance benefit and traditional benefit, respectively. If an employee is terminated and reemployed within one year, the period between the employee's severance date and the date of reemployment is included in the employee's period of service. A break in service occurs if an employee is not re-employed within one or two years after a severance date, as defined. The period prior to a break in service is excluded from the employee's period of service, as defined.

In January 2021, the Plan sponsor sold the portion of its operations that employed all active participants of the Plan. All affected participants are fully vested in Plan benefits. This event does not impact future eligibility for benefits.

#### *Death and Disability Benefits*

If an active employee dies at age 55 or older, a death benefit equal to the value of the employee's accumulated pension benefit is paid to the employee's beneficiary. Active employees who become totally disabled receive annual disability benefits that are equal to the equivalent normal retirement benefit they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age, at which time disabled participants will receive the normal retirement benefit computed as though they had been employed to normal retirement age, with their annual compensation remaining the same as at the time they became disabled.

#### *Death and Disability Benefits (Continued)*

If a participant had at least 10 years of service prior to becoming disabled and was participating in the Plan as of December 31, 2007, the Plan established a cash balance account for the participant. If a participant had at least 10 years of service prior to becoming disabled and was participating in the Plan as of January 1, 2002, the Plan has the participant's cash balance account credited with pay credits, transition credits and interest credits, as applicable, for each year that the participant receives payments under the Social Security Act, until the earliest of the date that the participant recovers from the disability, dies or reaches normal retirement age.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

As a result of the decision to terminate the Plan, the Plan changed its basis of accounting from the accrual basis to the liquidation basis in the Plan's 2023 financial statements. Under the liquidation basis of accounting, assets and liabilities are stated at their estimated net realizable value and estimated costs through the liquidation period and are provided to the extent reasonably determinable. There were no material changes to the financial statements as a result of the change under the liquidation of accounting. The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Prior to the termination, the financial statements of the Plan were prepared using the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities and the actuarial present value of the accumulated plan benefits at the date of the financial statements and changes therein. Accordingly, actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for disclosure of the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

### 2. Summary of Significant Accounting Policies (Continued)

#### *Administrative Expenses*

Administrative expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

### 3. Information Prepared and Certified by Principal Life Insurance Company (Principal)

The following is a summary of the Plan's asset information as of April 18, 2024 and December 31, 2023, and for the period from January 1, 2024 to April 18, 2024 and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified or provided by the trustee and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that the information provided related to the following assets is complete and accurate.

In accordance with the annual reporting compliance permitted by Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets:

The trustee also certified the completeness and accuracy of \$2,136 and \$3,116,679 of net appreciation in fair value of investments for the period from January 1, 2024 to April 18, 2024 and for the year ended December 31, 2023, respectively.

### 4. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Benefits under the Plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits payable under all circumstances – retirement, death, disability and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

### 4. Actuarial Present Value of Accumulated Plan Benefits (Continued)

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discount for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation as of January 1, 2023, were (a) life expectancy of participants per Pri-2012 Blue collar base rate mortality table projected generationally using the Principal Mortality Improvement Scale (Principal 2022), (b) varying retirement rates based on age, (c) assumed asset return rate of 5.75% and (d) inflation rate increase of 2.40% per year.

The computation of the actuarial present value of accumulated plan benefits was made as of January 1, 2023. The foregoing actuarial assumptions are based on the fact that the Plan terminated effective October 31, 2023.

### 5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification Topic 820, Fair Value Measurements and Disclosures, are described below:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Financial assets and liabilities whose values are based on (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, or (c) inputs other than quoted prices that are observable, directly or indirectly, for substantially the full term of the asset or liability (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at April 18, 2024 and December 31, 2023.

*Pooled separate accounts:* Pooled separate accounts are primarily valued at net asset value (NAV) per share used as a practical expedient based on quoted market prices of underlying investments.

As a result of the plan termination, as of April 18, 2024, no investments were held by the Plan as the distribution of assets was fully completed.

#### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### **8. Income Tax Status**

The Plan received a determination letter from the Internal Revenue Service (IRS) regarding the Plan's qualified status on December 18, 2014. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Related Party and Party-In-Interest Transactions**

The Plan investments are shares of pooled separate accounts managed by Principal. Principal is the trustee, as defined by the Plan and, therefore, these investments qualify as party-in-interest transactions.

The Plan sponsor paid certain administrative expenses related to the Plan for the period from January 1, 2024 to April 18, 2024 and for the year ended December 31, 2023.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through April 10, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to April 18, 2024, requiring recording or additional disclosure in these financial statements.
