INDEPENDENT AUDITOR'S REPORT

To the Pension and Savings Plans Committee as Administrator of the
NOVA Chemicals Inc. Savings Plan for U.S. Employees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NOVA Chemicals Inc. Savings Plan for U.S. Employees (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (collectively, Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (Qualified Institution).

Management has obtained certifications from a Qualified Institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the Financial Statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying Financial Statements related to assets held by and certified to by a Qualified Institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the Financial Statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of Financial Statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the Financial Statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the Financial Statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the Financial Statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the Financial Statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the Financial Statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the Financial Statements or to the Financial Statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS

(All amounts in U.S. dollars, unless otherwise noted)

1. Description of the Plan

The following description of the NOVA Chemicals Inc. Savings Plan for U.S. Employees (the "Plan") provides only general information. Participants should refer to the Plan Document and the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established by NOVA Chemicals Inc. (the "Company") to provide employees of the Company with the opportunity to save for their future financial needs. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Effective January 1, 2024, the Plan was restated and converted to Schwab's prototype document. Administrative amendments were also made to the Plan in 2024 to add a Roth 401(k) option for employee after-tax contributions, increase the automatic enrollment / escalation maximum deferral rates and permit hardship withdrawals of employee contributions.

Eligibility

Full-time and long-term part-time employees are eligible to participate in the Plan from their date of hire.

Contributions

Participants may make voluntary pre-tax and after-tax contributions to the Plan through payroll deductions of not less than one percent (1%) or more than one hundred percent (100%) of their total pay, with such contributions not exceeding \$23,000 and \$22,500 in total in calendar years 2024 and 2023, respectively. Additionally, participants age 50 and older may make "catch-up" pre-tax and after-tax contributions not to exceed \$7,500 for calendar years 2024 and 2023. From their date of hire, employees are eligible for a Company Basic contribution of three percent (3%) of total pay, and a Company Matching contribution equal to the participant's voluntary savings contribution to a maximum of six percent (6%) of total pay. All participant contributions are subject to contribution limitations as determined by the Internal Revenue Service ("IRS"). Participants may also rollover into the Plan amounts representing distributions from other qualified retirement plans or individual retirement accounts. Pre-tax contributions and any associated investment earnings are not taxable until withdrawn.

Voluntary contributions, Company contributions and employee rollovers are directed by the individual participants to investment choices offered under the Plan. Participants who do not select investment options are defaulted to the Schwab Target Index fund with the maturity date closest to the participant's 65th birthday.

The Plan includes an automatic enrollment process for participants who do not complete enrollment within 45 days after they are eligible to participate. Under this process, an eligible employee's deferral rate is initially set at six percent (6%) of pre-tax eligible compensation and increases annually by one percent (1%) up to a maximum of ten percent (10%), unless the eligible employee elects a different percentage or elects to cease making voluntary contributions. Prior to January 1, 2024, the initial deferral rate was set at three percent (3%) of eligible compensation and increased annually by one percent (1%) up to a maximum of six percent (6%).

Participant Accounts, Vesting and Distributions

Each participant's account is credited with voluntary contributions, Company Basic and Company Matching contributions, and the participant's account earnings. Each participant is, at all times, one hundred percent (100%) vested in voluntary contributions and Company Matching contributions, and participant's account earnings thereon. Employees hired on or before December 31, 2007 are one hundred percent (100%) vested in Company Basic contributions. Employees hired on or after January 1, 2008 are vested in Company Basic contributions after three (3) years of service. Forfeitures are used to reduce future Company contributions. Upon termination of employment, participants may receive the value of their account. Distributions are made as a single lump-sum payment, installment payments or non-recurring partial payments.

Notes Receivable from Participants

Notes receivable from participants represent loans that are available to all active participants, enabling them to borrow from their account an amount that does not exceed the lesser of: (a) \$50,000 (reduced by the highest outstanding balance of loans made under the Plan during the preceding 12-month period) or (b) one-half of the total value of the participant's account determined as of a valuation date coincident with or immediately preceding the date on which the loan is approved. Participants may have a maximum of one (1) loan outstanding at any time.

The loans bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator. Loans bear interest at rates of prime (7.50% at December 31, 2024) plus two percent (prime + 2%), and are secured by the assets in the participant's account and must be repaid within five years. Interest rates on outstanding participant loans are currently 5.25% - 10.50%.

Administration

The Company is the designated administrator of the Plan. The Company may delegate its administrative responsibilities to another person or persons, but shall remain the named fiduciary under ERISA.

Trustee

The investments are held under the terms of a trust agreement with Charles Schwab Trust Bank.

Termination Provisions

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions and terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value, which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

As of December 31, 2024 and 2023, the Plan also invests in the New York Life Anchor Acct IV, a traditional group annuity contract issued by the New York Life Insurance Company. The contract is reported at contract value (\$10,287,724 and \$12,571,363 at December 31, 2024 and 2023, respectively), which represents contributions plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in that fund at contract value. However, certain events initiated by the Plan sponsor, including total or partial Plan termination, merger, spin-off, lay-off, early retirement incentive program, sale or closing of all or part of the Plan sponsor's operations, bankruptcy or receivership of the Plan sponsor, which exceeds a certain threshold or without 12-month advance notice, may limit the ability of the Plan to transact at contract value and be subject to a market value adjustment. A similar market value adjustment would also be made if the Plan sponsor terminates the contract without 12-month advance notice. The issuer may only terminate the contract on 12-month advance notice to the Plan sponsor. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value are not probable of occurring.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefit payments are recorded as distributed.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest which approximates fair value. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. Interest income on notes receivable from participants is recorded when it is earned.

Administrative Costs

All investment management fees are paid from the Plan's assets. All other administrative costs are paid by the Plan sponsor with the exception of the origination fee for loans and the recordkeeping fees for terminated participants, which are paid directly by the participant.

3. Investments and Certification by the Trustee (Unaudited)

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation of investments as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

4. Fair Value Measurement

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 *Fair Value Measurement and Disclosures* defines fair value, provides the framework for measuring fair value and expands disclosure about fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: (i) quoted prices for similar assets or liabilities in active markets; (ii) quoted prices for identical or similar assets or liabilities in inactive markets, (iii) inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value measurement hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Shares of registered investment companies: Valued based on net asset values reported on the active market and shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, even though the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

5. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

6. Income Tax Status

Effective January 1, 2024, the Plan was restated and converted to a prototype Plan document. The prototype plan document received a IRS opinion letter dated September 21, 2020 stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code ("IRC"). Under the previous Plan document, the Plan received a favorable determination letter from the IRS dated February 4, 2014. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

7. Related-Party Transactions

Certain Plan investments are managed by the trustee of the Plan. Transactions in these investments are exempt from the party-in-interest transaction prohibition.

8. Subsequent Events

Management has evaluated subsequent events for the Plan through June 18, 2025, the date that the financial statements were available to be issued.

The Plan was amended effective January 1, 2025 to increase the force-out limit from \$5,000 to \$7,000 and permit super catch-up contributions for participants aged 60 to 63. Also, the Vanguard High-Yield Corp Adm fund was replaced with the BlackRock High Yield K fund effective January 1, 2025.
