(the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of Plan

The following description of the 401(k) Profit Sharing Plan for Employees of Care Central VNA and Hospice, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Care Central VNA and Hospice, Inc. (the Association). Employees of the Association who have attained 21 years of age are eligible to participate in employer-based contributions after completing one year of service. There is no age or service requirement for employee contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan transferred all assets from Mutual of America Life Insurance Company (MOA) to Mid-Atlantic Trust Company DBA American Trust Custody (ATC), as custodian of the Plan during the Plan year. MOA remained the Plan's recordkeeper after this asset transfer.

Contributions and Vesting

Participants may contribute up to 100% of eligible compensation, as defined in the plan document, to the Plan, subject to the limitations established by the Internal Revenue Code (the Code). In addition, participant contributions may also consist of rollovers from other qualified retirement plans. Participants are immediately vested in their elective deferrals and any rollover contributions. Newly hired employees are automatically enrolled to defer 2% of compensation.

The Plan allows for an employer discretionary non-elective contribution. For the year ended December 31, 2024, the percentage of eligible participants' compensation contributed to the Plan was 2%. A participant's vested interest in their account derived from employer contributions is based on a five-year vesting schedule.

Forfeitures

Participants who terminate their employment prior to becoming 100% vested in the Association's contributions forfeit the unvested portion of their account balances. These benefits plus accumulated interest are allocated among participants based on their compensation as a percentage of the total compensation of all eligible participants for the Plan year. At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$10,872 and \$96,852, respectively.

Participant Accounts

Individual accounts are maintained for each participant and are credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses and certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. At December 31, 2024, the Plan offered investments in shares of mutual funds and a common collective trust. At December 31, 2023, the Plan offered several pooled separate accounts and an interest accumulation account.

Benefits Paid to Participants

Upon severance from employment, attainment of age 59½, normal retirement (age 65), disability, or death, a participant or beneficiary may receive an amount equal to the value of the participant's vested interest in his or her account in any form permitted by the plan (lump-sum and various annuities). If a participant incurs a hardship, as defined by the Plan, a participant may receive an amount equal to the value of the participant's vested interest in his or her account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

Investments are reported at fair value, except for the interest accumulation account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation in fair value includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Substantially all administrative expenses are paid by the Association; however, certain expenses, including investment advisory fees, are paid by the participants.

Subsequent Events

Management has considered transactions or events occurring through May 21, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Certified by Custodians

The investments, investment transactions, net appreciation in fair value of investments, and interest and dividend amounts disclosed in the accompanying financial statements, notes to the financial statements, and supplemental schedule were obtained by management and agreed to or derived from the information certified by the custodians, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

4. Investment Contract with Insurance Company

In 2023, the Plan had a fully benefit-responsive interest accumulation account. The interest accumulation account was an investment contract, between participants and MOA, which was held in the general account of MOA. The contract was a fully benefit-responsive contract. The contract is included in the financial statements at contract value as reported to the Plan by MOA. This account represents the original contributions made under the contract, plus cumulative interest earnings, less participant withdrawals and administrative expenses. This account was part of MOA's general assets, which supported the Association's insurance and annuity obligations. MOA bore the full investment risk of all amounts participants allocated to the interest accumulation account. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

The average yield earned by the Plan was based on the crediting interest rate declared by MOA from time to time. The interest rate was a result of an agreed-upon formula stated in the contract, with no guaranteed minimum interest rate.

To the extent permitted within the Plan contract, participants could ordinarily direct the withdrawal or transfer of their investment at contract value.

5. Parties-in-Interest

All Plan investments are managed by MOA and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to MOA are reported as administrative expenses on the statement of changes in net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Association has the right to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become fully vested in their employer contributions.

7. Tax Status

The Plan is a prototype plan sponsored by the recordkeeper. The prototype plan received a favorable opinion letter dated November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Risks and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued using market quotations.

Common collective trust: Valued based on inputs that are derived principally from or corroborated by observable market data by correlation of the underlying assets and valued using the market approach based on the net asset value (NAV) of the units held by the Plan at year-end. The NAV is provided by the custodian and is used as a practical expedient to estimate fair value. The primary investment objective of the common collective trust is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. Daily redemption of the common collective trust is allowed.

Pooled separate accounts: Valued using quoted prices for similar assets in active markets.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
