## INDEPENDENT AUDITOR'S REPORT

To the 401(k) Plan Committee of the  
ASU Enterprise Partners 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the ASU Enterprise Partners 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the Financial Statements***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that were identified during the audit.

## 1. PLAN DESCRIPTION

The following description of the ASU Enterprise Partners 401(k) Plan (the "Plan") provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering eligible employees who have been employed by ASU Enterprise Partners (the "Plan Sponsor") or related affiliates (collectively, the "Employer") and have attained 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Contributions** - Each year, participants may elect to contribute pretax and Roth deferrals up to 100 percent of eligible compensation, as defined and subject to certain limitations under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined. The Plan includes an automatic enrollment provision that all newly eligible employees are automatically enrolled at a pretax deferral rate of six percent unless they elect otherwise. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for Employer matching contributions and for each of the years ended December 31, 2024 and 2023, the Employer matched each participant's deferral at the rate of 50 percent of the first six percent of the participant's deferred compensation. The Employer matching contribution was \$679,991, net of forfeitures of \$353,444, and \$934,849, net of forfeitures of \$55,485, for the years ended December 31, 2024 and 2023, respectively. The Employer also provides for discretionary nonelective contributions to eligible participants equal to four percent of eligible compensation, as defined. The Employer made nonelective contributions of \$1,506,571 and \$1,438,273 for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's nonelective contribution and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of service. Participants are vested in Employer contributions over a five-year period, as defined.

**Forfeitures** - Forfeitures of Employer contributions may be used to pay Plan administrative expenses or to reduce future Employer contributions and total \$26,114 and \$26,252 as of December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$353,444 and \$55,485, respectively, were utilized to reduce Employer contributions. In addition, during the years ended December 31, 2024 and 2023, forfeitures of \$0 and \$5,099, respectively, were utilized to reinstate a participant's account.

**Payment of Benefits** - On termination of service for any reason, a participant or their beneficiaries, as applicable, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, partial withdrawals, annuity payments, or installment payments as permitted under the Plan. Effective January 1, 2024, the Plan provides for a mandatory cash-out following severance of employment for account balances less than \$7,000.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** - Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the participant contributions are withheld from compensation.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are valued daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Administrative Expenses** - Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Employer. Administrative expenses paid by the Employer are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net appreciation of investments is reflected net of these fees.

**Benefits Payable to Participants** - Benefits are recorded when paid.

**Subsequent Events** - The Employer has evaluated subsequent events through May 12, 2025, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements, except as disclosed below.

Effective January 1, 2025, the Plan was amended to lower the minimum age to be eligible to participate in the Plan to 17 years of age.

### 3. FAIR VALUE

The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are the following:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 – Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – This category consists of publicly traded funds of registered investment companies. The net asset value (“NAV”) of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

*Self-directed brokerage accounts* – These accounts allow a participant to buy or sell investments such as money market funds, mutual funds, and common stock. The fair value of the brokerage accounts is the aggregation of the fair value of the underlying assets, all of which are actively traded, and therefore classified as Level 1 within the valuation hierarchy.

*CREF account* – This account consists of the CREF Social Choice investment and is a variable annuity offered by College Retirement Equities Fund, an insurance company and is registered with the Securities and Exchange Commission under the Investment Company Act of 1940 as an open-end diversified management investment company. Contributions to the CREF Social Choice account buy accumulation units whose value is calculated each business day. The unit values for the CREF Social Choice account are listed on NASDAQ's website. The unit value is updated overnight for each day that NASDAQ is open and is classified as Level 2 within the valuation hierarchy.

*TIAA Traditional Annuity* – This is a non-benefit responsive annuity contract. The TIAA Traditional Annuity is reported at contract value which approximates fair value. The contract value of the TIAA Traditional Annuity represents the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals and transfers. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates. As these investments are contract-based, observable prices for identical or similar investments do not exist and certain carry liquidity restrictions. The TIAA Traditional Annuity is classified as Level 3 in the valuation hierarchy.

For each contribution, TIAA continues to record a contractual liability for the current contribution and does not consider such liability to have any embedded gain or loss. The TIAA Traditional Annuity is an unallocated fixed rate guaranteed annuity offered by TIAA, an insurance company. Contributions to the TIAA Traditional Annuity purchase a contractual or guaranteed amount of future benefits for the participant. The guarantees and returns of the TIAA Traditional Annuity are backed by the claims-paying ability of TIAA. The Plan holds Retirement Choice Annuity ("RC") contracts and are subject to fair value reporting.

The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as guaranteed minimum interest rate, additional amounts paid, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

For accumulating RC contracts, the crediting interest rates were 5.50 percent and 7.00 percent as of December 31, 2024 and 2023, respectively. The guaranteed minimum rate of interest for RC contracts is one to three percent. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

Participant liquidity restrictions apply to the TIAA Traditional Annuity in the RC contracts. For RC contracts, lump sum withdrawals are available only within 120 days after termination of employment and are subject to a surrender charge of 2.50 percent and all other withdrawals and spread over an 84-month period (7 years) in monthly installments.

There is no guarantee, however, that TIAA will always be financially able to fulfill its various guarantees related to this investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Collective trusts* – The collective trusts are valued at NAV of units of a bank collective trust. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### 4. FINANCIAL DATA CERTIFIED BY THE CUSTODIAN AND TRUSTEE

## **5. NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their vested account balance. Loans are generally issued with a maturity of up to five years. The term of any loan for the purpose of purchasing a primary residence shall not exceed 10 years. The loan interest rate is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

## **6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **7. PLAN TERMINATION**

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

## **8. TAX STATUS**

The Employer adopted a non-standardized pre-approved profit sharing plan which is the subject of a favorable tax opinion letter from the IRS dated October 7, 2020. The plan administrator believes the Plan is currently being operated in accordance with the applicable provisions of the IRC and, accordingly, the plan administrator believes that the Plan is exempt from income taxes.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Employer has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Custodian and Trustee. Transactions with the Custodian and Trustee qualify as party in interest transactions for which exemptions exist. For the years ended December 31, 2024 and 2023, the Custodian and Trustee received \$60,543 and \$49,613, respectively, for administration fees paid by the participants through the Plan as well as indirect compensation from certain mutual funds.

### **10. PLAN SERVICING CREDIT**

Certain Plan investments maintain revenue sharing arrangements with the Custodian. Under these arrangements, revenue generated from the Plan in excess of TIAA's revenue requirement are held in a revenue credit account. The revenue credit account is used to offset permitted Plan administrative expenses, including those incurred for audits, investment performance monitoring, third party compliance consulting, and other administrative costs.

The Plan may also direct the Custodian to return any unused revenue credit balances to participants. During the years ended December 31, 2024 and 2023, the Custodian allocated revenue credits of \$0 and \$15,984, respectively, to participants. As of December 31, 2024 and 2023, there was \$8 and \$7, respectively, in the revenue credit account.
