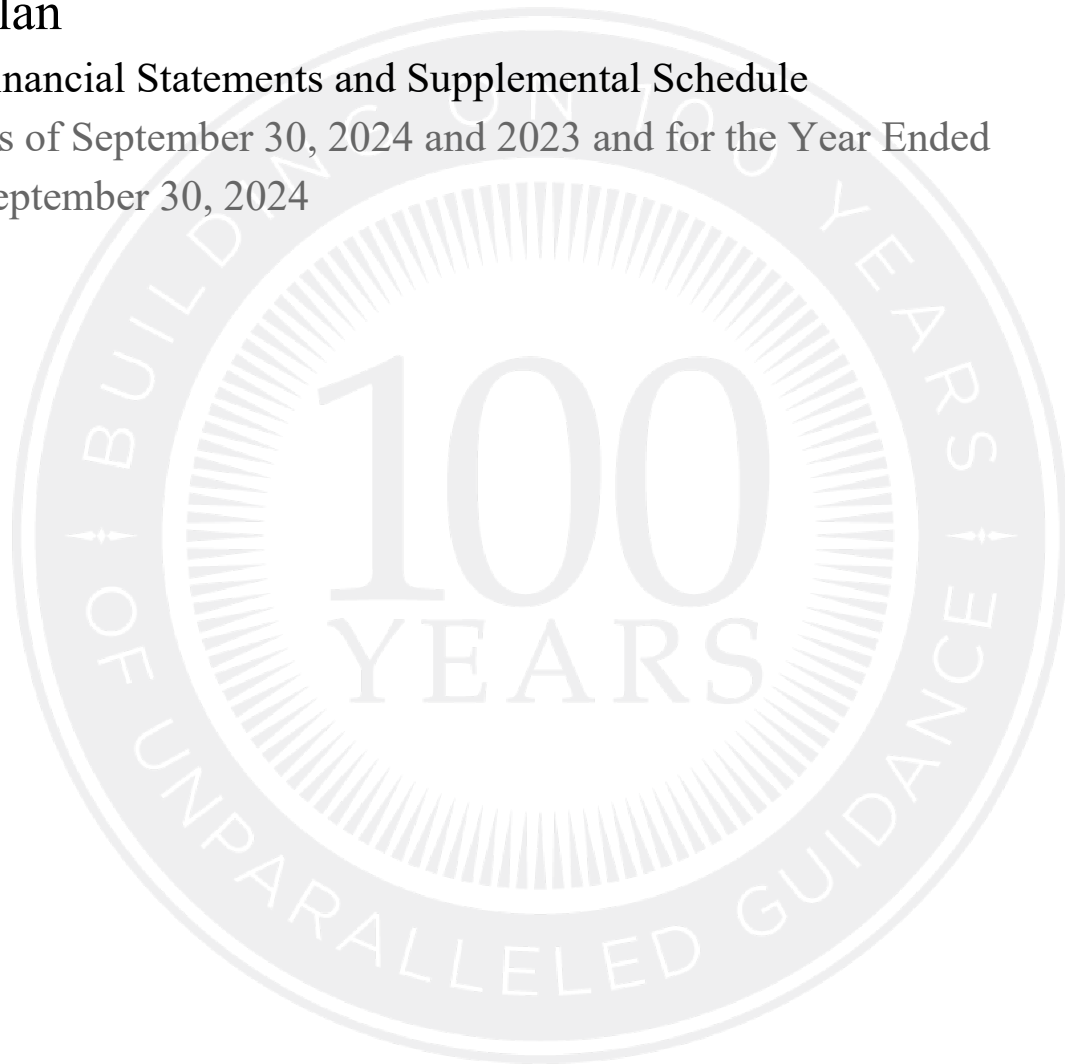

## Independent Auditor's Report

To the Plan Administrator of the Newtown Savings Bank Employees' 401(k) Savings Plan:

### ***Scope and Nature of ERISA Section 103(a)(3)(c) Audit***

We have performed audits of the financial statements of Newtown Savings Bank Employees' 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

## Notes to Financial Statements

As of September 30, 2024 and 2023 and for the Year Ended September 30, 2024

### 1. DESCRIPTION OF THE PLAN

The following description of the Newtown Savings Bank Employees' 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established for the benefit of the employees of Newtown Savings Bank (the "Bank"), the Plan's Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Bank is the Plan Administrator.

#### *Eligibility*

An employee is eligible to make salary deferrals into the Plan upon the individual's Employment Commencement Date, or, if later, the date on which the individual shall have attained 21 years of age. Eligibility to participate in employer matching contributions commences when the employee has completed one year of service in which the employee works a minimum of 1,000 hours.

#### *Contributions*

Participants may make salary deferral contributions, as defined subject to Internal Revenue Code (IRC) limitations. For eligible participants, the Bank will make a safe harbor matching contribution in an amount equal to 100% of the participant's deferral contributions to the extent such deferral contributions do not exceed 6% of the participant's compensation. In addition, eligible participants are allowed to make catch-up contributions in accordance with, and subject to, the limitation in IRC Section 414(v). Participants may also rollover amounts representing distributions from other qualified plans.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution, the Bank's contributions, if eligible, and Plan earnings. Plan earnings are allocated based on participant earnings or allocations of account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

## ***Participants' Investment Options***

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Investment Committee. Participants may change their investment options any time throughout the year via the internet or direct telephone access to the Plan's third-party administrator.

## ***Vesting***

Participants are immediately vested in their salary deferral and employer safe harbor matching contributions plus actual earnings thereon. A participant is 100% vested after five years of credited service as it relates to employer non-safe harbor contributions. At normal retirement, death, or disability, participants become 100% vested.

## ***Forfeitures***

Forfeited non-vested accounts are determined annually and are allocated to each participant's account based upon the relation of the participant's compensation to the total compensation for the Plan year. At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$1,595, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$1,617 from forfeited nonvested accounts.

## ***Notes Receivable from Participants***

Participants may borrow from their individual accounts from \$1,000 to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Generally, loan terms may not exceed five years. However, if the loan is utilized for the purchase of a participant's principal residence, the repayment period may be up to thirty years. Loans are secured by the vested interest in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

## ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum, in a series of monthly, quarterly, semi-annual, or annual installments over a specified number of years, not to exceed the participant's life expectancy, or payment in the form of an annuity. Withdrawals may also be made under certain other circumstances in accordance with the Plan document.

## ***Plan Termination***

Although it has not expressed any intent to do so currently, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting and are in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the dates of the financial statements and the changes in net assets available for benefits during the reporting periods and, when applicable, disclosures of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value using information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### ***Contributions***

Contributions from Plan participants and the safe harbor matching contributions from the Bank are recorded in the year in which the employee contributions are withheld from compensation.

## *Payment of Benefits*

Benefits are recorded when paid.

## *Administrative Expenses*

Audit fees and fees charged for administration of the Plan are paid by the Plan unless the Bank elects to pay these expenses. Loan transaction fees and investment fees are charged to participants.

### **3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

### **4. FAIR VALUE MEASUREMENTS**

The framework defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and sets out a fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Inputs are broadly defined as assumptions market participants would use in pricing an asset or liability. The three levels of the fair value hierarchy are described below:

Level 1 – Valuation is based on quoted prices in active markets for identical assets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.

Level 3 – Valuation is based on unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets. Level 3 assets include financial instruments whose value is determined using unobservable inputs to pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

In certain cases, inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

***Mutual funds:*** Valued at the net asset value (NAV) of shares held by the Plan at year-end. The fair value is based on the quoted closing price at the end of the day on the active market in which the mutual funds are traded.

***Stable Value Common Collective Trust Fund (CCT):*** Valued at the NAV of units of the collective trust. The NAV, as provided by the trust, is used as a practical expedient to determine fair value, and is based on the common collective trust's underlying investments based on the information reported by the investment advisor using audited financial statements of the common collective trust at year-end. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fund's objective is the safety and preservation of principal and accumulated interest for participant-initiated transactions. The interest credited to balances in the fund will reflect both current market conditions and performance of the underlying investments in the fund. The fund invests entirely in the MetLife Group Annuity Contract 25053 which consists of separately managed investment portfolios directed by Reliance Trust Company.

## 5. TAX STATUS

The Internal Revenue Service issued a determination letter on March 10, 2017 stating that the Plan qualifies under Section 401(a) of the IRC and, therefore, is not subject to tax under present federal income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving its determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With a few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

## **6. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest rate, market and credit ratings. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by USI Consulting Group (the "Recordkeeper") and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid recordkeeping and investment management fees aggregating \$84,710 to the Recordkeeper during 2024. The Plan Sponsor also provides certain administrative services at no cost to the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

## **8. SUBSEQUENT EVENTS**

The Bank has evaluated events through June 11, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.
