Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

Culligan Southwest, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) is a qualified retirement plan, covering substantially all eligible employees of Culligan Southwest, Inc. (the Company or Sponsor), Culligan Water Conditioning of San Antonio, Inc., Culligan Water Conditioning of West Texas, Inc., Culligan Water Conditioning of Seguin, Inc., and ZYX Corporation (Participating Employers). The plan was established on January 1, 1966, to help employees meet their financial goals by supplementing their retirement income. The Plan has been amended and restated as of July 1, 2022. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All employees of the Company and any Participating Employers, will be eligible to participate for purposes of salary deferrals and safe harbor contributions when they are at least age 18 and have completed three months of service. Employees may also be eligible to receive an employer profit sharing contribution if they are at least age 18 and have completed 12 months of service during which they worked at least 1000 hours. All eligible employees will become a participant on the first day of the Plan year quarter following the completion of the eligibility requirements.

Contributions: Participants may elect to defer a percentage of their eligible pay every pay period as an elective deferral, not to exceed 90% of plan compensation. An employee's contribution cannot exceed the annual dollar limitation set forth by Internal Revenue Code (IRC) section 402(g). Under the Plan, participants are able to make two kinds of deferrals: pre-tax elective deferrals and Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified retirement plans or an individual retirement account as rollover contributions. Participants who are projected to reach age 50 during a calendar year will be eligible to make catch-up contributions at any time during that calendar year. The Plan includes an automatic salary deferral feature. Upon eligibility, the Plan Sponsor will automatically enroll participants at a 5% contribution rate. The automatic deferral amount will increase by 1% per year up to a maximum of 10% of a participant's compensation. Participants can increase or decrease the amount of their contributions, suspend their contributions, or resume their contributions at any time.

As of January 1, 2017, the Plan is referred to as a qualified automatic contribution arrangement 401(k) plan (QACA), in which the Company commits to making certain contributions. In order to maintain the QACA safe harbor status, the Company will make a QACA safe harbor matching contribution equal to 100% of a participant's elective deferrals, not to exceed 1% of the participant's eligible compensation, plus 50% of the participant's elective deferrals between 1% and 6% of the participant's eligible compensation. Participants have to make elective deferrals in order to receive the safe harbor contribution.

Each year, the Company may make an annual discretionary profit sharing contribution to the Plan. Contributions are allocated to each eligible participant as outlined in the plan document. For the fiscal year ended September 30, 2024, the Company did not make any profit sharing contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are always 100% fully vested in their elective deferrals, rollovers, and any earnings thereon. Vesting in employer contributions is based on a vesting schedule. For the QACA safe harbor contributions, a participant will become 100% vested after two years of service. For discretionary profit sharing contributions, after two years of service, a participant receives a 20% vested percentage in their account and becomes 100% vested after six years of service.

Payment of Benefits: Benefits are payable to a participant after they leave the Company for any reason (retirement, termination, disability, or death). Participants can receive their vested benefit in a single lump sum payment, or have the payment paid as a direct rollover to an IRA or to another employer's tax qualified plan. If the vested account balance is greater than \$5,000, in addition to either a lump sum or direct rollover, the participant may choose to receive installments or defer receiving payments. If a participant's vested account balance is \$5,000 or less, then the account balance will be distributed in a single lump sum payment.

Participants may withdraw all or part of their vested account balance once they have reached age 59½. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Notes Receivable From Participants: Participants may take a loan from the Plan. The minimum loan amount is \$1,000 up to a maximum of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or one-half of their vested account balance (reduced by the current outstanding loan balance, if any), whichever is less. Loan terms range from one to five years, or longer if the loan is for the purchase of a principal residence. Loans are secured by the balance in the participants' account and bear an interest rate equal to 1% over the prime interest rate determined at the time a participant requests the loan. Participants may only have two outstanding loans at any given time. Principal and interest are paid ratably through payroll deductions.

Forfeitures: If a participant terminates employment before becoming 100% vested in their account balance, the non-vested portion of their account balance will be forfeited. The Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan.

Plan Termination: While the Company hopes and expects to continue the Plan indefinitely, it reserves the right to terminate, discontinue making contributions to, amend, or modify the Plan at any time. Upon termination of the Plan, participants will become 100% vested in their total account balance. The Company will arrange for distributions upon termination as soon as administratively feasible.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and are included in the investment income reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through May 16, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the fiscal year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follow:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: The fair values of participation units held in collective trusts are based on the net asset values (NAV) per unit as reported by the fund managers. The NAV is used as a practical expedient to estimate fair value. The Plan has the ability to redeem its investment at NAV on a daily basis, with no advance notice or restrictions on redemption. This investment is not classified within the fair value hierarchy.
