## **Report of Independent Auditors**

To the Participants and Trustees of  
Local 395 Annuity Fund

### ***Opinion***

We have audited the financial statements of Local 395 Annuity Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Local 395 Annuity Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Notes to Financial Statements

December 31, 2024 and 2023

#### Note 1. Summary of Significant Accounting Policies

**Method of Accounting** - The accompanying financial statements of Local 395 Annuity Fund (the Plan) have been prepared using the accrual basis of accounting.

**Investments** - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Contributions Receivable** - Employer contributions due and unpaid prior to year end are recorded as contributions receivable. Employer contribution deficiencies which are established through payroll compliance audits are recognized upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates set forth in the applicable collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 2 in the iron working industry within a jurisdiction primarily located in Indiana, including the counties of Jasper, Lake, La Porte, Newton, Porter and Pulaski.

## **Note 1. Summary of Significant Accounting Policies (continued)**

**Reciprocal Contributions** - The Plan is signatory to reciprocity agreements with various other retirement plans for its participants who perform work outside the geographical jurisdiction of the local union. Participants who are normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When a participant of the home local works in the territory of a reciprocating local, the latter is to make contributions to the former's fringe benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local fringe benefit plans. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$321,656 and \$350,112 for the years ended December 31, 2024 and 2023, respectively, from various other retirement plans under the terms of reciprocity agreements. The Plan remitted a total of \$530,236 and \$475,566 in reciprocal contributions to various other retirement plans under the terms of reciprocity agreements for the years ended December 31, 2024 and 2023, respectively.

**Payment of Benefits** - Benefit payments to or on behalf of participants are recorded upon distribution. There were no amounts allocated to participants who elected a withdrawal from the Plan at December 31, 2024 and 2023.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through May 13, 2025, which is the date the financial statements were available to be issued.

## **Note 2. Description of Plan**

The Plan was established in June 1995 by and between International Association of Bridge, Structural and Ornamental Iron Workers, Local 395; Industrial Contractors and Builders Association of Indiana; and Calumet Builders Association, Inc., with whom the union has a collective bargaining relationship. The Plan is primarily funded by employer contributions as specified in the collective bargaining agreement. Participant contributions are not permitted under the Plan. The Plan is a multiemployer defined contribution retirement plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Contributions to the Plan are invested as directed by the participant in various investment options. In the absence of participant direction, contributions are invested in default target-date funds. Participants may change their investment options daily with changes effective on the next business day. Participants must evaluate their own investment goals and objectives and choose the investment options best suited to achieve those goals and objectives. Poor investment performance by the investment option selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Participants' accounts are credited with employer contributions made on their behalf as well as an allocation of Plan earnings or losses. Allocations are based on account balances, or specific participant transactions, as defined. Participants are charged a monthly fee to help offset the administrative costs incurred by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Under current Plan provisions, each participant's account is immediately vested. Upon death, disability, retirement or separation from service, participants are entitled to receive the amount in their account, subject to the payment provision selected. Participants may also withdraw their benefits under the hardship withdrawal provisions of the Plan.

Participants should refer to the summary plan description for more complete details.

## **Note 3. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the pensioners, beneficiaries and participants, except that provision may be made for the payment of necessary expenses resulting from the termination of the Plan. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at the time and the priority of those benefits.

#### **Note 4. Contingency Reserve - Unallocated Accounts**

The Plan established a contingency reserve to pay administrative costs. The monthly administrative fee charged to each participant's account is \$20. The reserve is used to pay administrative expenses and establish participant accounts for employer contributions that are deemed delinquent in the current year. Net assets available for benefits include a reserve balance at December 31, 2024 and 2023 of approximately \$189,000 and \$148,000 respectively.

#### **Note 5. Tax Status**

The Plan's latest determination letter is dated March 21, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Fair Value Measurements**

The *Fair Value Measurements and Disclosure* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

##### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly

## **Note 6. Fair Value Measurements (continued)**

### Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

### Level 2 Measurements

The money market fund is valued at cost, which approximates its fair value.

### Measurements Using Net Asset Value as a Practical Expedient

The Plan's investments in the common collective trusts are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The common collective trusts are considered direct filing entities (DFEs) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the investment strategies of DFE investments. Full redemptions in the collective investments funds are available on a daily basis without notice, with the exception of the Galliard Stable Return Fund C. Full redemptions for the Galliard Stable Return Fund C are available upon written notice to the investment manager. The amount will be paid out one year after notice is provided to the manager.

## **Note 7. Funding Policy**

Employer contributions to the Plan are made in accordance with the collective bargaining agreement. Hourly contribution rates during the years ended December 31, 2024 and 2023 were as follows:

January 1, 2023 - May 31, 2023	\$ 5.54

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, currency and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Due to inherent uncertainties involved in the valuations of investment that are not publicly traded, estimated fair values may differ materially from the values that would have been used had a ready market for the underlying securities existed.

**Note 9. Related Organizations**

The Plan has four related tax-exempt organizations, which include a pension plan, an apprenticeship and training fund, a health and welfare plan and a local union.

The related health and welfare plan collects and distributes employer contributions on behalf of related affiliates through a lockbox arrangement. At December 31, 2024 and 2023, the Plan was owed \$866,234 and \$678,994 respectively, from the health and welfare plan for amounts held on its behalf in the lockbox account.

**Note 10. Exempt Party-in-Interest Transactions**

During the years ended December 31, 2024 and 2023, the Plan held units of a money market fund managed by Broadridge. Broadridge is the trustee of the Plan's investment assets, and therefore, these transactions qualify as exempt party-in-interest transactions.

**Note 11. Major Employers**

Contributions from one employer accounted for approximately 10% of total employer contributions for the year ended December 31, 2024. Contributions from two employers accounted for approximately 20% of employer contributions for the year ended December 31, 2023. In the event these employers were to suspend contributions, the Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.
