We have performed an audit of the financial statements of DRA Advisors LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the DRA Advisors LLC 401(k) Profit Sharing Plan (the “Plan”) is provided for general information. Participants should refer to the plan document for more complete information.

The Plan was amended and restated as of November 9, 2021.

General and Eligibility

The Plan is a defined contribution plan. It is sponsored and administered by DRA Advisors LLC (“DRA”). The Plan covers all eligible employees who are age 21 or older. Employees become eligible to participate in the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each participant may contribute a percentage of their pre-tax compensation up to a maximum of 100% of the participant’s eligible compensation, subject to certain limits imposed by the Internal Revenue Code (“IRC”). In addition, the plan allows for employees to make after tax ROTH contributions to the plan subject to IRC limits. The maximum allowable participant contribution was \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 by the end of the plan year can make additional catch-up contributions up to \$7,500.

Participants may also contribute amounts representing distributions (rollovers) from other qualified retirement plans.

The Plan Sponsor may contribute additional discretionary amounts at the discretion of the board of directors on an annual basis. No additional amounts were contributed to the plan during the year ended December 31, 2024.

For the year ended December 31, 2024, the Board of Directors authorized a match of 50% up to 6% of eligible compensation.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or his or her beneficiary, may elect to receive a lump-sum distribution of his or her entire account balance or a portion of the account balance. For termination of service for other reasons, the participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution of his or her entire account balance or a portion of the account balance.

Participant Accounts

Each participant account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses that are paid by the Plan.

Participants direct the investment of their participant contributions, employer contributions and earnings thereon into investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in discretionary matching contributions is based on years of service. A participant vests 20% per year for each year of service and is 100% vested after 5 years. In the event the Plan is terminated, matching contributions to the participants' accounts will become fully vested. Upon reaching normal retirement, disability or death, a participant account also becomes fully vested.

Forfeitures

Forfeitures of the non-vested portion of terminated participant accounts may be used to pay the Plan's expenses and/or to reduce employer matching contributions. During the year ended December 31, 2024, \$59,890 was added to the forfeiture account. \$32,218 and \$60,514 of forfeiture account were used to pay for a portion of the Plan's administrative expenses and employer match contributions, respectively, during 2024. The Plan's forfeiture account balance was \$14,663 and \$46,083 as of December 31, 2024, and 2023, respectively.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates determined by the plan administrator (ranging from 4.25% to 9.50% as of December 31, 2024). Loans are repayable through periodic payroll deductions or by check or money order whenever payroll withholdings are not possible, over a period generally ranging up to 60 months. Loans for the purchase of a primary residence can be repaid over a reasonable period that may exceed 60 months. The outstanding loans have a maturity date through July 2029.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

2. Summary of Significant Accounting Policies

Basis of Preparation

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the reporting period and, when applicable, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value as measured by quoted prices in an active market. Fair value is the price received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements. Fully benefit-responsive annuity contracts are stated at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the date received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the participants accounts for investments in mutual funds and fully benefit-responsive annuity contracts are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Subsequent Events

The Plan has evaluated subsequent events and transactions through June 18, 2025, the date that the financial statements were available to be issued and concluded that no additional disclosures were required.

3. Information Certified by the Plan's Custodians and Trustees

The Plan's financial statements and supplemental schedule as of December 31, 2024, and 2023 and for the year ended December 31, 2024, were prepared and derived from information provided by Empower Life & Annuity Insurance Company of New York and Empower Trust Company LLC, custodians and trustees of the Plan, and furnished to the plan administrator.

In accordance with the provisions of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the custodians and trustees have certified as complete and accurate all the investment information included in the accompanying financial statements and the supplemental schedule. Information included in the accompanying financial statements relating to investment and income derived therefrom was prepared by or derived from information prepared by the custodians and trustees of the Plan and furnished to the Company. The Company has obtained certifications from the custodians and trustees as of December 31, 2024, and 2023 and for the year ended December 31, 2024, that such information is complete and accurate. Such information includes investments at fair value, investments at contract value, notes receivable from participants, interest on notes receivable from participants, dividend income, interest income, and net appreciation in fair value of investments as shown in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment

information, except for comparing such certified investments information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds: Valued at quoted prices reported in an active market using the net asset value (NAV) of shares held by the Plan at year-end.

The preceding valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Group Annuity Contract

The Plan is party to an annuity contract with Empower Life & Annuity Insurance Company of New York, whereby it maintained certain of the Plan’s contributions in a group annuity account. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for the credit risk of the contract issuer or otherwise.

Certain events could limit the ability of the Plan to transact at contract value with Empower Life & Annuity Insurance Company of New York. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsors or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments were managed by its trustees and, therefore, transactions in such investments as defined by the Plan qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Additionally, expenses paid for investment advisory and auditing fees are paid by the Plan. For the

year ended December 31, 2024, total administrative expenses were \$121,275. The Company provides certain administrative services at no cost to the Plan.

7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by HUB International Limited. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on technical merits, to not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded, as of December 31, 2024, and 2023, that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan has contracts with its trustees that encompass various investment instruments, including mutual funds and group annuity accounts. Investment securities, in general, are exposed to various risks, such as interest rate, credit and market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

9. Plan Termination

Although it has not expressed any intent to do so, DRA has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.
