### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Davenport Companies 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## *Notes to Financial Statements*

### **Note 1 - Description of Plan**

The following description of the Davenport Companies 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing plan with a cash deferred arrangement and includes employees of Davenport Realty Trust and Affiliates (collectively known as the "Employer"), other than certain nonresident aliens and leased employees, who have attained age 21 ("Participants"). Participants may enter the Plan on the first day of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant directed.

#### **Participant Contributions**

Participants may defer from 2% up to 100% of their pre-tax annual compensation as defined by the Plan, up to a dollar limitation set forth by Federal law. Participants may suspend their contributions at any time and re-enter the Plan at the beginning of each month of the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("Participant Rollovers").

#### **Employer Matching Contributions**

Each year, the Employer may elect to make matching contributions equal to a discretionary percentage of an eligible Participant's elective deferral. For the Plan year ended December 31, 2024, the Employer elected to make a matching contribution equal to 100% of the amount deferred by each participant, up to a maximum of 4.00%.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and pro-rata allocations of the Employer's contribution, and the Plan's investment earnings. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are always fully vested in their participant deferral and rollover contributions. Participants begin vesting in Employer contributions after two years of service and become fully vested after six years of service. A year of service is defined as 400 hours of service. A participant becomes fully vested upon death or disability, as defined by the Plan or upon reaching normal retirement age (65), while employed by the Employer.

### **Note 1 - Description of Plan (Continued)**

#### ***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance at the earlier of the end of five consecutive one-year breaks in service or if the participant receives a complete distribution of their vested accounts. The Plan may use forfeitures to reduce future Employer contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, there were \$24,178 and \$30,624, respectively, in forfeitures available to reduce future Employer contributions or pay Plan administrative expenses. During 2024, \$30,624 of forfeitures was used to offset a portion of the 2023 Employer contributions funded in 2024. Subsequent to year end, \$24,178 was used to offset a portion of the 2024 Employer matching contributions funded in 2025.

#### ***Payment of Benefits***

Participants are entitled to their total vested account balance upon death, disability, retirement or termination of employment. A participant will receive a lump-sum amount equal to the value of his or her account. Upon termination, if a participant's vested account is more than \$1,000 but less than \$5,000, the Plan administrator, after notification, may distribute his/her entire non-forfeited account balance to an individual retirement account for the benefit of this participant. In addition, if a participant's account is \$1,000 or less and a disbursement election has not been made, the Plan administrator may distribute the benefit to the participant.

#### ***Administrative Expenses***

At the discretion of the Employer, Plan administrative expenses are paid directly by the Employer.

#### ***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. The Plan's trustees are officers of the Employer. Empower Annuity Insurance Company and Empower Trust Company, LLC are the Custodians.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Note 2 - Summary of Significant Accounting Policies (Continued)**

#### ***Investments, Investment Valuation and Income***

Investments other than fully benefit-responsive investment contracts (valued at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Accordingly, the investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through June 18, 2025, the date that the financial statements were available to be issued.

### **Note 3 - Information Certified by Custodians**

Plan investments are held in mutual fund accounts and a guaranteed interest account by the Plan's custodians, Empower Annuity Insurance Company and Empower Trust Company, LLC ("Empower"). The fair value of investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024, including interest and dividends, and net appreciation in fair values are certified as complete and accurate and reported to the Plan by Empower. Information contained in the supplemental Schedule of Assets (Held at End of Year) has also been derived from information certified by Empower.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the mutual fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The mutual fund investments held by the Plan as of December 31, 2024 and 2023 amounted to \$19,099,315 and \$16,793,889, respectively, and based on the fair value hierarchy, have been classified as Level 1 as of December 31, 2024 and 2023.

### **Note 5 - Fully Benefit-Responsive Investment Contract**

The Plan has a group annuity contract with Empower Annuity Insurance Company and Empower Trust Company, LLC ("Empower"). The group annuity contract, Key Guaranteed Portfolio Fund, is a fixed account that is part of the general account of Empower with a reported contract value of \$557,804 and \$1,033,275 at December 31, 2024 and 2023, respectively. The methodology for calculating the crediting interest rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum crediting interest rate (which will never be less than 0% as stated in the contract), and prevailing market conditions. The crediting interest rate for the guaranteed interest fund was 1.23% and 1.41% at December 31, 2024 and 2023, respectively. The average yield equals the crediting interest rate for each contract. There were no reserves against contract value for credit risk of the contract issuer or otherwise. Interest rates are reset quarterly.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **Note 6 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as a pandemic or international conflict that could have an impact on investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 7 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 8 - Related-Party and Party-In-Interest Transactions***

Certain Plan investments are managed by Empower. Empower is the custodian as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions. Fees paid by the Plan to Empower for investment management services totaled \$15,499 for the year ended December 31, 2024.

### ***Note 9 - Tax Status***

The Plan has adopted the Angell Pension Group, Inc. Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement that has received a favorable Internal Revenue Service ("IRS") opinion letter dated June 30, 2020. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and continues to qualify under Section 401(a) and the related trust continues to be tax-exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
